Forwarding of Remains to Another Funeral Home **\$1595.00**

This charge includes removal of remains, services of Funeral Director and Staff, use of facilities recording vital statistics, securing permits and authorizations, filing and obtaining death certificates and other forms and claims, embalming and other preparation of the body and other local transportation, but not shipping charges. This does not include any wake/visitation service or funeral service.

Receiving Remains from Another Funeral Home **\$1500.00**

This charge includes services of Funeral Director and Staff, use of facilities, securing permits and authorizations, care of remains, transportation to funeral home and to cemetery or crematory. This does not include any wake/visitation service of funeral service.

Direct Cremation **\$995.00**

This charge include services of Funeral Director and Staff, basic use of facilities, recording vital statistics, securing permits and authorizations, filing and obtaining death certificates and other forms and claims, care of remains and transportation to cemetery. This does not include any wake/visitation service, funeral service or crematory charges. If you want to arrange a direct cremation, you can use and unfinished wood box of any alternative container. Alternative containers can be made of materials like heavy cardboard or composition materials (with or without an outside covering) or pouches of canvas.

PROFESSIONAL SERVICES

Basic Services of the Funeral Director and Staff **\$1,295.00**

The basic service charge includes, but is not limited to staff responding to an initial request for service, arranging a conference with family or responsible party, preparation of a filing necessary certificates and permits, placement of obituary notices, planning of funeral arrangements, and coordination of service with cemetery, crematory, vault companies and others are required. Also, included in this charge are overhead expenses relative to our facility, such as insurance, maintenance and utility expenses, secretarial and administrative costs, equipment and inventory expenses.

Embalming **\$400.00**

Except in certain cases, embalming is not required by law. Embalming may be necessary in certain funeral arrangements, such as viewing, visitation, etc. If you do not want embalming, you usually have the right to choose an arrangement which does not require you to pay for it, such as direct cremation, immediate burials. It is the policy of our funeral home to require embalming where funerals are selected which require a public viewing.

Other Preparation of the Body **\$275.00**

This includes washing, exterior disinfection (dressing and casketing).

Visitation and Viewing **\$295.00**

This service includes visitation setup, placement of encased remains, and supervision attendance during visitation.
