Health: We can only accept well children. If symptoms of illness are observed upon arrival, the child will be sent home. If symptoms occur during the day, parents will be notified and the child will be isolated until the parents arrive. Parents will have one hour to pick up their child. After one hour, a delinquent fee of \$1.00 per minute will accrue until the child is picked up. Payment will be due prior to the child returning to the Center. If the child is injured while at the Center, emergency medical attention will be given and the parents will be notified immediately. It is the Center's policy to notify the parents of any exposure to communicable diseases and any noticeable adverse reactions to medications. It is the parent's responsibility to inform the Center of any communicable disease contracted by their children so that the other parents can be notified of exposure. We follow state recommendations for the exclusion of sick children with communicable diseases and their re-admission to the Center. Please remember that we can not have any child at the Center with a fever, excessive diarrhea or vomiting.

If a child is not well enough to participate in daily activities, the child is not well enough to be at the Center .

Children who become chronic biters and do not show improvement must be strictly evaluated and documented. A biter passes on health threats to other children. After appropriate discipline has been tried and repeatedly failed, a one-week suspension from the Center may be required as a final option. The weekly rate of \$165.00 will be charged to hold the child's place in our program. If progress has not been made, the child will be permanently dropped from our program.

Medications: For children requiring medication, a completed Medication Form is required. We are unable to administer medication unless the Medication Form is completed including proper dosage. Medication must be labeled with the child's name and in its original container.

Weather & Safety Procedures: If severe weather conditions should develop in our area, every effort will be made to ensure the safety of your children. All workers will be busy caring for the children in the appropriate "safe areas." It is your decision whether or not to pick up your child during these conditions. During winter months, it is sometimes necessary to close the Center due to snow or icy roads. We will notify WSB-TV if we close or must delay opening. **Should inclement weather occur, we will follow the decision made by the Coweta County School System.**

In case of fire or major utility problems, children will exit through the outside doors in their rooms and will proceed with the Center personnel to the Fellowship Hall in the main church building at which time parents will be notified to pick up their children. The Center does conduct routine drills for evacuation from fire, bomb threats, gas leaks, etc.

General Information:

The Center provides morning and afternoon snacks along with a hot lunch.

Your child may bring a nutritious breakfast to the Center in disposable containers only.

Weekly menus are posted at the Center.

Food exceptions are not made. In case of a food allergies, you may send a substitute food.

Parents of infants should send sufficient formula, cereal, etc. Send only unbreakable bottles. **All bottles, caps, and pacifiers must be labeled.**

Each child must have a change of clothing at the Center in case of an emergency. You will be called to bring extra clothing if needed.

Parents are required to label all personal belongings.

Parents are required to provide disposable diapers for their child and disposable training pants (Pull-Ups) during the early stages of potty training.

Children will play outdoors daily except during inclement weather.

Your child should wear washable clothing and shoes that will allow them to be comfortable while at the Center.

11. Your child may bring a labeled light weight blanket or beach towel for nap. Do not send large pillows.

12. Each child will have the advantage of taking an afternoon nap (12:00 pm - 2:00 pm).

13. Toys from home are not allowed.

14. The following items are prohibited at this facility: chewing gum, candy, glass containers, weapons (toy or real), and money.

The Center does not provide transportation.

16. We welcome the opportunity to celebrate your child's birthday. You may bring cupcakes, etc. if you wish; however, party invitations are not allowed unless every child in the class is invited.

Policies & Information:

Admission Requirements:

The Center is open from 7:00 am until 6:00 pm Monday thru Friday. Parents will be charged a delinquent fee of \$1.00 for each minute after 6:00 pm that there child is left at the Center. We are not licensed to operate after 6:00 pm and must adhere to these state rules. The delinquent fee is due in a cash payment when you pick your child up.
