DECISION OF LAW

SYLLABUS

The question of whether certain "resolved statements" of Petition 611 are aspirational in nature, whether a certain recital in Petition 611 is true and whether Petition 611 violates certain provision of *The Book of Discipline of The United Methodist Church - 2016*, are moot and hypothetical.

STATEMENT OF FACTS

At the plenary session of the Western Pennsylvania Annual Conference of The United Methodist Church on June 9, 2017, Bishop Cynthia Moore-Koikoi ruled Petition 611 out of order. No appeal was taken to the house from that ruling. Instead, a clergy member raised the following Questions of Law:

WHEREAS, Petition 611 was duly submitted to the Secretary of Western Pennsylvania Annual Conference prior to May 1, 2017 and subsequently printed in the Pre-Conference Journal, and,

WHEREAS, Bishop Cynthia Moore-Koikoi ruled that Petition 611 is in violation of paragraphs 33, 604, and 605 of *The Book of Discipline of The United Methodist Church - 2016* stating that is in light of the cited paragraphs "any legislation pertaining to the actions of another Conference or the affairs outside of this Conference is improper.",

THEREFORE BE IT RESOLVED that our resident Bishop Cynthia Moore-Koikoi is requested to decide a question of law, concurrent with paragraph 51 (Article VII) of *The Book of Discipline of The United Methodist Church - 2016*, on the following issues related to the possibility that Petition 611 is in violation of paragraphs 33, 604, and 605:

- 1) Is the statement in Petition 611, "WHEREAS The Book of Discipline of The United Methodist Church - 2016 states in paragraphs 103 and 104 that John Wesley's Explanatory Notes on the New Testament are doctrinal standards of The United Methodist Church," a true statement in accordance with paragraphs 17, 103, and 104?
- 2) Are the following resolved statements aspirational in nature in accordance with Judicial Council Decisions 1044, 1052, 1218, 1283?

- a. Is the statement contained in Petition 611, "THEREFORE BE IT RESOLVED, that the Western PA Conference pledges faithfulness to our covenant as outlined in *The Book of Discipline of The United Methodist Church - 2016* as an obedient witness to God's grace in Jesus Christ through The United Methodist Church, even as the Northeast Jurisdictional Conference encourages covenantal unfaithfulness, "aspirational in nature?
- b. Is the statement contained in Petition 611, "BE IT FURTHER RESOLVED, that the Western PA Conference express its profound disagreement with the call to non-conformity made by the Northeast Jurisdictional Conference as well as those made by other Jurisdictions and Annual Conferences is our United Methodist connection," aspirational in nature?
- c. Is the statement contained in Petition 611, "BE IT FURTHER RESOLVED that the Western PA Conference calls on its sibling Conferences in the Northeast Jurisdiction to prayerfully practice faithfulness to the provisions of *The Book of Discipline of The United Methodist Church 2016* which pertain to sexual behaviors, particularly as they relate to United Methodist clergy and candidates for ministry," aspirational in nature?
- 3) Is Petition 611 Against Actions of Non-Conformity in violation of paragraphs 33, 604, and 605 of *The Book of Discipline of The United Methodist Church 2016*?

ANALYSIS AND RATIONALE

The questions raised are moot and hypothetical. Petition 611 was ruled out of order by the chair and this ruling was not appealed to the house. Accordingly, the questions of law which address Petition 611 did not relate to any action taken by the Western Pennsylvania Annual Conference nor did the questions pertain to the business of the Western Pennsylvania Annual Conference. A decision of law must relate to an action taken by the annual conference or to one under consideration by the annual conference. See, Judicial Council Decisions 1160, 1286, 1293 and 1294. As such, the questions are moot and hypothetical and it would be improper to offer any substantive decision on these questions of law.

DISPOSITION

The questions of law are moot and hypothetical as Petition 611 was no longer under consideration by the Annual Conference and the questions of law did not relate to any action taken by the Annual Conference.

- 1) Is the statement in Petition 611, "WHEREAS *The Book of Discipline of the United Methodist Church-2016* states in paragraphs 103 and 104 that John Wesley's Explanatory Notes on the New Testament are doctrinal standards of The United Methodist Church," a true statement in accordance with paragraphs 17, 103, and 104?
- 2) Are the following resolved statements aspirational in nature in accordance with Judicial Council Decisions 1044, 1052, 1218, 1283?
 - a) Is the statement contained in Petition 611, "THEREFORE BE IT RESOLVED that the Western PA Conference pledges faithfulness to our covenant connection as outlined in *The Book of Discipline of The United Methodist Church 2016* as an obedient witness to God's grace in Jesus Christ through The United Methodist Church, even as the Northeast Jurisdictional Conference encourages covenantal unfaithfulness," aspirational in nature? b) Is the statement contained in Petition 611, "BE IT FURTHER RESOLVED that the Western PA Conference expresses its profound disagreement with the call to non-conformity made by the Northeast Jurisdictional Conference as well as those made by other Jurisdictions and Annual Conferences in our United Methodist connection," aspirational in nature?
 - c) Is the statement contained in Petition 611, "BE IT FURTHER RESOLVED that the Western PA Conference calls on its sibling Conferences in the Northeast Jurisdiction to prayerfully practice faithfulness to the provisions of The Book of Discipline of The United Methodist Church 2016 which pertain to sexual behaviors, particularly as they relate to United Methodist clergy and candidates for ministry," aspirational in nature?
- 3) Is Petition 611 Against Actions of Non-Conformity in violation of paragraphs 33, 604, and 605 of *The Book of Discipline of The United Methodist Church -2016*?

DAY TWO Friday, June 9, 2017

MORNING SESSION

ORDER - Bishop Moore-Koikoi called the morning session to order at 8:10 AM.

BIBLE STUDY I - Bishop Moore-Koikoi introduced Rev. Dr. Dawn Chesser, from Discipleship Ministries, to lead our Bible Studies for the next few days. Rev. Chesser brings greetings from Rev. Junius B. Dotson, the new General Secretary of the General Board of Discipleship Ministries. She then led the body in a study of the 1st chapter of Paul's letter to the Colossians.

OPENING PRAYER - Jim Pond, District Superintendent of the Indiana District, offered an opening prayer before the start of the morning's plenary session. Following the prayer, Bishop Moore-Koikoi asked us to pray for a young man who fell on the steps of a church and hit his head. This is a life or death injury, and silent prayer was observed.

VOTING KEYPAD PRACTICE - Bill Patrick, Floor Manager, asked Alan Morrison, Agenda Coordinator, to lead the conference in a period of practice with the new digital voting system.

CONSENT CALENDAR - Lisa Grant presented the Legislation and Corporation Consent Calendars (Daily Journal pages 617-620). RS401 is an order of the day for Saturday, so it was automatically removed from the Consent Calendar. RS403 and P505 failed to receive a 75% margin, so according to conference rules, they are automatically removed from the Consent Calendar. In addition to these three items, P307 and P611 were both ruled out of order by Bishop Moore-Koikoi.

Keith McIlwain submitted a letter in writing asking for a question of law under $\P 51$ on Petition 611.

Nathanael Fugate submitted a letter in writing asking for a question of law under $\P 51$ on Petition 307.

Bishop Moore-Koikoi stated that she will respond to both resolutions within 30 days.

Lisa Grant reminded the body that with 25 signatures, by 9:00 PM Friday evening, an item can be removed from the Consent Calendar.

READING OF APPOINTMENTS: BUTLER DISTRICT - Bishop Moore-Koikoi reappointed Joel Garrett as the Superintendent for the Butler District. Joel Garrett then read the new appointments to the District, while all current District pastors welcomed and greeted each other. Bishop Moore-Koikoi offered a prayer for all pastors of the District.

X. Conference Rules ARTICLE 2. SESSIONS

- 2.3.6 Sections The Conference Sessions Team shall structure the session of the conference on the same basic plan as the General Conference so as to provide sections for study and review of reports, resolutions and petitions before they come to the floor of the Annual Conference.
- 2.3.6.1 Each section shall be designated by number and shall be assigned reports, resolutions and petitions by the Conference Secretary.
- 2.3.6.2 The Conference Secretary shall designate section chairpersons and vice-chairpersons (preferably members of the Annual Conference) of the several sections and a coordinator of the sections. Such designation shall supersede all other membership assignments to section and therefore if a chairperson is a member of the Annual Conference they would have the right to vote in accordance with Robert's Rules of Order. Each section shall elect its own secretary.
- 2.3.6.3 The Conference Secretary shall be responsible for assignment of persons to membership in the several sections.
- 2.3.6.4 Notification of assignment to a specific section for study and review will be made at the time of the initial pre-conference report book mailing. Each member of the Annual Conference will be called upon to vote on ALL reports, resolutions and petitions reviewed by Legislative Section during the Plenary business sessions of the conference. All reports, resolutions and petitions assigned to the sections shall be reported to the Plenary session with recommendation for action.
- 2.3.6.5 All members of the Annual Conference, pastors under appointment, deaconesses under appointment, and young adult representatives shall be members of sections to discuss and if permitted in *The Book of Discipline* to vote on reports, resolutions and petitions before such matters reach the floor of the conference. All members of the Annual Conference may attend and speak in any section but their right to vote is limited to the section to which they are assigned.
- 2.3.7 Report to the Plenary Session All reports submitted to the conference shall be presented by the Conference Secretary at the first plenary session to be received without action, in which case the report shall not be considered as having been adopted as the position of the conference. Any member of the conference may request, at this time, that a report be reviewed by a Legislative Section. Such reports shall be assigned to a Legislative Section by the Conference Secretary, and a recommendation that the report be accepted or rejected in whole, or in part, or amended, shall be made by that Legislative Section to the Plenary Session during that session of the Annual Conference.
- 2.3.7.1 All resolutions and petitions shall be assigned by the Conference Secretary to a Legislative Section. The section shall move the section's report which shall be the main motion before the Conference. The vote of the section (including any abstentions) shall be reported to the Plenary Session. Any resolution which includes an amendment by the section shall be so noted.
- 2.3.7.2 The presiding officer may permit the proponent of a report or resolution to speak if, in the opinion of the presiding officer, the report or resolution is complex, unclear, or controversial, but such occasion shall not be used for a promotional presentation. Amendments to the recommendations of a section may be made from the floor of the conference.
- 2.3.7.3 Each legislative section leader shall record the votes of the legislative section in respect to each item of business considered, and shall give such information to the legislative floor manager, and shall include such information in reporting to the conference on the action of the legislative section.

2.3.7.4 Any Annual Conference legislation approved by a legislative section with no more than 25% of votes cast against the prevailing position shall be placed on the consent calendar, which shall be published in the Daily Journal at least ten (10) hours prior to any consideration of such legislation.

Upon written request of any twenty-five (25) Conference members, a particular piece of legislation shall be removed from the consent calendar and shall be presented to the conference for debate and action.

All legislation on the consent calendar shall be presented to the conference at one time for approval.

2.3.7.5 Upon motion duly made, seconded, and upon an affirmative vote of two-thirds of the members voting, the conference may group legislation for action by such categories as the conference may determine, such as legislation approved by a legislative section without an opposition vote greater than five of all section members voting, or greater than ten of all section members voting; provided, however, that any member may request that a particular item of legislation be removed from the group to be so acted upon, in which case that particular item of legislation shall be removed and thereafter called up in the regular order of business.

2.3.8 REPORTS AND RESOLUTIONS

- 2.3.8.1.1 Resolutions and Petitions All reports and resolutions of conference agencies and petitions of individuals and local churches to be submitted to the Annual Conference shall be printed in the pre-conference report book. Where practical all petitions shall be submitted by the Conference Secretary to the appropriate board or agency for consideration and their recommendations shall be noted upon presentation to the section. No resolution or petition shall be considered by the conference unless it has been submitted to the Conference Secretary by May 1. All petitions to the Annual Conference must be accompanied by sufficient scriptural footnoting, in the margins or otherwise plainly marked, so that the foundation of scriptural holiness is evident, (Colossians 3:23-24). The Annual Conference may consider any petition without proper section review upon a two-thirds vote of the conference.
- 2.3.8.1.3 That each piece of proposed or adopted legislation shall include as a part of its body a statement that will designate the appropriate conference agency or leader who will implement the legislation and be responsible for reporting its status to the conference. If the Annual Conference directs a letter to be written, then a correspondence secretary is to be named in the legislation and mailing labels with the addressees will be supplied. In the absence of any of these four parts, the responsibility will be accomplished by the author of the legislation.
- 2.3.8.2 No reports, resolutions, or petitions submitted can be considered by a section without the presence of the author of the report, resolution, or petition, or an identified spokesperson for the report, resolution, or petition.
- 2.3.8.3 No proposed resolution or petition which seeks, in substance, conference approval of any provision of *The Book of Discipline* or *The Book of Resolutions*, shall be considered or acted upon by any legislative section, nor by the conference. The Conference Sessions Team may determine whether a proposed resolution or petition violates this rule and if it does so, such determination shall be noted in the first Daily Journal, published for a conference session, or such may be raised by any members on a point of order. Any appeal from a determination shall be made without debate by the President.
- 2.3.8.4 All resolutions to modify the present system of apportionments shall include data showing effect on apportionments for all churches, or permit sufficient time for this to be calculated in the conference treasurer's office before presentation to the Annual Conference.
- 2.3.8.5 Conference Sessions Team has the responsibility to review and refuse distribution and/or displays that are inappropriate or contrary to the Social Principles.

BASIC PARLIAMENTARY GUIDE

"Conference" is a term applied uniquely in United Methodism. Having its origin in the concept of a "preacher's meeting." The Annual Conference (e.g. Western Pennsylvania Annual Conference) is the basic organic and functional unit of the Church in a geographical area, now consisting of an equal number of clergy and lay members. But the term also applies to the annual occasion when those members of the Conference convene to do its "work."

The term is also given to the smaller units of structure called Districts and to the local churches or charges; likewise at the regional and national level are the Jurisdictional and General Conferences.

Whatever other function the Conference may perform, it is the legislative and decision making body for its constituency. As a member of it, you need to understand that and be prepared to participate in legislation and the legislative process.

Parliamentary law or procedure is the system of principles and rules governing the transaction of business in deliberative groups. It is designed to clarify and expedite decisions.

BASIC PRINCIPLES

Although many rules of order exist in parliamentary law, they are consistent with and in large measure based upon the following principles:

- 1. The simplest and most direct method of doing business is the correct and proper procedure.
- 2. The decision of a majority of those voting governs, except where such decisions contravene By-Laws or violates some other basic rights of a member.
- 3. Every member of an organization has the right to full and free discussion of every question.
- 4. All business of an organization must be done by a motion, or, as it is called in its most formal form, a resolution.
- 5. Other kinds of motions, secondary motions, exist to deal with the main motion or meet some immediate requirement of the organization.

TRANSACTION OF BUSINESS

All business of an organization is initiated and concluded by motions; the discussion on the merits of the idea follow, not precede, the making of a motion. Each motion should be handled in the following manner:

- 1. Made: Any member previously recognized by the chair may make a motion.
- 2. Seconded: Without being recognized, any member may second a motion.

- 3. Stated: The chair should repeat the motion by virtue of which the chair implicitly:
 - (a) decides that the motion is in order; and
 - (b) delivers the question, as it were, to the membership.
- 4. Discussed and possibly amended: As to all debatable motions, the maker has the right to speak first; amendments are voted on before the final vote on the motion. Some special motions, like the motion to "table" are not debatable.
- 5. Vote taken: The chair must indicate the manner of voting, e.g. by voice, show of hands, rising, and if any doubt exists, the effect of the voting for or against the motion.
- 6. Results announced: The chair should ordinarily be prepared to give the tally of votes cast, particularly if there is a question about outcome.

In our Annual Conference, resolutions and other main motions cannot be considered (come to the "floor") until they have been acted on by one of the legislative sections of the Conference. The legislative section chairperson, not the author of the motion, therefore, moves its adoption.

PRECEDENCE

A definite and logical order governs introduction and disposition of the secondary motions which may come before the meeting while some main motion is under consideration. This means that the motion higher on the list must be dealt with first, or to state the obverse, the motion lower on the list must yield or wait its turn for disposition of the higher.

This is called the Order of Precedence of Motions, and is as follows:

- 1. Fix the time for next meeting
- 2. Adjourn
- 3. Recess
- 4. Question of privilege
- 5. Lay on the table
- 6. Vote immediately (Previous Question)
- 7. Limit Debate
- 8. Postpone to a definite time
- 9. Refer to a committee
- 10. Amend the main motion
- 11. Postpone indefinitely
- 12. Main motion

FREQUENT SITUATIONS

Amendments: Subject to the following rules, any motion can be amended if it is logically subject to being changed:

- 1. Amendment must be germane (relevant) to the motion.
- 2. Amendment may be opposite in the direction or spirit of the motion so long as it does not nullify it.

- 3. Amendment must be in the form of insertion, elimination, or substitution, and the form must be specified when the amendment is offered.
- 4. Any number of primary amendments (to the motion) may be made so long as they are made and disposed of one at a time.
- 5. Any number of secondary amendments (to a primary amendment) may be made so long as they are made and disposed of one at a time.
- 6. All amendments require a majority vote regardless of the vote required on the motion to which they may apply.

Substitute: In United Methodist circles a custom has developed which has no written origin in any parliamentary text: that a motion to "substitute" a whole sentence, paragraph, or motion is a special kind of secondary motion that "takes precedence" over other amendments and can be applied to almost any other motion.

Asking Questions/Points of Order: If a member is uncertain about the meaning or effect of a particular motion or resolution, the member may ask the chair or another member by simply addressing the chair and saying, "I would like to ask a question," or its equivalent. If the question is related to the procedure, the member would say instead, "I would like to ask a parliamentary question," or say, "Parliamentary inquiry." If the member believes the Rules have been violated in some way, the call should be "Point of Order." These statements are always in order except during the actual process of a vote.

Voting:

- 1. Motions are voted on either when no one wishes to speak further on the motion, or pursuant to a motion to "vote immediately," traditionally called the "previous question."
- 2. The motion to vote immediately must be made, seconded, stated and itself voted on and approved by a 2/3 vote before the vote is taken on the otherwise pending motion.
- 3. A call of "Question" by a member not recognized by the chairperson has no significance whatsoever.

WHEREAS 1 Corinthians 11:17-18 states, "I don't praise you as I give the following instruction because when you meet together as a church, it does more harm than good. When you meet together, I hear that there are divisions among you...",

WHEREAS *The Book of Discipline of The United Methodist Church - 2016* states in paragraphs 103 and 104 that John Wesley's Explanatory Notes on the New Testament are doctrinal standards of The United Methodist Church,

WHEREAS John Wesley's notes for 1 Corinthians 11:18 denounce divisional statements in the Church, stating, "It is plain that by schisms is not meant any separation from the church, but uncharitable divisions in it; for the Corinthians continued to be one church; and, notwithstanding all their strife and contention, there was no separation of any one party from the rest, with regard to external communion. And it is in the same sense that the word is used, 1 Corinthians 1:10; 1 Corinthians 12:25; which are the only places in the New Testament, beside this, where church schisms are mentioned. Therefore, the indulging any temper contrary to this tender care of each other is the true scriptural schism. This is, therefore, a quite different thing from that orderly separation from corrupt churches which later ages have stigmatized as schisms; and have made a pretence for the vilest cruelties, oppressions, and murders, that have troubled the Christian world. Both heresies and schisms are here mentioned in very near the same sense; unless by schisms be meant, rather, those inward animosities which occasion heresies; that is, outward divisions or parties: so that whilst one said, 'I am of Paul,' another, 'I am of Apollos,' this implied both schism and heresy. So wonderfully have later ages distorted the words heresy and schism from their scriptural meaning. Heresy is not, in all the Bible, taken for 'an error in fundamentals,' or in anything else; nor schism, for any separation made from the outward communion of others. Therefore, both heresy and schism, in the modern sense of the words, are sins that the scripture knows nothing of; but were invented merely to deprive mankind of the benefit of private judgment, and liberty of conscience.",

WHEREAS paragraph 125 of *The Book of Discipline of The United Methodist Church* – 2016 states, "United Methodists throughout the world are bound together in a connectional covenant in which we support and hold each other accountable for faithful discipleship and mission.",

WHEREAS paragraph 4 of *The Book of Discipline of The United Methodist Church* – 2016 states, "The United Methodist Church is a part of the church universal, which is one Body in Christ. The United Methodist Church acknowledges that all persons are of sacred worth. All persons without regard to race, color, national origin, status, or economic condition, shall be eligible to attend its worship services, participate in its programs, receive the sacraments, upon baptism be admitted as baptized members, and upon taking vows declaring the Christian faith, become professing members in any local church in the connection. In The United Methodist Church no conference or other organizational unit of the Church shall be structured so as to exclude any member or any constituent body of the Church because of race, color, national origin, status or economic condition.",

WHEREAS paragraph 304.3 of The Book of Discipline of The United Methodist Church –

44 2016 states, "While persons set apart by the Church for ordained ministry are subject to all

45 the frailties of the human condition and the pressures of society, they are required to

46 maintain the highest standards of holy living in the world. The practice of homosexuality

is incompatible with Christian teaching. Therefore self-avowed practicing homosexuals are not to be certified as candidates, ordained as ministers, or appointed to serve in The United Methodist Church,",

WHEREAS paragraph 161.C of *The Book of Discipline of The United Methodist Church* - 2016 states, "We affirm the sanctity of the marriage covenant that is expressed in love, mutual support, personal commitment, and shared fidelity between a man and a woman.
 We believe that God's blessing rests upon such marriage, whether or not there are children of the union. We reject social norms that assume different standards for women than for men in marriage. We support laws in civil society that define marriage as the union of one man and one woman.",

WHEREAS paragraph 161.G of The Book of Discipline of The United Methodist Church -2016 states, "We affirm that sexuality is God's good gift to all persons. We call everyone to responsible stewardship of this sacred gift. Although all persons are sexual beings whether or not they are married, sexual relations are affirmed only with the covenant of monogamous, heterosexual marriage. We deplore all forms of the commercialization, abuse, and exploitation of sex. We call for strict global enforcement of laws prohibiting the sexual exploitation of children and for adequate protection, guidance, and counseling for abused children. All persons, regardless of age, gender, marital status, or sexual orientation, are entitled to have their human and civil rights ensured and to be protected against violence. The Church should support the family in providing age-appropriate education regarding sexuality to children, youth, and adults. We affirm that all persons are individuals of sacred worth, created in the image of God. All persons need the ministry of the Church in their struggles for human fulfillment, as well as the spiritual and emotional care of a fellowship that enables reconciling relationships with God, with others, and with self. The United Methodist Church does not condone the practice of homosexuality and considers this practice incompatible with Christian teaching. We affirm that God's grace is available to all. We will seek to live together in Christian community, welcoming, forgiving, and loving one another, as Christ has loved and accepted us. We implore families and churches not to reject or condemn lesbian and gay members and friends. We commit ourselves to be in ministry for and with all persons.",

WHEREAS paragraph 613.19 of *The Book of Discipline of The United Methodist Church* − 2016 states that the Conference Council on Finance and Administration shall have authority and responsibility, "To ensure that no annual conference board, agency, committee, commission, or council shall give United Methodist funds to any gay caucus or group, or otherwise use such funds to promote the acceptance of homosexuality or violate the expressed commitment of The UMC "not to reject or condemn lesbian and gay members and friends" (¶ 161F). The council shall have the right to stop such expenditures. This restriction shall not limit the Church's ministry in response to the HIV epidemic, nor shall it preclude funding for dialogs or educational events where the Church's official position is fairly and equally represented.",

WHEREAS paragraph 2702.1 of *The Book of Discipline of The United Methodist Church* -2016 states, "A bishop, clergy member of an annual conference (¶ 370), local pastor, clergy on honorable or administrative location, or diaconal minister may be tried when charged (subject to the statute of limitations in ¶ 2702.4) with one or more of the following offenses: (a) immorality including but not limited to, not being celibate in singleness or not faithful in a heterosexual marriage; (b) practices declared by The United Methodist Church

to be incompatible with Christian teachings, including but not limited to: being a selfavowed practicing homosexual; or conducting ceremonies which celebrate homosexual unions; or performing same-sex wedding ceremonies; (c) crime; (d) disobedience to the order and discipline of The United Methodist Church; (e) dissemination of doctrines contrary to the established standards of doctrine of The United Methodist Church; (f) relationships and/or behavior that undermines the ministry of another pastor; (g) child abuse; (h) sexual abuse; i) sexual misconduct including the use or possession of

- pornography, (j) harassment, including, but not limited to racial and/or sexual harassment;
