SYLLABUS OF BISHOP LATRELLE MILLER EASTERLING'S RULINGS ON QUESTIONS OF PRESENTED DURING THE CLERGY EXECUTIVE SESSION OF THE BALTIMORE-WASHINGTON CONFERENCE ON MAY 30, 2018

Introduction

A Clergy Session of the Baltimore-Washington Conference of The United Methodist Church (Conference) was held in Baltimore, MD, on Wednesday, May 30, 2018. The Clergy Session commenced at approximately 1:30 p.m.; recessed for dinner and worship shortly after 5:00 p.m.; and reconvened that same evening after worship was concluded. The principal item of business during the Clergy Session was to consider the report of the Conference's Board of Ordained Ministry (BOOM), including its recommendation on the election of 29 clergy candidates as provisional members or members in full connection.¹

This syllabus addresses two questions of law that were presented to Bishop LaTrelle Miller Easterling during this Clergy Session, both by the Rev. Mark Gorman. Rev. Gorman presented his first question of law before the Clergy Session recessed for dinner and worship. Rev. Gorman's second question of law was presented after Clergy Session reconvened the same evening, and before Bishop Easterling had ruled on Rev. Gorman's first question. As explained below, Bishop Easterling has concluded that Rev. Gorman's second question of law was intended to, and did in fact, supersede his first question, rendering the earlier question moot. Bishop Easterling rendered her ruling on Rev. Gorman's second question during the Clergy Session, but that ruling and its rationale are also outlined in this syllabus.

Statement of Facts

The facts recited here are relevant to both of the questions of law Rev. Gorman presented to Bishop Easterling.

BOOM's Policy on Human Sexuality

By way of background, in October 2017, BOOM voted to adopt the following Policy on Human Sexuality:

One of the primary purposes of the Board of Ordained Ministry is "to examine applicants and assess their fitness for ministry." We understand the Judicial Council's most recent rulings to encourage a full and thoughtful inquiry of all persons who come before us, using the range of questions and standards found in paragraphs 310, 324, 330 and 335 of the Book of Discipline for provisional membership, Deacon or Elder respectively. We write in response to these rulings' specific mandate to not ignore in the inquiry a candidate's self-disclosure of sexual orientation. We respectfully disagree with these rulings, acknowledging that the following policy is not compliant with the Book of Discipline.

The Board of Ordained Ministry will examine and assess all candidates who come before us. Knowing each of us is a child of God, made in God's image, and a recipient and vehicle of God's grace, we do not view race, ethnicity, gender, sexual orientation, marital status, or age as a barrier to ministry. We will not consider or evaluate sexual orientation or gender identity nor see them to be sufficient reasons to

deny a candidate's ability to live up to our United Methodist standards. We will utilize our denomination's expectation of faithfulness in marriage and celibacy in singleness within our examination and expect not only high moral standards but also a strong sense of self-awareness about one's relational life. Our aim is to promote well-grounded, Spirit—led, equipped ministers of the Gospel who live up to the high standards for fitness, readiness, and effectiveness in ministry.

We acknowledge that The United Methodist Church is not of one mind around issues of human sexuality, and affirm the ongoing work of the Commission on a Way Forward. We believe this policy upholds the expectation of a full inquiry and high moral standards of all candidates. It also reflects some of our core values as a Board, including openness to the Holy Spirit, deep listening to one another, and a commitment to justice for all. We affirm the right and responsibility of all Board members to engage in holy conferencing during deliberations and to vote their conscience following a fair examination of all candidates.²

Preliminary Ruling on a Point of Order

Against that backdrop, when the Clergy Session turned to consider the portion of BOOM's report relating to the election of candidates for ministry, the Rev. John Rudisill raised a point of order, objecting that the Board's report was based on a policy for examining clergy candidates that violated ¶ 304.3 of *The Book of Discipline of The United Methodist Church* ("Discipline").³ To assist in ruling on the point of order, Bishop Easterling posed a question to the Chair of the Board of Ordained Ministry, the Rev. Dr. C. Anthony Hunt, asking, "Dr. Hunt, in terms of the examination of the candidates, can you tell us: Were the candidates examined in accordance with the *Book of Discipline*, specifically paragraph 304.3?" Dr. Hunt replied that, insofar as human sexuality was concerned, all candidates were asked, "Are you faithful in marriage and celibate in singleness?" When asked by Rev. Rudisill whether any candidates were asked "if they were practicing homosexuals," Dr. Hunt replied that BOOM asked only "Are you faithful in marriage and celibate in singleness," and further stated that BOOM believed it "did not have sufficient reason . . . to ask the question as [Rev. Rudisill] framed it."

Following an exchange between another elder and Dr. Hunt, Bishop Easterling stated that it was her recollection that "during last year's annual conference there was one person who came to the floor of the conference and self-avowed that that individual was a practicing homosexual." Bishop Easterling then asked Dr. Hunt, "Is that individual in the list of candidates that you have brought forward?" In reply, Dr. Hunt ultimately answered the Bishop's question in the affirmative. "If that is the case," Bishop Easterling stated, "then you didn't need a charge [or] other documentation to inquire as of that candidate with respect to [Judicial Council] Decision 1341 and the other decisions that have been . . . named on the floor of this clergy session as well as the Book of Discipline" Dr. Hunt further confirmed that, consistent with the policy BOOM adopted in October 2017, the candidate the Bishop was recalling had not been re-

examined by BOOM following the Judicial Council's rulings in Decisions 1341, 1343 and 1344."

At that point, Bishop Easterling ruled on Rev. Rudisill's point of order as follows:

[W]ith respect to what [Dr. Hunt has] just shared and acknowledged and what I recall of last year's annual conference, I believe that I have to say that this portion of the Board of Ordained Ministry's report is out of order.

Presentation of Rev. Gorman's First Question of Law

Shortly after Bishop Easterling made her ruling on Rev. Rudisill's point of order, Rev. Gorman took the floor and stated that, "[g]iven the seriousness of this situation," he thought it appropriate to ask Bishop Easterling for a ruling on the following question of law, which he also submitted in writing to the Conference Secretary:

On the basis of the policy of the Board of Ordained Ministry for this annual conference reported on April 6, 2018, specifically that policy's candid admission that it is not compliant with The Book of Discipline, and on the basis of The Book of Discipline ¶¶ 604.1, 604.3 and 635.1(b), as well as numerous judicial council rulings, I ask: "Must the annual conference exclude from its business the portion of the report of the Board of Ordained Ministry pertaining to the election of candidates for membership or provisional membership?"

Bishop Easterling did not issue a ruling on this question of law at that time, but announced that she expected to render a ruling before the Clergy Session was concluded. There followed much discussion about various options that might be pursued in light of the Bishop's ruling on Rev. Rudisill's point of order. The possibilities mentioned including having BOOM re-interview the candidates and then report back; having the Bishop interview the candidates; and bringing the candidates before the Clergy Session to be interviewed by the body as a whole. Shortly after 5:00 p.m., Bishop Easterling put the Clergy Session in recess, to allow time for dinner and worship.

Rev. Gorman's Second Question of Law, Following a Further Report from BOOM, and Bishop Easterling's Ruling on that Question

When the Clergy Session reconvened later that evening, Dr. Hunt, as Chair of BOOM, made the following report to the body:

Members of the Board of Ordained Ministry had a chance to meet with all of the candidates prior to dinner this evening. . . . All candidates were given an opportunity to offer information and self-disclosure about any issues that were not brought up in the profiling and examination, particularly as it pertained to human sexuality. No additional information was shared with us.

We do want to share with the body that in the course of [BOOM's] profiling, two of our candidates shared in writing that they . . . are married to persons of the same gender, T.C. Morrow and Joseph Heath. That is the information that we have that pertains to the report.

Immediately after Dr. Hunt concluded his report, Rev. Gorman came to a microphone and stated that, "[i]n light of Dr. Hunt's report, I would move that we remove these two candidates from consideration for this session of the clergy." Upon inquiry by Bishop Easterling, Rev.

Gorman reframed his motion as a question of law, as follows: "Must this session of the clergy exclude these two candidates on the basis of Dr. Hunt's report and on the basis of The Book of Discipline ¶ 304.3?"

After reminding Rev. Gorman to submit his second question of law in writing, Bishop Easterling rendered the following ruling on that question:

[B]eloved, as I shared earlier, typically I have thirty (30) days to rule on a question of law but I can't wait thirty days to rule on this information . . . that is now before us. The matter that was causing us to not be able to move forward on [BOOM's] report was the concern that the Board of Ordained Ministry had not done a full inquiry as some believe that the Book of Discipline requires and several of the Judicial Council's rulings require. The Board met with the candidates, both those for commissioning and those for elders orders, and asked for full disclosure on those matters. No other persons came forward except the two who had already disclosed in writing as a part of their profile that they are married to same-gendered partners. In light of that fact, in light of Decision 1341 by the Judicial Council and several that followed thereafter and the *Book of Discipline* and the Baltimore-Washington Conference rules, I rule, to this question of law, that these two individuals are not able to come forward as candidates either for commissioning or for ordination.

After receiving this ruling on his second question of law, Rev. Gorman made a motion that the body proceed forward with voting on the <u>other</u> clergy candidates that had been recommended in BOOM's report, i.e., all but the two excluded by Bishop Easterling's ruling. The body approved Rev. Gorman's motion to move forward with the election of those other candidates, and never took any vote on the two excluded candidates.

Disposition and Analysis

Bishop Easterling's Ruling on Rev. Gorman's First Question of Law

The Judicial Council has repeatedly held that bishop may not provide substantive responses to moot or hypothetical questions. *See* JCD 33, 799. Based on the ordinary usage of the word, a question may be understood to be moot when it has been "deprived of practical significance: made abstract or purely academic." See https://www.merriam-webster.com/dictionary/moot (accessed June 27, 2018). In addition, the Judicial Council has explained that to avoid being deemed moot or hypothetical, a question of law must either (1) "be germane to the regular business, consideration, or discussion of the Annual Conference and shall state the connection to a specific *action taken*," or (2) "the question must be raised during the deliberation of a specific issue of a matter upon which the conference *takes action*." JCD 799 (emphasis added).

Based on these understandings, the <u>first</u> question of law presented by Rev. Gorman during the Clergy Session convened on May 30, 2018, is deemed moot. At the time Rev. Gorman presented that question, the Conference had not yet taken any action on the clergy candidates recommended in BOOM's report. Moreover, although Rev. Gorman's first question was germane to an action the annual conference was being <u>asked</u> to take <u>at the time</u>—namely, to vote on all 29 clergy candidates recommended in BOOM's report for membership or provisional membership—the annual conference never subsequently

took that action either. On the contrary, following the recess, the focus of Clergy Session's deliberations regarding the clergy candidates changed based on the further report received from BOOM's Chair, Dr. Hunt, which in turn led Rev. Gorman himself to pose his distinct, <u>second</u> question of law—a question now tailored to correspond to the facts newly illuminated in Dr. Hunt's post-recess report.

More specifically, whereas Rev. Gorman's first question sought to exclude the *entirety* of that portion BOOM's report "pertaining to the election of candidates for membership or provisional membership," the question Rev. Gorman posed following Dr. Hunt's clarifying report sought only to "exclude . . . two candidates on the basis of Dr. Hunt's report," namely the two candidates that had acknowledged being married to persons of the same gender. Indeed, the record demonstrates that Rev. Gorman himself regarded his second question of law as *superseding* the first, rendering his initial question moot. That is the only reasonable conclusion to draw from the fact that, after receiving Bishop Easterling's ruling on the second question, it was Rev. Gorman who made the motion, subsequently approved by the body, that the Clergy Session should proceed forward with voting on all of the remaining clergy candidates recommended by BOOM.

Bishop Easterling's Ruling on Rev. Gorman's Second Question of Law

As indicated above, Bishop Easterling rendered a substantive ruling on Rev. Gorman's second question of law immediately after it was presented. The rationale for that ruling may be stated succinctly. As the Judicial Council emphasized in Decision 1352—which itself concerned BOOM's prior consideration of one of the candidates excluded here—the opinions handed down in "Decisions 1341, 1343 and 1344 prevent a Board of Ordained Ministry from ignoring statements of self-disclosure about any action that violates any portion of church law as is the case of the candidate who acknowledged that she is a lesbian and married to another woman." Those holdings, which stand as binding interpretations of the provisions of the *Discipline* currently in force, dictate that the two individuals excluded by my ruling, both of whom have acknowledged being married to persons of the same gender, may not "certified as candidates, ordained as ministers, or appointed to serve in The United Methodist Church." *Discipline* ¶ 304.3.

Response from the Dean and the Cabinet.

Conrad O. Link

The question before us as an Executive session is: "are all the clergy members of the conference blameless in their life and official administration?"

Every year, for 38 years, I have heard this question read and answered by the Dean of the Cabinet who offered the official response. When I would hear this question, early in my pastoral ministry, I was hoping and praying that I could live up to the ideals it reflected. I was glad I would never have to answer this question in front of all the clergy and my colleagues. What would I say?

When I got into my middle career, when things were rolling along for me in ministry, I usually just sat quietly, maybe joked with a few colleagues about some of the behaviors and rumors we all heard about various colleagues.

But now, I am Dean of the Baltimore-Washington Conference Cabinet. This is a tremendous honor, but with it comes this question and I am compelled to answer.

The best way to answer this question is with a simple: "No." All clergy are not blameless in their life and, no, all clergy are not effective or sufficient in their official administration."

Each clergy person -- ordained, commissioned, licensed, and credentialed -- in this Annual Conference is called to the highest ideals of servant leadership as they proclaim the Gospel. We are called to live a life worthy of the Gospel, modeling to those within the faith community and those in the world a life dedicated to the highest standard of morality, integrity, service, obedience, and faith that allows others to see Christ in us. As an old Sunday school teacher said: "You might be the only Bible someone might read" (William Toms).

It is quite possible that some of our clergy/pastors have forgotten their call, not just to preach but to live a life that becomes the Gospel. Increased issues of immorality, lack of integrity, disobedience to authority, and financial mismanagement are becoming all too common. Some of our colleagues have elevated their personal agendas over the agenda of Christ and the Church. Clergy immaturity seems to be on the rise as self-centeredness and self-aggrandizement becomes a mode of operation that works contrary to building the Kingdom of God.

Colleagues: the majority of our clergy are doing well. Perhaps over-stressed, worn out and tired, but faithful to the call. Perhaps some colleagues get side tracked from time to time but, through prayer and proclamation, they return and continue their faith journey. Perhaps some of us, you and I, get tired of the pettiness and silliness that happens in the church. Then, we remember that "there, but for the grace of God go I." We remember we are all children of God. We reclaim grace.

Colleagues: Let it be known that the clergy and pastors of the Baltimore-Washington Conference are not perfect, but they are seeking to be better in the pursuit of faithfulness in word, order, sacrament, service, and witness. Let it be known that these same clergy seek to honor their call by supporting the church, with all their prayers, presence, gifts, service and witness. Let it be known that the clergy and pastors of this historic conference are not perfect, but are forgiven, and that with humility we offer the same forgiveness that we have received to others we meet along the way.

As we focus on the idea of servant leadership, know that your Cabinet stands ready to help and eager to hear the issues and work with you to overcome troubles and anxieties. Together, let us embrace the covenant that has held us throughout the generations, "I am no longer my own, but God's. ... May we ...freely and fully surrender all things to God's glory and service."

And now, O wonderful and holy God, Creator, Redeemer, and Sustainer, you are ours and we are yours. May it be so. Amen.

BOOM policy on Human Sexuality⁴

The Baltimore-Washington Board of Ordained Ministry has served on behalf of all persons across the Conference called to representative ministry of the Church as licensed, commissioned and ordained persons. This year, BOOM has sought to strengthen its work by engaging in several initiatives which have included working throughout the year to continue to clarify and affirm our values in light of the stated values of the Baltimore-Washington Conference and The United Methodist Church. Additionally, the Board's Human Sexuality Task Force has worked to help clarify Board policy and practices with regard to the diversity among those we serve on behalf of the Church.

An important part of the Board's work, in accordance with paragraph 635 of the 2016 Book of Discipline, involves serving as stewards of the process of supporting, evaluating and examining persons who have offered themselves as candidates for ordained ministry as Deacons and Elders. In October 2017, a proposal from the Board's Task Force on Human Sexuality was approved by the full Board, which has served as a framework for the evaluation of candidates for ordained ministry. Their overarching goals have remained to discern ways that together the people of the Baltimore-Washington Conference can continue to engage in ministry that is faithful and fruitful toward the end of making disciples of Jesus Christ for the transformation of our communities and the world.

The rationale and policy affirmed and adopted by the Baltimore-Washington Conference Board of Ordained Ministry in October 2017 states that:

One of the primary purposes of the Board of Ordained Ministry is "to examine applicants and assess their fitness for ministry." We understand the Judicial Council's most recent rulings to encourage a full and thoughtful inquiry of all persons who come before us, using the range of questions and standards found in paragraphs 310, 324, 330 and 335 of the Book of Discipline for provisional membership, Deacon or Elder respectively. We write in response to these rulings' specific mandate to not ignore in the inquiry a candidate's self-disclosure of sexual orientation. We respectfully disagree with these rulings, acknowledging that the following policy is not compliant with the Book of Discipline.

The Board of Ordained Ministry will examine and assess all candidates who come before us. Knowing each of us is a child of God, made in God's image, and a recipient and vehicle of God's grace, we do not view race, ethnicity, gender, sexual orientation, marital status, or age as a barrier to ministry. We will not consider or evaluate sexual orientation or gender identity nor see them to be sufficient reasons to deny a candidate's ability to live up to our United Methodist standards. We will utilize our denomination's expectation of faithfulness in marriage and celibacy in singleness within our examination and expect not only high moral standards but also a strong sense of self-awareness about one's relational life. Our aim is to promote well-grounded, Spirit—led, equipped ministers of the Gospel who live up to the high standards for fitness, readiness, and effectiveness in ministry.

We acknowledge that The United Methodist Church is not of one mind around issues of human sexuality, and affirm the ongoing work of the Commission on a Way Forward. We believe this policy upholds the expectation of a full inquiry and high moral standards of all candidates. It also reflects some of our core values as a Board, including openness to the Holy Spirit, deep listening to one another, and a commitment to justice for all. We affirm the right and responsibility of all Board

members to engage in holy conferencing during deliberations and to vote their conscience following a fair examination of all candidates.

Clergy Session

Marriott Waterfront, Baltimore Wednesday, May 30, 2018 | 1:30 p.m.

Bishop LaTrelle Easterling invited all to come in so that the session could begin.

* * *

The Rev. C. Anthony Hunt, Chair of the Board of Ordained Ministry, greeted those assembled. Bishop Easterling thanked the Worship Team for centering those in attendance in such a beautiful way. She reminded those present that there was very important work before them and that it is work required by the Discipline. "We are here in one covenant," she declared. "All children of God covered by the grace of God." Bishop Easterling said that there had been a lot of talk and speculation about how the session would unfold and reminded everyone "we are brothers and sisters in Christ, in covenant with one another. We will respect one another. We will speak with dignity and calmness. And we will not use words that are offensive or even words that might provoke a strong response. We are 'One Body Beneath the Cross.'"

Hunt read the Clergy Session Organizing Motion. It passed.

Rev. Hunt invited the Rev. Conrad Link, Dean of the Cabinet, to give the Cabinet's response to Disciplinary Question 17.

The Rev. Mark Gorman, speaking as Chair of the Conference Rules Committee, raised a point of order question: "Concerning the Board and its work especially in light of its policy adopted and that was announced in April, I ask whether according to our Annual Conference rules, especially ¶5410.1.B.1, which states 'The Presiding Officer shall see that all business pertaining to the Conference is brought before it, and conducted in accordance with the provision of the *Discipline* and the Rules of the Session' and also in light of Book of Discipline ¶604.1 whether or not the report of the Board of Ordained Ministry should be in order at this point."

Bishop Easterling responded, "It is the understanding of the chair that we can receive the report of the Board of Ordained Ministry. We can take it seriatim so that items of the report that are not in question might be duly acted upon then portions of the report that anyone deems out of order could be addressed at that time."

Gorman moved that it would be in order.

Link, Dean of the Cabinet, gave the Cabinet's response to Question 17.

Hunt presented the Board of Ordained Ministry narrative report that can be found in Section VI Reports. . . .

* * *

Continuing his report, Hunt said that "three areas that give particular evidence to the work of the Board of Ordained Ministry this year" and the importance of the work they do are The Residency in Ministry Program (RIM) coordinated by the Rev. Ron Foster; the Culture of the Call, chaired by the Rev. Kirkland Reynolds; and the Task Force on Human Sexuality,

co-chaired by the Revs. Amy McCullough and Bruce Jones. They came forward and shared briefly on their work.

* * *

McCullough gave an accounting of the work done by the Task Force on Human Sexuality, formed in June of 2017 with a charge "to review the Board's recent policies on sexuality, gender identity and marriage as it relates to the examination of candidates for ministry." Based on this work, the task force was to make recommendations for future policies. The task force was comprised of nine members of the board including Elders, Deacons and laity. McCullough described how they approached their task. On October 2017, the Board adopted its policy, used it in their examinations in January and February, and shared it with the Conference in April 2018.

Hunt began leading the session through the Disciplinary Questions regarding clergy.

* * *

Question 25, which listed clergy in good standing who have been approved to serve within the bounds of the Annual Conference, was approved. Question 26.b. listed Affiliate members with no vote who were approved by two-thirds of the body to serve without vote in the Annual Conference and Question 26.a. had no one listed nor did Question 27.

Gorman asked in reference to the question he asked earlier, if Question 28 could be treated *ad seriatim* and continue with the report and come back to these sections and perhaps picking up at question 35 to continue with those parts of the report least likely to cause discussion and debate. Bishop Easterling agreed to move to Question 35 and then return to Question 28.

* * *

Hunt came forward to return to page 9 of the report, Question 28. The Rev. John Rudisill, Montgomery Church, raised a point of order stating that he believed it was an "inappropriate motion as it stands." He then read:

"No main motion is in order that conflicts with the corporate charter, constitution or bylaws and to the extent that the procedure rules applicable to the organization or assembly are prescribed by federal, state or local law, no main motion is in order that conflicts with such rules." And he concluded, "So I believe that in its current constitution that this motion is out of order."

Bishop Easterling asked what he was reading from and he replied, "Roberts Rules of Order."

Bishop Easterling clarified that he was raising an objection to this portion of the Board of Ordained Ministry report coming forward. The bishop deferred to the Chancellor on whether or not "raising a civil question is appropriate for the body operating under the Book of Discipline and the rules of the Baltimore-Washington Conference." Rudisill cited ¶304.3 of the Discipline. Bishop Easterling stated that he was raising ¶304.3 for this part of the report.

Bishop Easterling asked Hunt if the candidates were examined in accordance with the Book of Discipline, specifically ¶304.3. Hunt replied that the Board of Ordained Ministry engaged in

what they deemed to be a full examination of each candidate based on the candidate's qualifications of which they were aware, definitions they reviewed and that the task force reviewed pertaining to these and other paragraphs including ¶365 and Judicial Council rulings that pertained to this. The question candidates were asked was, "Are you faithful in marriage and celibate in singleness?" They reviewed information from the candidates, from their local settings, District Superintendents and District Committees on Ministry. All of the information was included in what they deemed to be a "full examination of each candidate." He felt the they adhered to those criteria and in terms of their review of good standing; they were not given any information on any candidate of the 29 being recommended that it was in violation of ¶2702 chargeable offenses.

Rudisill asked Hunt if, in light of Judicial Council Decision 1344, did the Board in faithfulness to that decision ask the candidates if they were practicing homosexuals? Hunt responded "no." He said that question was not asked in that way of any of the candidates. The question they asked on examination pertained to the Disciplinary Question: "Are you faithful in marriage and celibate in singleness?" They did not have a provision or guidance to ask the question as Rudisill framed it of any candidate. They did not have sufficient reason to ask the question as he framed it of any candidate. No information was presented from the local settings, from the District Committee on Ministry or the District Superintendents, or Supervisors or Recommender that indicated need to ask that question.

Gorman asked Hunt if he was aware of Judicial Council Ruling 1352, which is a ruling in response to the Board's action which requires the questions be asked. Hunt said that he was aware of it. Gorman asked if the Board was aware of the policy when the decision was made and if decision 1352 was part of the Board's decision making. Hunt said that the information they shared was a matter of transparency with the Conference and clarity about their operating policies and practices. The information shared with the conference stated the Board's awareness of Judicial Council Rulings.

Bishop Easterling had a question for Hunt. She stated that last year, one person was a "self-avowed homosexual" and asked if that person was included in the list of candidates. Hunt said he did not recall the person indicating they were a self-avowed but conceded that "yes," based on his understanding of self-avowed, the person was. The bishop said if that were the case, there was no need for documentation or other cases or decisions. Hunt said they did not re-examine the candidate and sent communication to the bishop's office in October 2017.

Bishop Easterling explained that the Episcopal Office does not direct the work of the Board of Ordained Ministry when they are in session. It is not appropriate to speak to votes taken internally as they are doing their work. The first opportunity to speak to the work is when it comes to the clergy session at Annual Conference. The bishop ruled that this part of the Board's report was out of order.

Rudisill requested a brief recess for additional consultation, which was not granted. Gaines-Cirelli voiced concern about relying on something said last year for making a decision this year, and asked to see the minutes from last year's Annual Conference Session to see if there was a public self-avowal.

The Rev. Laura Blauvelt, Potomac, asked for clarity by the bishop if she is ruling this part of the Board's report is out of order and what that does for all the candidates being recommended by the Board at this time. Bishop Easterling offered several alternative actions that could be taken.

She stated that she believed the Board was clear in their statement and that it was published in the *UMConnection* newspaper. She added that she wanted to avoid as much "gamesmanship" as possible. The Board was clear that they were not going to examine candidates with respect to whether or not those candidates met the definition of self-avowed practicing homosexuals. The question is whether the entire class has been fully examined. Bishop Easterling said the Judicial Council has said not only do you have to give the depth but also you have to give the full breath of the examination, which would include whether or not any persons being brought forth as candidates meet the definition of self-avowed practicing homosexuals.

Gorman asked for a ruling on a question of law: "On the basis of the policy of the Board of Ordained Ministries of this Annual Conference, reported on April 6, 2018 (http://www.bwcumc.org/news-and-views/boom-revises-policy-that-addresses-homosexuality/) and confirmed by Board's chair in this Clergy session, specifically, that policy's candid admission that it is 'not compliant with the Book of Discipline,' and on the basis of The Book of Discipline ¶604.1, 604.3, and 635.1.b. as well as numerous Judicial Council rulings (e.g., #s 96, 690, 886, 1330, and 1352), I ask the following questions of law: Must the Annual Conference exclude from its business the portions of the report of the Board of Ordained Ministries [sic] pertaining to the election of candidates for membership or provisional membership?"

Bishop stated she would rule on request before the end of the Clergy Session.

The Rev. Roberta Scoville, retired clergy, said that she was uncertain as to what options the body has. She asked if moving forward did they have the right to ask to hear the report.

Bishop Easterling responded that she believed the body had the right to examine the candidates for provisional and full membership. The Rules Chair confirmed this. Scoville asked if the body had the right to question the candidates.

Gorman said there were two options (both of which the bishop had previously stated): 1) The bishop could recess and examine the candidates herself and report back to the body; 2) The body has the right, according to the Book of Discipline, to ask questions related to character and to interview each candidate individually. His preference was for the bishop to do that.

Hunt, speaking on behalf of the Board of Ordained Ministry, explained that the policy was prayerfully adopted and that there was serious deliberation to clarify the values of the board and of the Annual Conference. They stand behind all 29 candidates and the recommendations. For the good of the church and of the candidates, Hunt suggested the Board convene and question each candidate on the homosexuality question.

The Rev. Mary Kay Totty moved that "this clergy session of the Baltimore-Washington Conference affirm the work of the Board of Ordained Ministry and claim as a policy of the entire clergy session that we support the policy adopted by BOOM and we are completely satisfied with the thorough and full examination the Board of Ordained Ministry has made candidates undergo." The motion was seconded. Bishop Easterling ruled that the motion was out of order because they would be voting to codify an action that is outside the Book of Discipline as well as the rules of the Baltimore-Washington Conference. Totty responded

that the motion is in keeping with the Jurisdictional Conference of 2016. Easterling again said the motion is out of order.

An unidentified clergy member questioned if he heard correctly that the Board was willing to meet with and examine the candidates according to the Book of Discipline. Bishop Easterling confirmed that it was correct. Asked if it was appropriate to make a motion to be adjourned so that the Board could complete that task and meet again when the task was completed. Bishop Easterling confirmed with Hunt that he would fully examine the candidates in keeping with the Book of Discipline as well as the Judicial Council rulings. Hunt replied that he felt they had done a full examination but if necessary he would ask the question on human sexuality. He asked for further instruction from the bishop.

Bishop Easterling said that beyond what it says in the Book of Discipline around the meeting of the Annual Conference, ¶33 of the Book of Discipline states that "the annual conference is the basic body in the church and as such shall have reserved to it the right to vote on all constitutional amendments, on the election of clergy and lay delegates to the General and the jurisdictional or central conferences, on all matters relating to the character and conference relations of is clergy member, and on the ordination of clergy and such other rights as have not been delegated to the General Conference under the Constitution..." The bishop reiterated that the body has the right to examine the candidates before them for provisional and full membership within the Annual Conference.

* * *

Rev. Debbie Scott, Calvary Mt. Airy, raised a Point of Information. She was concerned about how the candidates were prepared for being examined when for years they have been "automatically" sending candidates through. She questioned what they had been told as they were waiting. Bishop Easterling acknowledged that she appreciated the Scott's question. She explained that persons longing to become provisional or full members of the Baltimore-Washington Conference have an obligation to read and to retain what is in the Book of Discipline and to expect examination, as it is the right of the Annual Conference. The bishop said that when a committee, agency or board take actions that will have bearing and consequence on what is coming before the Conference, she would think it would be incumbent upon the body to have conversations about possible consequences and discussions regarding who would be affected by those actions.

Hunt said they would have to think about the process. He reiterated that the ordination process is a 7 to 10-year process, and they take none of decisions or consequences lightly. Bishop Easterling said that in no way was anything being said to be taken personally. She said she believed the work was done with integrity and the best of intention. There was now a need to act upon the matters during the Annual Conference Session.

The Rev. Theresa Tims, Extension Ministry, Princeton University, questioned how candidates are being rated regarding fitness for ministry besides human sexuality. She asked what the other areas of fitness are. She shared that when she was ordained, no one asked her questions about her genitalia or even her work in the local church. Question to BOOM is how are we now, even as clergy colleagues, ranking candidates. She asked if they were looking at credit scores, financial giving, physical fitness and the fitness for ministry and ranking that as well.

Hunt replied that a full examination is considered to be psychological reports by district committees leading to profiling, reports on credit checks, reports on effectiveness in ministry, recommendations from multiple persons, including people in supervisory and academic chains. The examination includes multiple facets of a person's life.

Tims said she understood that but was interested in the ranking system that was now happening. Hunt responded that all of the things mentioned are important and if areas need more examination, more is done. She then asked if someone would be disqualified for not being physically fit or not having good credit. Homophobia and human sexuality appeared to her to be ranked above all else. She was trying to determine if there were other disqualifying factors.

Bishop Easterling cited Judicial Council Ruling #1344 which states that all matters enumerated in the Book of Disciple that determine one's fitness and effectiveness for ministry are to be examined and held equally.

* * *

The Rev. Curtis Ehrgott, Grace Hagerstown, asked because there is a difference between ordinated and provisional status and in anticipation of changes in 2019, could the body move a person into provisional status in anticipation that things may change next year? Bishop Easterling explained that the Book of Discipline states that individual are not eligible for provisional status or Elders orders if they don't meet the criteria for effectiveness and fitness through character.

The Rev. Meredith Wilson-Arnold, Calvary UMC in Annapolis, who said she transferred her credentials from the Lutheran Church three years ago after being ordained in the Lutheran Church, said the questions about sexuality and marriage were asked before she was ordained. She said that many present sat on DCOM and BOOM while she was transferring and she was never asked about her marriage except in her psychological exam. No one asked about her marriage or her sex life and she was concerned that they were now going to do that to 29 people. She said that if it was going to be done to them, it needed to be done to all of the body in the same public manner.

Bishop Easterling said those who already hold credentials within in the Conference, unless they are provisional and coming for full Elders orders, to be in question a charge would have to be brought against them. She asked the body to restrain from making statements that did not advance the work of the session.

Scott asked for the candidates to be brought in and advised of what was going on. Bishop Easterling said that BOOM will advise them. Another member asked for the definition of "self-avowed, practicing homosexual," and if there is any required proof of the practice? Bishop Easterling cited Judicial Council Decision 1341 as offering guidance on what is proof of a self-avowed practicing homosexual. Scott asked for a copy of the decision and Bishop referred her to the United Methodist website.

The Rev. Doug Hayes, Lexington Park, made a motion to adjourn the clergy session so that BOOM could fully examine the candidates according to the Book of Discipline including the

Judicial Decisions just mentioned. Bishop responded that the chair was about to recess the session and asked for five minutes. She then announced that the session would recess until after opening worship service ended, and that she would not ask the historic questions during the worship service.

Clergy Session

Marriott Waterfront, Baltimore Wednesday, May 30, 2018 | 9 p.m.

Bishop Easterling reminded those assembled that only those persons allowed in Clergy Session were to be there and that the bar had been established so that everyone to the left were persons who could be present but did not have vote.

Bishop asked for the Rev. Scott Shumaker to offer a prayer for the evening's work. Bishop Easterling announced that the Rev. Tony Hunt was going to share the work done with the candidates during the dinner recess.

Hunt reported that members of the Board of Ordained Ministry met with all the candidates. They shared with the candidates that they were trying to find a way to move the process forward. It was also shared with all of the candidates that as a part of full inquiry as it pertains to the Book of Discipline and Judicial Council rulings, inquiries needed to be made in regards to human sexuality. He said that all candidates were given an opportunity to offer information and self-disclosure about any issues not brought up in the profiling and examination particularly as they pertain to human sexuality. No additional information was shared with the Board. Rev. Hunt added that, in the course of profiling, two of the candidates had previously shared in writing that they are married to a person of the same gender.

The Rev. Mark Gorman, Centre, Forest Hill, said in light of Hunt's report, he moved that the two candidates be removed from consideration for this session of the clergy.

Bishop Easterling asked how he was asking the question. He responded that he was asking it as a question of law – "Must this session of the clergy exclude these two candidates on the basis of Dr. Hunt's report and on the basis of the Book of Discipline ¶304.3." Bishop Easterling reminded those present that she typically has 30 days to rule on a question of law, but she was unable to wait 30 days to rule on the information before the session. Easterling continued that the matter that was keeping them from moving forward on the report was "the concern that the Board of Ordained Ministry had not done a full inquiry as some believe the Book of Discipline requires and as some Judicial Council rulings require." The Board met with the candidates for commissioning and Elders' orders and asked for full disclosure on the matters indicated. Two candidates had previously disclosed in writing as part of their profile that they were married to same gendered partners. In light of that fact, in light of decision 1341 by the Judicial Council and several decisions that followed and the Book of Discipline and the Baltimore-Washington Conference Rules, the bishop ruled that the two individuals would not be able to come forward as candidates for commissioning or ordination.

The Rev. Mark Schaefer, University Chaplain, American University, asked if the publication of one's marital status constitutes "self-avowal" or "self-avowal and practice." Bishop Easterling replied that according to Judicial Council Ruling 1341,

"evidence of a marriage license is evidence of being a self-avowed practicing homosexual." She further stated that it was made quite clear in the ruling.

The Rev. Phil Wogoman stated that he recalled reading the decision and it was not quite that absolute. He said, "It indicated it was presumptive but rebuttable." He asked if it had been determined that it was a rebuttable proposal.

Bishop Easterling replied that in 1341, the word "rebuttable" was there. Because the two individuals disclosed their marital status, the bishop said she ruled that they are not eligible for commissioning and ordination at this Annual Conference.

Wogoman responded that he did not think the Judicial Council said that if you are in a same gender marriage that it is not necessarily a self-disclosure. He said that is what is rebuttable. "You have a presumption, but the burden of proof is with you." He continued that it was "preoccupied with physical sex and not looking at the relational realities of marriage."

Bishop Easterling responded that her ruling of law stands.

Gorman moved that, in light of the bishop's ruling, consideration be given to combining some of the questions, specifically the questions on provisional Elders and Deacons, to vote on it now and move the questions ahead.

Bishop said that the motion was to move ahead with all candidates but the two candidates excluded.

Local pastor, Laura Kigweba James, asked that we hold the two people in prayer. The bishop replied that it was appropriate.

Hunt said the people have been under the care of the Board of Ordained Ministry and that there was nothing to preclude them from continuing in some form of candidacy. He asked if at some point the two could be invited in and prayed with at some point with the body to share with them where we are.

The Rev. Kevin Wright, Extension Ministry, said that he was tired of prayer and wanted to see justice. He gave the "gun violence epidemic" as an example. He added that all had taken a vow to do no harm and then do harm and invite them in for prayer. He said that prayer is to appease their conscious and he did not want to be a part of that.

The bishop said that she could appreciate that, but that the prayers of the righteous "availeth much" whether we appreciate it or not. "God is not impotent to act upon our prayers." Bishop Easterling called upon Laura Kigweba James to pray.

Bishop Easterling asked if Hunt agreed to move forward as was moved, and he agreed with reluctance.

The Rev. John Wunderlich, First Saints Community, raised concerns about the lack of clarity regarding the status of candidates who get to this point and do not progress. He asked how communications to candidates could be clearer so that the Board, the candidates, and the body are clear on their status.

Bishop Easterling explained that it was incumbent upon the Board of Ordained Ministry in their report on the vote of the body, to identify to the candidates what status that places them in. She acknowledged that there was debate about whether the candidates should go back to their district committees and be interviewed again or if they can be held by the Board of Ordained Ministry. She said the Board should review the Discipline and decide where candidates reside after the Clergy Session. She reminded everyone that in nine months, the denomination will convene in a special session of General Conference and the law of the church may change.

The bishop stated that there was a motion before the body to vote on the remaining candidates. She then asked a speaker at the microphone if she were rising to a point of order.

She wanted to make a motion; however, the bishop said the motion was out of order because there was a motion on the floor.

The Rev. Katie Bishop asked for clarification on which questions were being voted upon. Hunt clarified that the body was on page 9, Question 28, and that they needed to work through page 12. The motion carried to continue the report from the Board of Ordained Ministry. Hunt directed the body to return to page 9 and asked the Rev. Scott Shumaker, the registrar for provisional members, to come forward.

By a three-fourths vote, Megan B. Blanchard was approved as a Provisional Deacon (Question 28.a). The following were approved as Provisional Elders (Question 28.b.): Sherwyn Benjamin, Scott Bostic, Patrick Hurder Buhrman, Mi Ja Cho, Christopher Dembeck, Sarah Elliott, James Gosnell, Lynne Humphries-Russ, David Jacobson, Kathryn Mackereth, Robert Ruggieri, Anna Schwartz, Emily Smiley, and Matthew Tate. Shumaker offered a prayer for the 2018 class of Provisional Members.

The Rev. Bonnie McCubbin, Good Shepherd, asked for prayer for the Provisional Deacon, Megan B. Blanchard, who was invited back into the room. Shumaker prayed for her.

Question 29.a. Persons continued as Provisional Members were approved. Question 29.b. and c had no one listed. The Rev. Ronald Fleming-Triplett was approved as a Provisional Member transferred from another conference or denomination (Question 29.d).

The Rev. Al Hammer, the registrar for full members, came forward for Question 32, parts a. and b., which listed those elected as members in full connection. The following were elected by vote of more the three-fourths of the body: as Deacon, Leo Yates, Jr.; as Elder: Giovanni Arroyo, Nicholas Bufano, Beth Hutton, Elizabeth LeMaster, Brenda Lewis, James McSavaney, Laura Novell, Katharine Saari, Dawn Steward, Heath Wilson, and, for recognition of orders, Reginald Tarpley. All but Tarpley were listed under Questions 33 and 34 which ask who are ordained as Deacons and Elders. They were approved by a three-fourths vote. When they returned to the stage to the applause of the body, the bishop then asked them the Historic Questions.

* * *

Hunt moved for approval of the report as amended. * * *

The Rev. Dean Snyder, retired, requested an appeal of the bishop's most recent ruling of law because it was based on Judicial Council ruling 1341 which was unconstitutional, he said, because "it was an intrusion by the Judicial Council into the constitutional authority of the General Conference by redefining and adding to the definition made by the General Conference of self-avowed practicing homosexual." He said that the language of his appeal was from an article by William Lawrence, former chair of the Judicial Council, published in the Methodist Review. The article argued that 1341 was unconstitutional because it was not the role of the Judicial Council to change the General Conference's definition of self-avowed practicing homosexual.

Bishop Easterling clarified that he was not saying that the Judicial Council is saying that the Judicial Council ruling is unconstitutional. Snyder said he was asking that her rule of law be reviewed by the Judicial Council because 1341 was unconstitutional. Easterling added that her ruling was also based on the Book of Discipline but said his challenge still stood.

Gorman suggested that the way the appeal was phrased may be out of order because Snyder is appealing the Judicial Council and the Annual Conference does not have that standing. He suggested the appeal be to the bishop's ruling and not include the Judicial Council.

Snyder said that his concern was that a rationale for the appeal be included in communication with the Judicial Council and if there was a better way to do that, he welcomed the suggestion. He was unsure that the appeal without the rationale would be helpful. Bishop Easterling agreed with Gorman and asked Snyder to restate the appeal. Snyder felt his appeal would offer an opportunity for the Judicial Council to reconsider its decision.

Gorman stated that a mechanism exists for such reconsideration, but it is the General Conference and the Council of Bishops and perhaps the Jurisdictional Conference and that he would have to check in the Book of Discipline.

After several exchanges between Gorman and Snyder, the body, at the bishop's request, allowed the Conference Chancellor, Thomas Starnes, to address the appeal under discussion. Starnes explained that no rationale needed to be provided in the appeal. He instructed that the actions he could take was to make a motion to appeal, let the body vote on it and, provide whatever rationale he wanted when the time came. Snyder offered the appeal without the rationale.

The Rev. Alisa Wailoo, Capitol Hill, asked for clarification on what a yes vote and a no vote meant. Bishop Easterling explained that a yes vote would mean support of the appeal of her ruling of law. A no vote would affirm her ruling. The appeal was approved.

The Board of Ordained Ministry report was approved as amended. Bishop Easterling shared the concerns for the treatment of those not moved forward and asked if the Board would review the Book of Discipline and tell the candidates with "specificity" their status moving forward. Hunt will review what has been done and move forward on what was heard from the body.

In response to a request by the Rev. Roberta Scoville, retired, to communicate to clergy and the conference what the Board does and how it cares for those excluded from moving forward based on a "category," Bishop Easterling stated that the Book of Discipline provides that policy. She asked the Board of Ordained Ministry provide information regarding its policy but not individual candidates or their names. By sharing the Board's policy, in the current case and moving forward what happens to any candidate that does not pass clergy session will be understood.

Hunt explained that the Executive Committee considers these matters as it did when it published its policy in March. They discussed what information to include and how detailed they would get. They work with Communications to message in ways they think are helpful including FAQ's and articles. They are guided by in their work by ¶635 of the Discipline.

The Rev. Loretta Johnson, Jones Memorial, asked if the BOOM policy communicated by the Board of Ordained Ministry regarding asking questions on human sexuality at the DCOM level and BOOM level and approving candidates, rendered their memo void based on actions taken at the clergy session. She asked if BOOM will issue a new policy and rescind the current policy. Hunt responded that BOOM will continue to review their policies and will review the aforementioned policy in light of the information they now have. He said that it is a fluid time and much can change. They will be working on policy during the summer.

Wailoo asked for a pastoral word on what to say about the outcome of the session to the people of their congregations, many of whom will be "broken hearted." Bishop Easterling said, "I would say that we are imperfect people dealing with an imperfect Book of Discipline guiding us through uncertain times. That we've done the best work we can do with integrity and fidelity to the Book of Discipline and the rule of law of the Church as it stands right now. It doesn't mean that everybody who voted agrees with the Book of Discipline and yet we are bound to uphold the Book of Discipline." The bishop asked that everyone remain in prayer for the work that will be undertaken in February 2019 in St. Louis, Missouri. She spoke on the value of prayer as a means by which we "call upon almighty God to guide us and lead us into all truth."

Bishop Easterling thanked the Board of Ordained Ministry for their work and Dr. Hunt for his leadership on the Board of Ordained Ministry. She reminded the session that we don't have to always agree but that we can disagree with love and respect for each other as "beloved children of God."

* * *

The Bishop asked that all stand and sing "Bless Be the Ties that Bind." The long evening session closed with the delivery of a closing prayer by the bishop.
