### **Appeal Summary**

Mr. Seise appeals the recommendation and actions of the appellees leading to his involuntary leave of absence and discontinuance as a Provisional Member of the Florida Conference of the United Methodist Church.

### Findings of the Southeastern Jurisdiction Committee on Appeals

After careful review of the appeal filed by Mr. Seise, the records of the administrative process and the written arguments of the parties this committee by maJority vote finds the following:

- 1. The appeal is properly before the committee and Jurisdiction is valid.
- 2. ¶ 2718.4.g of the 2016 Book of Discipline asserts: The appellate body shall determine one question only: Were there such errors of Church law as to vitiate the recommendation and/or action of the administrative body?
- 3. There were no errors of Church Law as to vitiate the recommendation and/or action of the administrative bodies named as appellees.
