The Revised Family Rights and Privacy Act became a Federal law in November of 1974. The intent of this law is to protect the accuracy and privacy of student educational records. Without your prior consent, only you and authorized individuals having legitimate educational interests will have access to your child's educational records.

You may have an appointment to inspect and review your child's records. The appointment may be made in person, or by telephoning your local school district at the number listed above. Records of students in Intermediate Unit programs are located at the Chester County Intermediate Unit. Upon review of the records, if you have reason to believe that any information contained therein is inaccurate, misleading or inappropriate, you have the right to challenge that information. If there is agreement, the necessary steps to amend or correct the information contained in the record will be taken. If agreement is not reached, a hearing will be scheduled. The hearing will provide you with the opportunity to present your views and reasons for the challenge. You may bring with you, at your expense, any individual who may be of assistance. Following the hearing, should there be a failure to reach an agreement, you have the right to appeal the decision to the appropriate area superintendent. In the event that your appeal falls at any level of the hearing procedure, you have the right to have entered into the record a statement of the issue as you see it.

The rights pertaining to access and challenge described herein are transferred to your child upon the attainment of his/her eighteenth birthday or admission to an institution of post secondary education.

Directory information, which includes name, address, telephone listing, date and place of birth, dates of attendance, major field of study, participation in officially recognized activities and sports, weight and height, if a member of an athletic team, degrees and awards received, and most recent previous educational agency or institution attended, may be released unless you make a request in writing to the contrary. This information will be released only in accordance with the guidelines established by your local school district and/or the Chester County Intermediate Unit.

You have the right to obtain a copy of the official policy of your local school district and/or the Chester County Intermediate Unit at the addresses listed above. La Ley estatal enmendada sobre La Privacidad y Los Derechos Familiares se convirtió en ley federal en noviembre del 1974. La ley protege la precision y privacidad de los expedientes academicos del estudiante. Sin su consentimiento previo, solamente ustedes y las autoridades pertinentes tendran acceso a dichos expedientes.

Ustedes pueden solicitar una entrevista para inspeccionar y revisar los expedientes de sus hijos, llamando a la escuela o el telefono del distrito escolar mencionado arriba. Los expedientes de los estudiantes de los Programas que existen en la Unidad Intermedia estan localizados en la unidad intermedia del Condado de Chester. Asi mismo tienen el derecho de pedir revision de cualquier informacion que aparezca en el expediente de sus hijos si la consideran incorrecta o inapropiada y, de llegar a un acuerdo, se tomaran las medidas necesarias para rectificarlo. En caso contrario se les concedera una audiencia en la cual usted puede exponer sus razones. Puede traer a otra persona, por su cuenta, que lo puede asistir. En ultima instancia podra apelar la decision al superintendente de su area.

Todo los derechos aqui descritos seran transferidos a sus hijos al cumplir estos los dieciocho años de edad o al ser admitidos en una institucion educacional para adultos.

A menos que ustedes soliciten lo contrario por escrito, nosotros podemos remitir sin su consentimiento la siguiente informacion contenida en el expediente de sus hijos; nombre, direccion, numero de telefono, fecha y lugar de nacimiento, fecha de asistencia a la escuela, estudios realizados, participacion en actividades y deportes escolares, si es miembro de algun equipo atletico, peso y estatura, certificados, diplomas y trofeos recibidos, y los informes de la ultima institucion educacional donde curso estudios. Esta informacion puede ser remitida solamente de acuerdo con las reglas establecidas por los distritos escolares o la unidad intermedia del Condado de Chester.

Usted tiene el derecho de archivar una queja en la oficina de la Privacidad y Los Derechos Familiares, Departamento de Salud, Educacion y Bienestar Social, Washington, D.C. 20201, si usted piensa que esta escuela o sistema escolar no esta cumpliendo con la ley. Usted tiene el derecho a obtener una copia de la reglas de su distrito escolar o de la Unidad Intermedia en las direcciones mencionadas arriba.
