

OFFICIAL SWEEPSTAKES RULES: NO PURCHASE OR DONATION IS NECESSARY TO ENTER OR WIN. A PURCHASE OR PAYMENT WILL NOT IMPROVE YOUR CHANCES OF WINNING. THIS SWEEPSTAKES IS GOVERNED BY THESE RULES AND IS SUBJECT TO ALL APPLICABLE FEDERAL, STATE AND LOCAL LAWS. VOID WHERE OTHERWISE PROHIBITED OR RESTRICTED BY LAW. ENTRY INTO THE SWEEPSTAKES CONSTITUTES YOUR ACCEPTANCE OF THE RULES. ALL AMOUNTS ARE IN U.S. DOLLARS.

1. Sweepstakes Sponsor, Period & Prize. This Sweepstakes, sponsored by Red Frog Events LLC (“Sponsor”), begins on December 3, 2017 and runs until 11:59 pm (Central Time) on March 2, 2018 (“Sweepstakes Period”). Selected entrants (“Winners”) will receive the following prize packages (collectively, “Prize”) and only the Prizes specified below will be awarded. One (1) Grand Prize Winner shall receive a trip for two (2) to a 2018 participating air show* (“Event”) of their choice, including:

- Two (2) round-trip economy flights (not to exceed \$400 per flight)
 - Two (2) night stay at a hotel (one hotel room not to exceed \$200)
 - Two (2) tickets in the VIP Hospitality space at the selected Event
 - Food and entertainment per diem (\$300 total)
 - Grunt Style gift card (\$150)
- *Participating Events are the Sun ‘N Fun International Fly-In Expo (Lakeland, FL); Bethpage Air Show at Jones Beach (Wantagh, NY); Cleveland National Air Show (Cleveland, OH); and CAF Wings Over Houston Airshow (Houston, TX)

Three (3) Runner-Up Winners shall receive a Grunt Style gift card. Approximate retail value of the Grand Prize is \$1,500 and the Runner-Up Prize is \$150. The Grand Prize does not include transportation to or from the winner’s home, hotel or airport, travel or health insurance or any expenses other than as described above. The Prizes are non-transferable with no cash redemption or equivalent. Winners are responsible for paying all federal, state or local taxes and any other fees connected to the Prize. Sponsor-designated judges will randomly select the Winners from all eligible entries the day after the Sweepstakes Period ends. Odds of winning depend on the nature, quality and number of eligible entries received. Decisions of judges are final and cannot be appealed.

2. Eligibility. The Sweepstakes is open only to legal residents of the United States (including the District of Columbia) who are physically located in the United States at the time of entry and who are eighteen (18) years of age and older on the date they enter the Sweepstakes. The following are not eligible to enter the Sweepstakes: (a) owners, employees or agents of Sponsor; or (b) immediate family members of the individuals identified in (a). “Immediate Family Member” is defined as a spouse, parents, in-laws, siblings, children, grandchildren of the employee and his/her spouse (including “step” relationships), individuals for whom an employee is the current legal guardian or individuals who are not legally related to but who reside with the employee.

3. How to Enter. To enter the Contest, you must complete the contact form/entry at the Air Show Majors website (<http://airshowmajors.com/>), including (without limitation) providing your name and email address. **All entries must be received by 11:59 PM Central Time on the last day of the Sweepstakes Period.** Limit one (1) entry per person throughout the Sweepstakes Period. Additional entries by the same person will be disregarded. Entries will be deemed submitted by the authorized account holder of the email address submitted at the time of entry. “Authorized account holder” is defined as the natural person who is assigned to an email address by an Internet access provider, online service provider or organization (e.g., business, educational institution, etc.) that is responsible for assigning email addresses for the domain associated with the submitted email address. Upon receipt, all submissions shall be licensed to Sponsor and will not be acknowledged or returned.

4. Winner Notification. The selected potential winners will be notified by mail, phone and/or e-mail, at Sponsor’s discretion, using the information provided by each entrant. Sponsor shall have no liability for any winner notification that is lost, intercepted or not received by the potential winner for any reason. In Sponsor’s sole discretion, selected potential winners may be disqualified and required to forfeit the prize, and alternate potential winners may be selected in accordance with the Rules from among the remaining eligible entrants if the selected potential winner(s): (a) cannot be reached for whatever reason after a reasonable effort has been exerted based on the information provided by the potential winner or winner notification is returned as undeliverable; (b) declines or cannot accept, receive or use the Prize for any reason; (c) is found to be ineligible to enter the Sweepstakes or receive the Prize; or (d) cannot or does not comply with the Rules. Sponsor is not obligated to leave voice mail or other messages on any answering machine or service.

5. Claiming Prize. A properly claimed Prize will be awarded. As a condition of winning the Prize, the Winner(s) may be required to complete, sign and return an Affidavit of Eligibility and Release, where permitted by law, and any other applicable forms required by a taxing authority, within ten (10) days of receipt of written prize notification or the Prize will be forfeited and an alternate winner selected. 7. No Tampering; Right To Cancel; Modify. Sponsor shall have no obligation or responsibility, including any responsibility to award any prize to entrants, with regard to: (a) entries that contain inaccurate information or do not comply with or violate the Rules; (b) entries, prize claims or notifications that are lost, late, incomplete, illegible, damaged or otherwise not received by the intended recipient, in whole or in part, due to computer, human or technical error of any kind; (c) entrants who have committed fraud or deception in entering or participating in the Sweepstakes or claiming the prize; (d) telephone, electronic, hardware, software, network, Internet or computer malfunctions, failures or difficulties; (e) any inability of the winner to accept the prize for any reason; (f) if a prize cannot be awarded due to delays or interruptions due to Acts of God or events beyond Sponsor’s reasonable control; or (g) any damages, injuries or losses of any kind caused by any prize or resulting from awarding, accepting, possessing, using, misusing, losing or misdirecting any prize or resulting from participating in the Sweepstakes or any promotion or prize related activities. Sponsor reserves the right, in its sole discretion, to disqualify any individual it finds to be in violation of the Rules.

8. Limitation of Liability. By participating in the Sweepstakes, entrants agree to release, hold harmless and not to institute any claim against Sponsor and its owners, managers, members, affiliates, past or present employees, agents and representatives (collectively, “Released Parties”) from any and all liability whatsoever for any injuries, losses or damages of any kind arising from or in connection with, either directly or indirectly, (a) the award, acceptance, receipt, possession, use and/or misuse of the Prize, (b) participation in the Sweepstakes or any prize-related activities, including, but not limited to, traveling to or from the Event. Upon delivery of the Prize to Winners, the Winners shall assume full responsibility for the Prize. Released Parties are not responsible for technical, hardware, software, telephone or other communications malfunctions, errors or failures of any kind, lost or unavailable network connections, website, Internet or ISP availability, unauthorized human intervention, traffic congestion, incomplete or inaccurate capture of entry information (regardless of cause) or failed, incomplete or delayed computer transmissions that may limit one’s ability to enter the Sweepstakes, including any injury or damage to your or any other person’s computer relating to the Sweepstakes or downloading materials in connection with the Sweepstakes. Winners and entrants acknowledge that Sponsor has neither made nor is in any manner responsible or liable for any warranty, representation or guaranty, express or implied, in fact or in law, relative to any prize or any component thereof, including, but not limited to, express warranties provided by the supplier of the Prize (or any component thereof) or their affiliates.

9. Choice of Law and Venue. All issues and questions concerning the construction, validity, interpretation and enforceability of the Rules, or the rights and obligations of entrants and Sponsor in connection with the Sweepstakes, shall be governed by the laws of the State of Illinois, without regard to conflict of law principles. Any action or proceeding arising out of or related to the Sweepstakes shall only be brought in state or federal courts located in Chicago, Illinois. Entrants hereby irrevocably consent to the personal jurisdiction of said courts and waive any claim of forum *non conveniens* or lack of personal jurisdiction they may have.

10. Miscellaneous. If for any reason the Sweepstakes is not capable of running as planned, including infection by computer virus, tampering, technical failures or any other causes beyond Sponsor’s control, Sponsor reserves the right, at its sole discretion, to cancel, terminate, modify or suspend the Sweepstakes and select a Winner from among all eligible entries prior to the cancellation. Persons found tampering with or abusing any aspect of the Sweepstakes, or whom Sponsor believes to be causing malfunction, error, disruption or damage will be disqualified. Sponsor reserves the right to correct any typographical, printing, computer programming or operator errors.
