Whereas academic excellence in this technological age requires a certain level of Information Technology (IT) skills and knowledge; and

- Whereas historically there has been a gap between the necessity for a variety of IT skills and the funding made available;

  The Faculty Senate resolves that SCSU adopt and provide appropriate resources for
- implementation and evaluation of the following essential IT competencies for its students:
- Demonstrate the ability to navigate and manage files by utilizing basic computer operating systems.
   Create effective documents, e.g., term papers, professional papers, creative writing samples, by utilizing word processing software.
  - 3) Demonstrate the ability to develop an effective presentation by utilizing presentation software packages.
  - 4) Use technology to communicate and collaborate effectively with other people, e.g. e-mail.
    5) Demonstrate the ability to manage, organize, and analyze information effectively
  - 5) Demonstrate the ability to manage, organize, and analyze information effective by utilizing spreadsheet software.6) Demonstrate an understanding of internet browser capabilities by accessing
  - information from the World Wide Web.

We are in agreement concerning the importance of IT competencies and the need to address them. The resolution, however, would mandate that "appropriate resources" be committed to insure IT competencies without a full understanding of just what those resources would amount to. This matter needs further study and explication. Further, because the proposed resolution appears to concern curricular matters, I recommend that the issue it addresses be referred to the UCF.
