Dear Sir/Madam

From 1 November 2011, the *Anti-Money Laundering and Counter-Terrorism Financing Act 2006* will impose a new enrolment obligation on all reporting entities.

As a result, you will need to enrol with AUSTRAC between 1 and 28 November 2011.

Your enrolment information will provide AUSTRAC with a more accurate understanding of its regulated population.

If you have previously voluntarily enrolled with AUSTRAC, you will still need to enrol during this period.


