Kennel/Boarding Policy:

1. All pets coming in to board are required to be up to date on all necessary vaccines, fecal/heartworm checks, and flea/heartworm preventatives. In order to protect your pet as well as other pets in the kennel and hospital, your pet must be flea and tick free. If fleas are found upon check-in, we will administer a one-time oral flea killer (Capstar) and ticks will be removed, all at the owner's expense. These parasite control methods are not included in the standard price of daily boarding.
2. Pets may be picked up between 8am-4:30pm on Monday, Tuesday, and Thursday, between 9am-4:30pm on Friday, and between 8am-11:30am on Wednesday and Saturday. Personal items are left at your own risk. Animals of Eden Veterinary Hospital is not responsible for loss or damage.
3. Animals of Eden Veterinary Hospital cannot guarantee the health of any pet, but pledges to give the utmost loving care to all of our boarders. I agree to hold Animals of Eden Veterinary Hospital harmless for conditions that may result from boarding including but not limited to: weight loss or gain, stiffness, vomiting, or diarrhea.
4. I agree to pay in full when I pick up my pet. I accept that if I fail to pick up my pet within 10 days of the checkout date, it will be considered abandoned and will be handled in accordance with state law, and doing so does not relieve me of my financial obligations.
