

## Boarding Agreement

**This is an agreement between Rocky Hill Animal Hospital and the pet owner whose signature appears below (hereinafter called "Owner").**

1. Owner agrees to pay the rate for pet care provided in effect on the date pet is checked into Rocky Hill Animal Hospital.
2. Owner further agrees to pay all costs and charges for special services requested, and all veterinary costs for the pet during the period said pet is in the care of Rocky Hill Animal Hospital.
3. Owner further agrees that the pet shall not leave the facility until Owner pays all charges due or both parties agree upon proper payment arrangements.
4. By signing this Agreement and leaving pet with Rocky Hill Animal Hospital, Owner certifies to the accuracy of all information given about said pet. Owner has also reviewed "Pet Questionnaire". Rocky Hill Animal Hospital gives the right to deny admittance to Owner's pet for any reason at any time.

5. Owner specifically represent that he or she is the sole owner of the pet, free and clear of all liens and encumbrances.
6. Owner specifically represents to Rocky Hill Animal Hospital that, to Owner's knowledge, the pet has not been exposed to any contagious diseases within a thirty-day period prior to check-in. During the period of this agreement, Owner also agrees to notify Rocky Hill Animal Hospital of any known exposure of pet to a communicable disease and hold pet out of attending Rocky Hill Animal Hospital until pet has written veterinary clearance. Owner further agrees to maintain currency of vaccinations as required by Rocky Hill Animal Hospital policy.
7. All charges incurred by Owner shall be payable upon pick-up of pet. Rocky Hill Animal Hospital shall have, and is hereby granted, a lien on the pet for any and all unpaid charges resulting from services provided by Rocky Hill Animal Hospital. Those with this contract, Rocky Hill Animal Hospital may exercise it lien rights upon ten days written notice given by Rocky Hill Animal Hospital to Owner by certified mail to address shown on contract. Rocky Hill Animal Hospital may dispose of pet for any and all unpaid charges, at private or public sale, in the sole discretion of Rocky Hill Animal Hospital, and Owner specifically waives all statutory or legal rights to the contrary. If such sale shall not secure a price adequate to pay such costs of pet care or other charges delinquent, plus costs of sale, then Owner shall be liable to Rocky Hill Animal Hospital or the differences. All monies realized by Rocky Hill Animal Hospital at such sale, over and above the charges due and costs of sale, shall be paid to Owner.
8. If pet becomes ill or injured, or if the state of the animal's health otherwise requires professional attention. Rocky Hill Animal Hospital in its sole discretion may engage the services of a veterinarian or administer medicine or give other requisite attention to the animal, and the Owner thereof shall pay the expenses.
9. Pet care provider will kennel pet in kennel and/or crate pet care provider's discretion.
10. This Agreement contains the entire agreement between the parties. All terms and conditions of this Agreement shall be binding on the heirs, administrators, personal representatives and assigns of the Owner and Rocky Hill Animal Hospital.

Arbitrator may be entered in any Court having jurisdiction thereof. The arbitrator shall, as part of the award, determine an award to the prevailing party of the costs of such arbitration and reasonable attorney's fees of the prevailing party.
