When travelling with your pet(s), there may be animal health requirements specific for that destination. As soon as you know your travel details, contact your local veterinarian to assist with the pet travel process. Factors to consider may include meeting time frames for obtaining a health certificate, updating vaccinations, diagnostic testing, or administration of medications/ treatments.

## Take your pet *from* the United States to a foreign country (Export)

Your destination country may have specific health requirements that must be met before your pet can enter the country. Since export requirements are determined by each country and can change frequently, every time you plan pet travel you will need to verify the export requirements. ### STEPS TO FOLLOW:

1. TO FIND THE REQUIREMENTS FOR TRAVELING WITH A PET, PLEASE USE THE FOLLOWING LINK:

2. THIS LINK WILL DIRECT YOU TO THE APPROPRIATE WEB PAGE, IN WHICH YOU CAN FIND THE EXACT REQUIREMENTS FOR MOST DESTINATION COUNTRIES AND DIFFERENT TYPES OF PETS. CLICK THE DROP-DOWN MENU TO SELECT THE CLIENT'S COUNTRY OF CHOICE, INDICATED BY THE TAB "— **SELECT COUNTRY** —". FOLLOWING THE SELECTION, CLICK ON THE "**VIEW REQUIREMENTS**" TAB IN ORDER TO BE RE-DIRECTED TO THE NEXT WEBPAGE WHERE YOU CAN FIND THE MOST CURRENT INFORMATION AVAILABLE FOR THAT PARTICULAR COUNTRY. THERE IS ALSO INSTRUCTIONS ON WHAT TO DO IF THE DESTINATION COUNTRY IS NOT LISTED.
3. THE NEXT WEBPAGE WILL HAVE A TAB AVAILABLE FOR YOU TO SELECT THE TYPE OF PET THE CLIENT INTENDS TO TRAVEL WITH TO THE DESTINATION COUNTRY. THE DROP DOWN MENU FOR THE SELECTED TYPE OF PET, WHETHER IT A BE A DOG, CAT OR OTHER SPECIES LISTED, WILL INCLUDE COUNTRY SPECIFIC HEALTH CERTIFICATES AND OTHER INSTRUCTIONS.
