

## **ABSTRAK**

Pembangunan desa harus dilakukan sesuai rencana, dan masyarakat serta pemerintah harus memahami dan memantau prosesnya. Dengan dana desa, pemerintah harus menggunakannya dengan baik dan akuntabel. Sehingga saya mengangkat judul penelitian “Peranan Hukum Tentang Pengelolaan Dana Desa Dalam Meningkatkan Infrastruktur Di Desa Sigata Kecamatan Pulau - Pulau Batu Barat” untuk mengetahui peranan hukum dalam menangani pengelolaan dana desa untuk meningkatkan infrastruktur, pengelolaan dana didesa sigata kecamatan pulau-pulau batu barat yang dilakukan oleh kepala desa serta pandangan masyarakat di desa sigata mengenai pengelolaan dana desa dalam meningkatkan infrastruktur. Dalam penelitian ini lokasi yang dijadikan sebagai tempat penelitian adalah Desa Sigata, Kecamatan Pulau - Pulau Batu Barat, Kabupaten Nias Selatan, Provinsi Sumatera Utara. Adapun jenis penelitian adalah yuridis normative dan deskriptif kuantitatif. Teknik pengumpulan data melalui studi kepustakaan serta studi lapangan. Analisis data diperoleh dengan proses wawancara terbuka dengan kepala desa, masyarakat desa sigata kecamatan pulau - pulau batu barat. Perlindungan hukum terhadap pengelolaan dana desa dituangkan dalam Undang-Undang Nomor 6 Tahun 2014. Pengelolaan dana yang dilakukan kepala desa dikelola dengan efektif. Pandangan masyarakat terhadap pengelolaan dana yang dilakukan oleh kepala desa dinilai menguntungkan dalam kehidupan sehari-hari.

## **ABSTRACT**

*The construction of the village must be done as planned, and the public and government must understand and monitor the process. With the village funds, the government must use them well and accountably. So I raised the title of the research "Role of Law on the Management of the Village Fund In Improving Infrastructure in the Village of Sigata Island-Stone Island West" to know the role of law in dealing with the management of the village funds to improve infrastructure, management of funds sigata district of the islands of the western stone islands carried out by the village head as well as the view of the public in the village of sigata about management of villages funds in improving infrastructure. In this research, the location used as the place of research is the village of Sigata, the island district - the western stone island, the southern Nias district, the northern Sumatera province. The types of research are juridic normative and descriptive quantitative. Data collection techniques through library studies and field studies. Data analysis was obtained through the process of open interviews with the head of the village, the community of the villages of the island - the island of the western rock. The legal protection against the management of village funds is laid down in the Nomor Act 6 of 2014. The management of the funds by the head of the village is managed effectively. The public view of the management of funds carried out by the head of the village is assessed as beneficial in everyday life.*
