

AN ORDINANCE TO PROVIDE FOR THE REDISTRICTING OF BARNWELL COUNTY COUNCIL SEATS UTILIZING POPULATION DATA FROM THE 2010 FEDERAL CENSUS IN ACCORDANCE WITH THE SOUTH CAROLINA CODE OF LAWS, 1976 AS AMENDED.

Whereas Section 4-9-90 of the South Carolina Code of Laws, 1976 as amended, requires South Carolina counties (in which council members are elected from defined single-member election districts) to reapportion the boundaries of such districts subsequent to adoption by the State of each federal decennial census; and

Whereas The State has accepted the 2010 Federal Census data, and

Whereas Barnwell County Council has employed the services of the Office of Research and Statistics, a division of the South Carolina Budget and Control Board, to ensure the equitable redistricting of Barnwell County's seven single-member districts; and

Whereas Barnwell County has been provided with statistical data and maps for the seven single member districts to assist it in complying with the 1965 U.S. Voting Rights Act. (See attached – Map Entitled Barnwell County Council: Plan 2).

NOW THEREFORE BE IT ORDAINED:

1. The statistical data and the maps provided by the South Carolina Budget and Control Board pertaining to the County Council districts will be retained by the Clerk to the Barnwell County Council and the County Administrator.
2. A copy of the final map (Plan 2) delineating the geographical boundaries of the County Council Districts as redrawn for this ordinance is attached hereto and made a part of this ordinance, with detailed census information pertaining to such districts residing in the custody of the South Carolina Budget and Control Board.
3. The map attached and incorporated by reference into this ordinance is hereby adopted upon a majority vote of council as the Redistricting Map of Barnwell County.



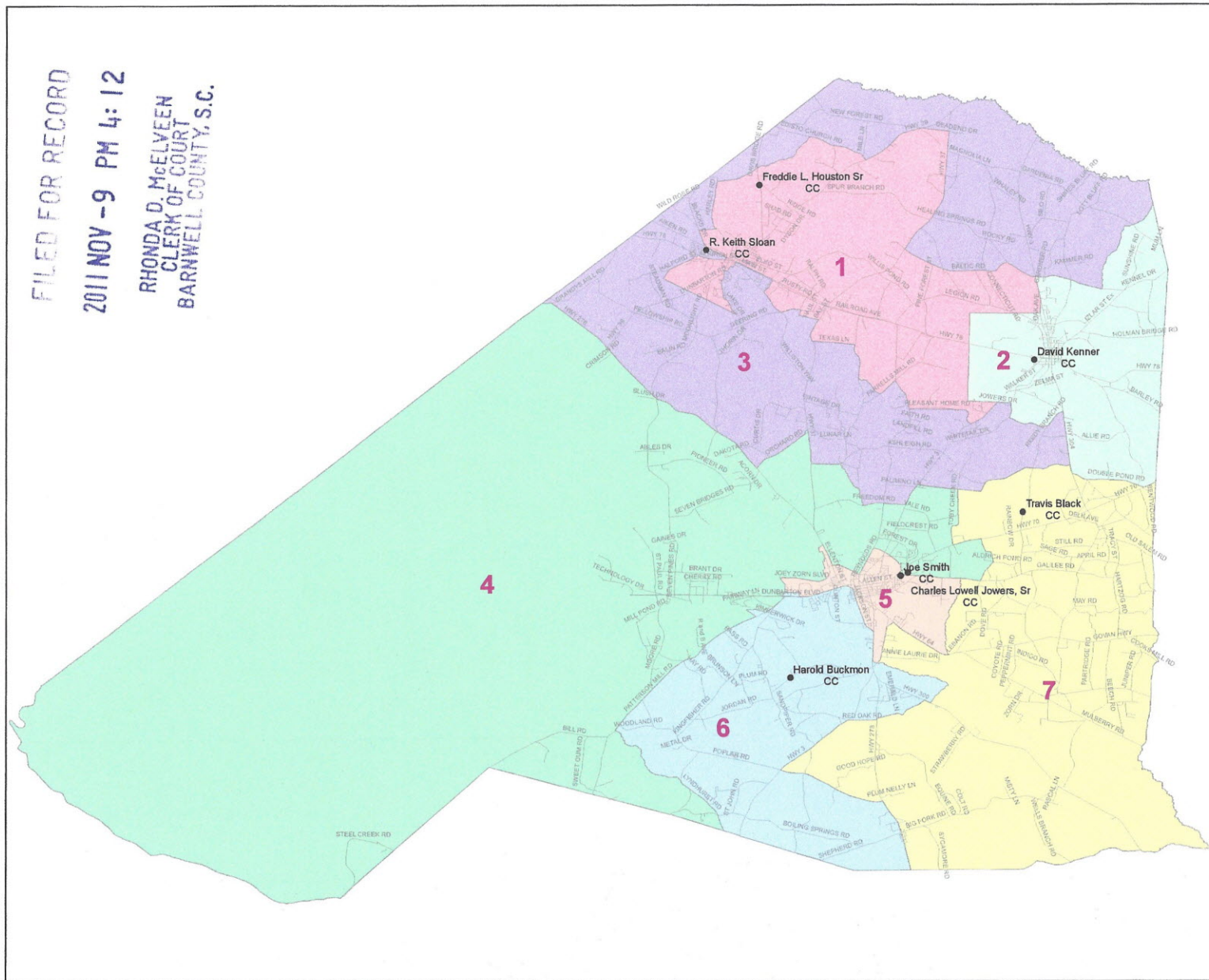
