

Service Contract

ULTRA PARTY BUS DETROIT will be providing a luxury Party Bus with a Commercially licensed driver to escort you on your party adventure. Our goal is to prevent people from drunk driving and let everyone know there are safe and entertaining alternatives. To ensure that everyone will have a great time and a safe trip, we would like every guest to abide by our safety rules listed below.

1. All GUESTS ON AN ULTRA PARTY BUS MUST BE 21 OR OLDER TO DRINK ALCOHOLIC BEVERAGES OF ANY KIND.

VIOLATION WILL RESULT IN EARLY TERMINATION OF SERVICE-NO REFUNDS.

2. No drugs, no violence, no obscenity, no weapons of any kind will be tolerated. If any of the above occurs you will be immediately dropped off at your prearranged destination and will not be refunded any amount.

3. For your safety, Please DO NOT under any circumstance distract the driver.

4. Enter at your own risk. **ULTRA PARTY BUS DETROIT** will not be held responsible / liable if any guest gets injured from various causes. For instance, if the bus is in motion and all guests are not seated, or if you are under the influence of any substance.

5. Keep all personal items with you at all times; **ULTRA PARTY BUS DETROIT** is not responsible for lost, damaged, or stolen items. Do not leave anything of value on the bus; we are not responsible for any discarded items left on the bus. If any property of the **ULTRA PARTY BUS** is damaged or stolen during rental by guests of your party, signor will be held liable. Signor is responsible for any and all replacement costs, collection fees, legal fees, or any other court costs.

6. We will not pick up additional people (strangers) through the night. This is for your safety.

7. *****ABSOLUTELY NO SMOKING ON THE BUS!!!**

8. Please note that your party begins when the driver arrives for the initial pick-up and ends when the last person is dropped off. No exceptions!

9. If your party goes over the prearranged time you will be held responsible for the additional hours charged. **Additional charges will be \$50 per 15 minutes NO EXCEPTIONS!**

10. At no time will we allow anyone to be hanging out the windows or throwing trash out the windows.

11. To prevent injury please limit the number of people standing while the bus is in motion!

12. If the music stops & the DRIVER announces for everyone to be seated, please do so promptly!

13. There will be NO glass cups allowed on the bus.

14. Pictures and \ or videos taken by ULTRA PARTY BUS DETROIT STAFF may be used in advertising, flyers, T.V., web site etc. By signing below you are giving permission for **ULTRA PARTY BUS DETROIT** to use pictures and \ or videos of your party and guests for the above purposes. Some exceptions apply.

15. All carry-on bags are subject to search by ULTRA PARTY BUS DETROIT staff.

16. **DAMAGE CLAUSE****** Signor is liable for any and all damage inflicted on the bus during the period of rental. • VOMIT CHARGE - There will be a **\$150** charge per incident. No exceptions. • If bus is damaged beyond normal, excessive litter, food, or spillage a cleaning fee of **\$100** will be assessed. Basically, treat the bus with respect. • Any equipment damaged during rental will be charged to signor for cost of replacement value.

17. Please understand that every effort will be made to provide you with the vehicle of your choice, however, due to extreme circumstances, it may be necessary to use a substitute vehicle. We reserve the right to make any changes we may deem necessary. In the event of a breakdown during a rental, ULTRA PARTY BUS DETROIT is not liable to provide a refund. ULTRA PARTY BUS.DETROIT reserves the right to subcontract any limousine service booked and confirmed with ULTRA PARTY BUS.DETROIT to our affiliate limousine companies should the need arise. We also reserve the right to supply the credit card information, as well as information submitted on our reservation form, with said affiliate limo companies to cover the cost of limo service.

18. In the event that it may become necessary, ULTRA PARTY BUS. DETROIT reserves the right to charge for any collections and/or attorney's fees associated with any and all collection actions for

unpaid balances, damages or charge-backs. *****CLUB ENTRY POLICY***** Free club entry is not guaranteed. This is a courtesy we offer our customers, and you are not charged for this service. If for any reason you are denied entry to any club, **ULTRA PARTY BUS DETROIT** is not liable. •DEPOSITS - All Rentals Require a \$100 Security Deposit. Deposit is held on your credit/debit card unless paid in cash as security, and will be deducted from your rental balance!. •BUS CANCELLATION - **Deposits are NON-REFUNDABLE!!** Some circumstances may warrant a refund, However they are solely at the discretion of **ULTRA PARTY BUS DETROIT**. •**All rentals must be paid in full before boarding the bus** if paying with a Credit Card you are subject to a 3% service charge. *****Note.** To guarantee your reservation you must pay the deposit, sign and return contract and itinerary.
