STUDENT TEACHING AGREEMENT
TRUSTEES OF THE CALIFORNIA STATE UNIVERSITY
SAN DIEGO STATE UNIVERSITY AND
DEL MAR UNION SCHOOL DISTRICT

Original Agreement No.40046243, dated July 1, 2006, is hereby amended to add the following:

On Page 2, paragraphs one and two, ADD the following units and increase total payment:

The SERVICES to be provided by District to State shall include an additional 4 Semester Units of Practice Teaching or --- Quarter Units of Practice Teaching, which will increase the Agreement by the amount of \$100.00.

The University shall pay District for such services at the RATE AND AMOUNT of \$16.67 per quarter unit, and \$25.00 per semester unit, not to exceed a total payment of \$ 500.00.

All other terms and conditions of the original Agreement shall remain the same.
