Building 8000-12000 square feet of modular space on the grounds of Torrey Hills would reduce green space available to the students, an unacceptable limitation given that Torrey Hills is already the 3rd largest school in the district with more than 640 students, and is anticipated to grow to more than 800 students in the next few years. The addition of District Offices to the Torrey Hills site would increase traffic in the area, and reduce available parking.
