The Board of Trustees is authorized each year by resolution, to determine the specific Special Tax rates and amounts to be levied for the next fiscal year. Pursuant to the Rate and Method of Apportionment each July 1 the previous year's one time special tax may be increased by using the Lee Saylor/Marshall Swift Index or 2% whichever is greater.

Attachment "A" to Resolution No. CFD 95-69 lists the tax per square foot. The rate for fiscal year 2010-11 is \$1.42.

**FISCAL IMPACT:** Approval of this resolution will establish the tax rates for fiscal year 2010-2011.

**RECOMMENDED:** The Superintendent recommends the Board approve Resolution No. CFD 95-69.

**RESOLUTION OF THE BOARD OF TRUSTEES OF THE DEL MAR UNION SCHOOL DISTRICT, ACTING AS THE LEGISLATIVE BODY OF THE COMMUNITY FACILITIES DISTRICT NO. 95-1 DETERMINING ADJUSTMENTS IN SPECIAL TAX RATES FOR SUCH COMMUNITY FACILITIES DISTRICT FOR FISCAL YEAR 2010-2011**

WHEREAS, the Del Mar Union School District ("School District") has previously formed Community Facilities District No. 95-1 of the Del Mar Union School District ("CFD No 95-1") pursuant to the provisions of the Mello-Roos Community Facilities Act of 1982, as amended ("Act"); and

WHEREAS, on behalf of CFD No. 95-1, a Rate and Method of Apportionment of Special Tax ("Rate and Method") was adopted and has been approved for CFD No. 95-1; and

WHEREAS, pursuant to the Rate and Method, the Maximum Annual Special Taxes for Undeveloped Property, the One-Time Special Tax, the One-Time Supplemental Prepayment Special Tax and the maximum Annual Special Tax and One-Time Supplemental Prepayment Special Tax are to be annually adjusted by applying the specified index for the appropriate fiscal year or 2.0%, whichever is greater; and

WHEREAS, the School District has been provided with information from its special tax consultant relative to the adjustment in the aforementioned tax rates of CFD No. 95-1 for fiscal year 2010-2011; and

WHEREAS, the Board desires to determine the adjustments to the Maximum Annual Special Tax for Undeveloped Property, the One-Time Special Tax, the One-Time Supplemental Prepayment Special Tax and Maximum Annual Special Tax without One-Time Supplemental Prepayment Special Tax for CFD No. 95-1 for fiscal year 2010-2011 as required by the Rate and Method.

NOW, THEREFORE, THE BOARD OF TRUSTEES OF THE DEL MAR UNION SCHOOL DISTRICT, ACTING AS THE LEGISLATIVE BODY OF COMMUNITY FACILITIES DISTRICT NO. 95-1, DOES HEREBY RESOLVE, DETERMINE AND ORDER AS FOLLOWS:

**Section 1.** The adjustment to the Rate and Method of CFD 95-1, as set forth in Attachment "A", attached hereto and incorporated herein by this reference, and are hereby determined to be correct and are hereby adopted for CFD No. 95-1 for fiscal year 2010-2011.

**Section 2.** The adjustment specified in this Resolution shall be effective as of July 1, 2010.

**Section 3.** School District staff and consultants are hereby directed and authorized to take all necessary and appropriate actions to carry out the directives of this Resolution and provide such information to interested parties in regard to the Rate and Method.

Resolution No. CFD 95-70 sets forth the proposed 2010-2011 Budget for CFD 95-1 and directs the levy of the Special Taxes for all non-exempt property within its boundaries. The proposed budget and special tax amounts to be levied are attached.

**FISCAL IMPACT:** Approval of this resolution will authorize collection of taxes within the boundaries of CFD 95-1 in order to meet anticipated expenditures for the fiscal year.

**RECOMMENDED:** The Superintendent recommends the Board approve Resolution No. CFD 95-70.

**RESOLUTION NO. CFD 95-70**

**RESOLUTION OF THE BOARD OF TRUSTEES OF THE DEL MAR UNION SCHOOL DISTRICT, ACTING AS THE LEGISLATIVE BODY OF THE COMMUNITY FACILITIES DISTRICT NO. 95-1 ESTABLISHING A BUDGET FOR FISCAL YEAR 2010-2011; DIRECTING THE LEVY OF THE SPECIAL TAX AND TAKING RELATED ACTIONS**

WHEREAS, the Board of Trustees ("Board") of Del Mar Union School District ("School District") has previously completed proceedings pursuant to the Mello-Roos Community Facilities Act of 1982, as amended, commencing with Section 53311 of the Government Code of the State of California ("Act"), for the formation of Community Facilities District No. 95-1 of the Del Mar Union School District ("CFD No. 95-1"); and

WHEREAS, CFD No. 95-1 was formed by way of Resolution No. CFD 95-07 of the Board of the School District adopted on April 19, 1995; and

WHEREAS, the qualified electors within CFD No. 95-1 have authorized the levy and collection of a special tax within CFD No. 95-1 to pay for identified schools and school facilities pursuant to a Rate and Method of Apportionment of Special Tax ("Rate and Method") at an election conducted on May 10 1995; and

WHEREAS, pursuant to Ordinance No. 1995-1 adopted by the Board, acting as the Legislative Body of the CFD No. 95-1, on June 14, 1995, CFD No. 95-1 is authorized to levy and collect the special tax within CFD No. 95-1, and territory subsequently annexed into CFD No. 95-1, pursuant to the Act and the Rate and Method; and

WHEREAS, the Board, acting pursuant to the directives of the Rate and Method has adopted Resolution No. CFD 95-70 establishing the special tax rates for fiscal year 2010-2011 for property within CFD No. 95-1 which is subject to the special tax, which special tax rates are incorporated herein by this reference; and

WHEREAS, the Board, acting as the Legislative Body of CFD No. 95-1, has reviewed the financial affairs of CFD No. 95-1 and has reviewed the proposed budget setting forth the costs of administration, special tax requirements and related costs of CFD No. 95-1 for fiscal year 2010-2011; and

WHEREAS, the Board desires at this time to approve the budget and the levy of special taxes at the rate(s) specified herein for fiscal year 2010-2011 for CFD No. 95-1.

NOW, THEREFORE, THE BOARD OF TRUSTEES OF THE DEL MAR UNION SCHOOL DISTRICT, ACTING AS THE LEGISLATIVE BODY OF COMMUNITY FACILITIES DISTRICT NO. 95-1, DOES HEREBY RESOLVE, DETERMINE AND ORDER AS FOLLOWS:

**Section 1.** Pursuant to Section 53340 of the Act of the Board hereby levies the special taxes on all non-exempt property within CFD No. 95-1 pursuant to the Act and Rate and Method, and specifically in the amounts provided by and certified by Willdan Financial Services, as being sufficient to satisfy the special tax expenditure requirements of CFD No. 95-1 and to pay all costs of administration for fiscal year 2010-2011. The special tax amounts to be levied on property within CFD No. 95-1 for fiscal year 2010-2011 are set forth in Exhibit "A", attached hereto and incorporated herein by this reference.

**Section 2.** Certification is hereby made that the tax rates of the District are levied in accordance with Section 93(a) and Section 97.65 of the Revenue and Taxation Code of the State of California.

**Section 3.** The budget for CFD No. 95-1 for fiscal year 2010-2011, as set forth in Exhibit "B", is hereby approved by this Board. The budget shall be placed on file with the Clerk of the Board of Trustees of the District and is by this reference incorporated herein ("Budget").

**Section 4.** That the Superintendent and the Assistant Superintendent Business Services of the School District are hereby authorized to file copies of the Budget with such other public agencies as may be necessary.
