

20 Year Limited warranty

BRICK IT $^{\text{IM}}$ siding panels are warranted to you, the original property owner(s) named in this certificate, by the manufacturer, BRICK IT $^{\text{IT}}$ against the siding containing manufacturing defects. This warranty remains in effect for as long as the original property owner(s) owns the property or for twenty years, whichever comes first, to the property to which the siding was applied.

WARRANTY COVERAGE

BRICK IT™ warrants that the product installed on the home at the address and on the date shown hereon, will wear and age under ordinary conditions and subject to the following terms and conditions.

COVERAGE EXCLUSIONS AND LIMITATIONS

This warranty does not cover damage of any kind resulting from faulty installation, exposure to harmful materials, fire, lightning, hurricane, tornado, hailstorm, windstorm, vandalism, earthquake, or other acts of God, structural movement, or movement of surrounding areas, shrinkage, or distortion of structure members, harmful chemicals, salt spray directly applied or in the atmosphere, fumes or vapors, misuse, abuse, normal weathering, mildew accumulation, the owner(s) failure to provide reasonable and necessary maintenance of the product, such as point mortar joints if necessary, preventing water penetration from getting behind siding and not limited to and all other protective measures which can cause siding, brick, and mortar material damage, or other causes beyond the control of BRICK IT™

BRICK IT™ reserves the right to discontinue or make changes in any of its products. If the products covered by this warranty are not available, BRICK IT™ shall have the right to substitute a product that, in BRICK IT™'s sole discretion is of equal quality or value. If the BRICK IT™ product fails to perform in accordance with above standards during warranty period, BRICK IT™ will upon notification and validation of the complaint by inspection, either repair or replace at its option, the defective product with material costs pro-rated between manufacturer and owner(s). Under no conditions shall the manufacturer cover labor required to repair or replace material under this warranty.

BRICK ITTM's share of material replacement shall be 100% of the material cost, exclusive of labor to repair or replace for the first year of the warranty period. From the end of the first warranty year through the beginning of the fifth warranty year, manufacturer's share in each preceding year shall be 25% less each year for each preceding warranty year. From the beginning of the fifth warranty year through the beginning of the sixth warranty year, manufacturer's share shall be 15%. From the beginning of the sixth warranty year, manufacturer's share shall be 19% less each year for each preceding year.

BRICK $IT^{m'}s$ obligations under this warranty shall in no event exceed the original material purchase price of the installed materials. Any costs and expenses beyond BRICK $IT^{m'}s$ liability hereunder shall be the owner(s) responsibility.

BRICK IT™ shall not be liable to you for a breach of any other written or oral or express warranties, applications, or distributors of the siding. Any implied warranties imposed by law, such as the implied warranties of merchantability and fitness for purpose, are limited in time to the duration of this express warranty. BRICK IT™ shall not be liable to you for any consequential damages or incidental damages for any breach of any express written, oral or implied warranty on the siding. Your exclusive remedy shall be replacement of material solely stated in the certificate. This warranty gives you specific legal rights and you may also have other rights which vary from state to state. This warranty covers only genuine BRICK IT™ products, when used as manufacturer has so stated. This warranty is not transferable.

REGISTRATION

This warranty is valid only after the warranty registration form is completed and signed by the dealer, and signed by the original owner(s) and mailed to BRICK IT™ after installation has been completed.

CLAIM PROCEDURE

Any claim hereunder must be presented to BRICK IT™ within the warranty period and within a reasonable period of time after defect has occurred and should be accompanied by this document.
