### Submission Release for Entry into the Summit Showdown

To enter a project into the Summit Showdown, you or your company (referred to going forward as “you” or “your”) must be the sole owner of all rights in and to the project (including, but not limited to intellectual property rights), free from any rights from any third party, including another broadcast or cable network, SVoD platform or distributor, and you acknowledge that you have freely submitted your project to the Summit Showdown for consideration by Brunico Marketing Inc. (“Realscreen”) and the network selected in your application form: A&E or WE tv (the “Participating Networks”).

You accept and agree that your project will be reviewed and discussed amongst employees of Realscreen and employees of the Participating Network selected by you in your Summit Showdown application. This review and discussion will determine your project’s eligibility to be presented at the Summit Showdown live pitch competition at Realscreen Summit on Monday, January 28, 2019, as well as your project’s eligibility for a USD\$20,000 development deal with the Participating Network (subject to entering and executing a written development agreement with the applicable Participating Network).

You understand that the Participating Networks may have, at any time, explored or created materials containing programs and ideas that are similar to the theme, plot, idea or format of your submitted project, and that by submitting your project to the Summit Showdown, you relinquish any claim to the ideas, in full or in part, as it relates to any current or future programs on the Participating Networks. By entering a project into the Summit Showdown you waive any and all claims against Realscreen and/or the Participating Networks and you will not be entitled to any compensation from Realscreen, nor the Participating Networks, for the use of such materials. Further, you hereby release Realscreen and the Participating Networks from any and all claims, demands or causes of action which you and/or your heirs, successors or assigns may now have or hereafter acquire with respect to your project.

Submission of your project to the Summit Showdown does not imply a contractual agreement between you and Realscreen, nor the Participating Networks. Realscreen and the Participating Networks shall not be under any obligation to you with respect to your project except as may later be set forth in a fully executed written agreement between you and one of the Participating Networks.

If selected to pitch at the Summit Showdown, you agree to present your project during the live pitch competition at Realscreen Summit, during a timed, five-minute presentation. Any presentation of footage or handing out of materials must fall within your five-minute pitch.

As Realscreen Summit’s main conference sessions are videotaped and posted after the event on Realscreen’s event messaging tool, realXchange, you agree to provide the release of footage captured during your live presentation for future viewing by registered Realscreen Summit attendees. Realscreen and the Participating Networks will not be held responsible for the use of your idea by any third party due to your participation in the live pitch competition at Realscreen Summit.

Please acknowledge your agreement to the terms and conditions for submitting your project to the Summit Showdown at Realscreen Summit 2019 by signing below. Submissions without a signed release form will not be considered.
