Introduced: 11/26/2018

Sponsor: Sen. Roy Blunt (R-MO)

This Senate resolution expresses support for the goals of National Adoption Day and National Adoption Month by promoting national awareness of adoption and the children awaiting families, celebrating children and families involved in adoption, and encouraging the people of the United States to secure safety, permanency, and well-being for all children. *Status: Submitted in the Senate, considered, and agreed to without amendment and with a preamble by Unanimous Consent on 11/26/18.*

In an effort to highlight the importance of supporting historically underrepresented students in higher education institutions, including foster youth. This bill would amend the Higher Education Act of 1965 to create an innovation zone initiative and authorize the Secretary and higher education institutions to conduct voluntary experiments that aim to increase student success. *Status: Read twice and referred to the Committee on Health, Education, Labor, and Pensions on 10/11/18.*

H.R.7012: Supporting Kinship Connections Act

Introduced: 10/2/2018

Sponsor: Rep. Karen Bass (D-CA)

This bill would amend part B of title IV of the Social Security Act to provide for grants to develop and enhance, or to evaluate, kinship navigator programs. *Status: Referred to House Committee on Ways and Means on 10/2/2018.*

H.R.6985: To establish an Intercountry Adoption Advisory Committee, and for other purposes

Introduced: 9/28/2018

Sponsor: Rep. John R. Curtis (R-UT)

This bill is the House companion to S.3396 and it supports the establishment of an Intercountry Adoption Advisory Committee. *Status: Referred to the House Committee on Foreign Affairs on 9/28/2018.*

H.Res.1093: Expressing support for the designation of September 2018 as “National Kinship Care Month”

Introduced: 9/27/2018

Sponsor: Rep. Karen Bass (D-CA)

This resolution expresses support for the designation of September 2018 as “National Kinship Care Month”, encourages Congress to implement policies to improve the lives of vulnerable children and families, honor the commitment and dedication of kinship caregivers and the advocates and allies who work tirelessly to provide assistance and services to kinship families, and reaffirm the need to continue working to improve the outcomes of all vulnerable children. *Status: Referred to the House Committee on Ways and Means on 9/27/2018.*

S.Res.637: A Resolution Designation September 2018 as “National Kinship Care Month”

Introduced: 9/18/2018

Sponsor: Sen. Ron Wyden (D-OR)

This resolution encourages Congress, states, local governments, and community organizations to continue to work to improve the lives of vulnerable children and families, and support the communities working together to lift them up. *Status: Agreed to in Senate without amendment and with a preamble by Unanimous Consent on 9/27/2018.*

S. 3396: Intercountry Adoption Advisory Committee Act of 2018

Introduced: 8/28/2018

Sponsor: Sen. Amy Klobuchar (D-MN)

This bill would allow for the Secretary of State to establish within the Bureau of Consular Affairs an intercountry adoption advisory committee. *Status: Read twice and referred to the Committee on Foreign Relations on 8/28/2018.*

S.Res. 612: A Resolution designating September as “National Child Awareness Month” to promote awareness of charities that benefit children and youth-serving organizations throughout the United States and recognizing the efforts made by those charities and organizations on behalf of children and youth as critical contributions to the future of the United States.

Introduced: 8/22/2018

Sponsor: Sen. Dianne Feinstein (D-CA)

This resolution designates September 2018 as “National Child Awareness Month” to promote awareness of charities that benefit children and youth-serving organizations throughout the United States; to recognize the efforts made by those charities and organizations on behalf of children and youth as critical contributions to the future of the United States; and to recognize the importance of meeting the needs of at-risk children and youth who—have experienced homelessness; are in the foster care system; have been victims, or are at risk of becoming victims, of child sex trafficking; have been impacted by violence; have experienced trauma; and have serious physical and mental health needs. *Status: Agreed to in Senate without amendment and with a preamble by Unanimous Consent on 9/6/2018.*

S. 3294 FINISH Act

Introduced: 7/26/2018

Sponsor: Sen. Orrin G. Hatch (R-UT)

To amend the Higher Education Act of 1965 to support innovative, evidence-based approaches that improve the effectiveness and efficiency of postsecondary education for all students through the establishment of competitive grant partnerships that specifically target “high-need” students like former foster youth. These may include pay for success initiatives and other innovative solutions and incentives to improve the post-secondary education system. The act also requires additional evaluations of all programs authorized under it. *Status: Referred to the Committee on Health, Education, Labor, and Pensions on 7/26/2018.*

H.R. 6553: To amend the William Wilberforce Trafficking Victims Protection Reauthorization Act of 2008 to require consultation with State and local elected officials and a public hearing before awarding grants or contracts for housing facilities for unaccompanied alien children.

Introduced: 7/26/2018

Sponsor: Rep. Pete Olson (R-TX)

To amend the William Wilberforce Trafficking Victims Protection Reauthorization Act of 2008 to require consultation with State and local elected officials and a public hearing before awarding grants or contracts for housing facilities for unaccompanied alien children. *Status: Referred to the House Committee on the Judiciary on 7/26/2018.*

H.R. 6594: To reunite families separated at or near ports of entry, and for other purposes.

Introduced: 7/26/2018

Sponsor: Rep. Adriano Espaillat (D-NY)

To reunite families separated at or near ports of entry, and for other purposes. *Status: Referred to the House Committee on the Judiciary on 7/26/2018.*

H.R. 6527: To provide access to counsel for children and other vulnerable populations

Introduced: 7/25/2018

Sponsor: Rep. Donald A. McEachin (D-VA)

This amendment would provide access to counsel for children and other vulnerable populations.

Status: Referred to the House Committee on the Judiciary on 7/25/2018.

S.3263: A bill to limit the separation of families at or near ports of entry, to provide access to counsel to unaccompanied alien children, and to improve immigration detention, and for other purposes.

Introduced: 7/25/2018

Sponsor: Sen. Richard Durbin (D-IL)

This bill would prescribe rules limiting the separation of families at or near ports of entry with an emphasis on promoting family unity and limiting sibling separation. It also requires the Secretary to publish a policy for locating separated families and provide the detained parents with certain information on their separated children, and provides access to counsel for unaccompanied children. *Status: Read twice and referred to the Committee on the Judiciary on 7/25/2018.*

H.Res. 1005: Directing the Secretary of Homeland Security to transmit certain documents to the House of Representatives relating to the border security policies, procedures, and activities as such relate to the interdiction of families by the U.S. Border Patrol between ports of entry.

Introduced: 7/19/2018

Sponsor: Rep. Bennie G. Thompson (D-MS)

This resolution would direct the Secretary of Homeland Security to transmit all records regarding families interdicted between ports of entry by U.S. Border Patrol from June 2016 through June 2018, including the ages of the children interdicted, what actions were taken with respect to the children interdicted, and the number of criminal referrals, including for trafficking children, the U.S. Border Patrol made. *Status: Placed on the House Calendar (Calendar No. 178) on 7/26/2018.*

Amdt. to Department of Labor, HHS, & Education, and other Related Agencies Appropriations Act, 2019 (H.R. 6470)

Introduced: 7/11/2018

Sponsor: Rep. Robert Aderholt (R-AL)

This amendment would withhold 15% of federal funding from states or local governments that hinder child welfare service providers from refusing to provide services based on their religious beliefs. *Status: Passed Committee on Appropriations on 7/11/2018.*

H.R. 6326: Reunite Separated Families Act of 2018

Introduced: 7/10/2018

Sponsored: Rep. Michael E. Capuano (D-MA)

To temporarily restrict the removal of alien parents separated from their children, and for other purposes. This bill would prevent the deportation of any parents separated from their children at the border until the separation practices is ended by law, as well as assure communication among separated family members and the psycho-social health of the separated children. *Status: Referred to the House Committee on the Judiciary on 7/10/2018.*

H. Res. 982: Of Inquiry requesting the President, and directing the Secretary of Health and Human Services, to transmit, respectively, certain information to the House of Representatives referring to the separation of children from their parents or guardians as a result of the President's "zero tolerance" policy

Introduced: 7/3/2018

Sponsored: Rep. Frank Pallone, Jr. (D-NJ)

Requests information on the family separation practice at the border, including about the welfare and health of the separated children as well as long-term implications of the policy. *Status: Ordered to be reported by the Committee on Energy and Commerce with a vote of 52-0.*

H.R. 6304: Reunifying Separated Families Act of 2018 To direct the Secretary of Homeland Security to reunite alien children separated from their parent or legal guardian with such parent or legal guardian, and for other purposes. *Status: Referred to the Subcommittee on Border and Maritime Security on 7/16/2018.*
Introduced: 7/3/2018
Sponsored: Rep. Charlie Crist (R-FL)

S.3173: Safe Home Act of 2018 To amend the Child Abuse Prevention and Treatment Act to include an act of unregulated custody transfer in the definition of child abuse and neglect, and for other purposes. *Status: Read twice and referred to the Committee on Health, Education, Labor, and Pensions on 6/28/2018.*
Introduced: 6/28/2018
Sponsor: Sen. Amy Klobuchar (D-MN)

S.3163: Intercountry Adoption Information Act of 2018 To amend the Intercountry Adoption Act of 2000 to require the Secretary of State to report on intercountry adoptions from countries which have significantly reduced adoption rates involving immigration to the United States, and for other purposes. The report would include information on actions taken by the U.S. and the other country to address shortcomings and reasons as to why the adoption rate has been reduced or halted. *Status: Read twice and referred to the Committee on Foreign Relations on 6/28/2018.*
Introduced: 6/28/2018
Sponsor: Sen. Richard Burr (R-NC)

S.3158: Departments of Labor, Health and Human Services, and Education, and Related Agencies Appropriations Act, 2019 Making appropriations for the Department of Health & Human Services, including the Administration for Children & Families, foster care programs, and other family-oriented services. *Status: Placed on Senate Legislative Calendar on 6/28/2018.*
Introduced: 6/28/2018
Sponsor: Sen. Roy Blunt (R-MO)

H.R. 6236 Family Unity Rights & Protection Act To require the reunification of families separated upon entry into the United States as a result of the “zero-tolerance” immigration policy requiring criminal prosecution of all adults apprehended crossing the border illegally. The bill provides for a registry to track and stay in contact with separated families, as well as conditions on terminating parental rights within those families. *Status: Referred to the Subcommittee on Immigration and Border Security on 8/2/2018.*

H.R.6233: Family Poverty is Not Child Neglect Act

Introduced: 6/26/2018

Sponsor: Rep. Gwen Moore (D-WI)

To amend the Child Abuse Prevention and Treatment Act to ensure that child protective services systems do not permit the separation of children from parents on the basis of poverty, and for other purposes. *Status: Referred to the House Committee on Education and the Workforce on 6/26/2018.*

H.R. 6223: Child Advocate Program Reauthorization Act

Introduced: 6/26/2018

Sponsor: Rep. Grace Meng (D-NY)

Reauthorizes the Child Advocate Program through fiscal year 2022. *Status: Referred to the House Committee on the Judiciary on 6/26/2018.*

H.R. 6222: Better Care for Kids Act

Introduced: 6/26/2018

Sponsor: Rep. Grace Meng (D-NY)

To improve the specialized training requirement for Federal personnel who have substantive contact with unaccompanied alien children. *Status: Referred to the Subcommittee on Immigration and Border Security on 8/2/2018.*

S. 3120: HEAL Act of 2018

Introduced: 6/25/2018

Sponsor: Sen. Orrin G. Hatch (R-UT)

A bill to help end addictions and lessen substance abuse disorders. Supports family residential treatment programs where children reside with their parents and guardians during treatment. Enables DHHS and to provide guidelines for state programs and their implementation of Medicaid funding. *Status: Placed on the Senate Legislative Calendar under General Orders, Calendar No. 484, on 6/25/2018.*

H.R. 6204: Families First Act of 2018

Introduced: 6/22/2018

Sponsor: Rep. Pete Sessions (R-TX)

To clarify standards of family detention and the treatment of unaccompanied alien children. This bill provides procedures for interviewing the child and keeping track of their placement and guardian. *Status: Referred to the Subcommittee on Immigration and Border Security on 8/2/2018.*

H.R. 6195: Protect Kids and Parents Act

Introduced: 6/22/2018

Sponsor: Rep. Dave Brat (R-VA)

This bill preserves parental rights, favors parental retention of custody, and requires strictly evidence-based procedures and reasoning for separating children from their families. *Status: Referred to the Subcommittee on Immigration and Border Security on 8/6/2018.*

H.R. 6183: Family Reunification Act

Introduced: 6/21/2018

Sponsor: Rep. Bill Huizenga (R-MI)

To require the Secretary of Homeland Security to reunite unaccompanied alien children with the parents or legal guardians with whom they entered the United States and defining exceptions to reunification pertaining to the “best interests of the child” according to the Adoption and Safe Families Act of 1997. *Status: Referred to the Subcommittee on Immigration and Border Security on 8/2/2018.*

H.R. 6180: Mental Health Care for Children Inhumanely Separated from Parents by the Federal Government Act of 2018

Introduced: 6/21/2018

Sponsor: Rep. Nanette Diaz Barragan (D-CA)

To require the Federal Government to provide mental health services to each child who has been separated from one or more parent as a result of implementation of the Trump Administration’s zero tolerance policy at the United States border. These services would be provided by professionals not employed by the federal government. *Status: Referred to the Subcommittee on Immigration and Border Security on 8/6/2018.*

H.R. 6172: Reunite Children with Their Parent Act of 2018

Introduced: 6/21/2018

Sponsor: Rep. Brendan F. Boyle (D-PA)

This bill directs the Department of Homeland Security to reunite an alien who entered the United States with the alien's minor child (under the age of 18) who was separated from the child pending prosecution for improper entry or the adjudication of an asylum application. *Status: Referred to the Subcommittee on Immigration and Border Security on 8/2/2018.*

H.R. 6115: Safe Home Act of 2018

Introduced 6/14/2018

Sponsor: Rep. James R. Langevin (D-RI)

To amend the Child Abuse Prevention and Treatment Act to include an act of unregulated custody transfer in the definition of child abuse and neglect. *Status: Referred to the House Committee on Education and the Workforce on 6/14/2018.*

S. 3075: Children’s Budget Act

Introduced: 6/14/2018

Sponsor: Sen. Robert Menendez (D-NJ)

This bill requires the President's annual budget submission to include a detailed and separate analysis of current and requested levels of spending for children and children's programs. *Status: Read twice and referred to the Committee on the Budget on 6/14/2018.*

S. 3074: Focus on Children Act

Introduced: 6/14/2018

Sponsor: Sen. Kamala D. Harris (D-CA)

This bill amends the Congressional Budget Act of 1974 to require the Congressional Budget Office (CBO) to produce studies and reports regarding federal spending on children. Also requires the CBO to maintain a public website including these reports and studies, indicators and other tools on child spending trends, and quantitative data on that federal spending. *Status: Read twice and referred to the Committee on the Budget on 6/14/2018.*

H.R. 6: SUPPORT for Patients and Communities Act

Introduced: 6/13/2018

Sponsor: Rep. Greg Walden (R-OR)

Expands Medicaid coverage for former foster youth by allowing states to extend coverage to age 26. Increases monitoring of antipsychotic medication of children in foster care. *Status: Signed by President and became Public Law No: 115-271 on 10/24/2018.*

S. 3039: Using Data to Help Protect Children and Families Act

Introduced: 6/7/2018

Sponsor: Sen. Todd C. Young (R-IN)

To provide funding for the development of a predictive analytics pilot program to help children and families who come to the attention of the child welfare system. Creates grant pathways for research-based strategies for risk and safety assessments of child abuse and neglect. *Status: Read twice and referred to the Committee on Health, Education, Labor, and Pensions on 6/7/2018.*

S. 3036: Keep Families Together Act

Introduced: 6/7/2018

Sponsor: Sen. Dianne Feinstein (D-CA)

The bill favors family and sibling unity and parental rights. Prohibits removing a child who is under the age of 18 and has no permanent immigration status from his or her parent or legal guardian with 100 miles of the U.S. border unless, among other things, a state or county child welfare official with expertise in child trauma and development determines that it is in the child's best interests to be removed because of abuse or neglect. *Status: Read twice and referred to the Committee on the Judiciary on 6/7/2018.*

H.R.6014: To reauthorize the Family Violence Prevention and Services Act

Introduced: 6/6/2018

Sponsor: Rep. Glenn Thompson (R-PA)

This bill allows for the reauthorization of the family Violence Prevention and Services Act. *Status: Passed without objection on 9/28/2018 and was received in the Senate on 10/1/2018.*

H.R. 5955: Victims of Child Abuse Reauthorization Act of 2018

Introduced: 5/24/2018

Sponsor: Rep. Ted Poe (R-TX)

This bill would amend the Victims of Child Abuse Act of 1990 to authorize grants to create multidisciplinary child abuse investigations, intervention, and prosecution and to promote, develop, and oversee the use of an evidence-informed Children's Advocacy Model to respond to child abuse. It also would authorize grants to states to assist local Children's Advocacy Centers to provide evidence-informed initiatives such as mental health counseling, forensic interviewing, multidisciplinary team coordination, and victim advocacy. *Status: Referred to the Subcommittee on Crime, Terrorism, Homeland Security, and Investigations on 7/24/2018.*

H.R. 5915: Foster Youth Success in College Act This bill would amend the TRIO programs to require priority be given to homeless children and youth, and students in foster care.

Sponsor: Rep. Paul Mitchell (R-MI) *Status: Referred to the House Committee on Education and Workforce on 5/22/2018*

H.R. 5950: HELP Separated Children Act This bill would require the Secretary to provide detained parents access to free telephone calls to child welfare agencies and family courts to ensure that their child's best interest is considered in child welfare agency or family court proceedings. *Status: Referred to the Subcommittee on Immigration and Border Security on 7/24/2018.*
Introduced: 5/23/2018
Sponsor: Rep. Lucille Roybal-Allard (D-CA)

H.R. 5833: Expanding Housing Opportunities for Foster Youth Act of 2018 This bill authorizes appropriations for family unification vouchers, for rental housing assistance, and for other purposes. The Family Unification Voucher program provides housing assistance for foster youth and case management, without a work requirement. *Status: Referred to the House Committee on Financial Services on 5/16/2018.*
Introduced: 5/16/2018
Sponsor: Rep. Maxine Waters (D-CA)

H.R. 5799: Medicaid Drug Review, Utilization, Good Governance Improvement Act Improves state monitoring of antipsychotic medications by children. *Status: Reported by the Committee on Energy and Commerce on 6/12/2018.*
Introduced: 5/15/2018
Sponsor: Rep. Marsha Blackburn (R-TN)

H. R. 5626: Intercountry Adoption Information Act of 2018 This bill amends the Intercountry Adoption Act of 2000 to require the State Department's annual intercountry adoption report to identify which countries have stopped or reduced adoptions involving immigration the U.S., what efforts the State Department has made to encourage resuming such adoptions, and what actions the State Department has taken to prevent such adoptions. It would also require the report to be made available to the public on the State Department's website. *Status: Received in the Senate, read twice and referred to the Committee on Foreign Relations.*

S. 2680: Opioid Crisis Response Act of 2018 To address the opioid crisis. *Status: Places on Senate Legislative Calendar on 5/7/2018.*
Introduced: 4/16/2018
Sponsor: Sen. Lamar Alexander (R-TN)

To create a community-action opioid response grant program. The funds would be used for public education, identification of at-risk individuals, support for foster youth or those at-risk of foster placement and their caregivers, and other projects and services responding to multi-generational risks of opioid addiction. *Status: Read twice and referred to the Committee on Health, Education, Labor, and Pensions on 4/10/2018.*

[H.R. 5233: Adoptee Citizenship Act of 2018](#)

Introduced: 3/8/2018

Sponsor: Rep. Adam Smith (D-WA)

To provide for automatic acquisition of United States citizenship for certain internationally adopted individuals. *Status: Referred to the Subcommittee on Immigration and Border Security on 4/30/2018.*

Introduced: 3/8/2018

Sponsor: Sen. Roy Blunt (R-MO)

To provide for automatic acquisition of United States citizenship for certain internationally adopted individuals. *Status: Read twice and referred to the Committee on the Judiciary on 3/8/2018.*

[H.R. 5124: Community Action Opioid Response Act of 2018](#)

Introduced: 2/27/2018

Sponsor: Rep. Betty McCollum (D-MN)

To create a community-action opioid response grant program. The funds would be used for public education, identification of at-risk individuals, support for foster youth or those at-risk of foster placement and their caregivers, and other projects and services responding to multi-generational risks of opioid addiction. *Status: Referred to the Committee on Education and the Workforce on 2/27/2018.*

[H.R. 4990: Rehab and Ahmed Amer Foster Care Improvement Act of 2018](#)

Introduced: 2/8/2018

Sponsor: Rep. Debbie Dingell (D-MI)

To require States to follow certain procedures in placing a child who has been removed from the custody of his or her parents. The bill calls for notification of all adult relatives of a child removed from parental custody, as well as notice of the placement decision and reasons for it. *Status: Referred to the Subcommittee on Human Resources on 2/14/2018.*

[H.R. 4547: Strengthening Protections For Social Security Beneficiaries Act of 2018](#)

Introduced: 12/05/2017

Sponsor: Rep. Sam Johnson (R-TX)

A bill requiring the Social Security Administration (SSA) to enter into agreements with each state for the purpose of sharing information to identify represented minor beneficiaries who are in foster care; and determine the appropriate representative payee for any represented minor beneficiary who has entered foster care, exited foster care, or changed foster care placement in a given month. *Status: Signed into Public Law No. 115-165 by the President on 4/13/2018.*

H.R. 4461: The COURTS Act

In an effort to ensure that organizations with religious or moral beliefs are allowed to continue to provide services for children, prohibits the federal government, and states receiving federal funding under Parts B or E of Title IV of the Social Security Act, from discriminating or taking an adverse action against a child welfare service provider that declines to provide, facilitate, or refer for a child welfare service that conflicts with, or under circumstances that conflict with, the provider's sincerely held religious beliefs or moral convictions. *Status: Read twice and referred to the Committee on Finance on 4/4/2017.*

H.R. 1881: Child Welfare Provider Inclusion Act of 2017

In an effort to ensure that organizations with religious or moral beliefs are allowed to continue to provide services for children, prohibits the federal government, and states receiving federal funding under Parts B or E of Title IV of the Social Security Act, from discriminating or taking an adverse action against a child welfare service provider that declines to provide, facilitate, or refer for a child welfare service that conflicts with, or under circumstances that conflict with, the provider's sincerely held religious beliefs or moral convictions. *Status: Referred to the Subcommittee on Human Resources on 4/17/2017.*

H.R. 1892: Bipartisan Budget Act of 2018

Introduced: 4/4/2017

Sponsor: Rep. John Larson (D-CT)

A bill to reauthorize adoption and legal guardianship incentive programs through 2021. Ensures states reinvest savings resulting from increase in adoption assistance with GAO study and report. Enables states to provide enhanced support to children and families and prevent foster care placements through the provision of mental health and substance abuse prevention and treatment services, in-home parent skill-based programs, and kinship navigator services. Eliminates the time limit for family reunification services while in foster care. *Status: Signed into Public Law No. 115-123 by the President on 2/9/2018.*

H.R. 1808: Improving Support for Missing and Exploited Children Act of 2017

Introduced: 3/30/2017

Sponsor: Rep. Brett Guthrie (R-KY)

In an effort to strengthen efforts to recover missing children and support youth who are the victims of violent crime, amends the Missing Children's Assistance Act to update language and expand the role of the National Center for Missing and Exploited Children (NCMEC). Requires that training be provided to relevant entities on responses to foster children missing from state child welfare systems and increases the role of nongovernmental organizations, law enforcement agencies, and schools in identifying, locating, and recovering victims of, and children at risk for, child sex trafficking. *Status: Passed by the House on 5/23/2017. Status: Received in the Senate and read twice on 5/24/2017 and referred to the Committee on the Judiciary.*

S. 774: Trauma-Informed Care for Children and Families Act of 2017

Sponsor: Sen. Heidi Heitkamp (D-ND)

In an effort to address the psychological, developmental, social, and emotional needs of children, youth, and families who have experienced trauma, establishes the Interagency Task Force on Trauma-Informed Care, the National Law Enforcement Child and Youth Trauma Coordinating Center, and the Native American Technical Assistance Resource Center. Amends the Public Health Service Act, Child Care and Developmental Block Grant Act, Social Security Act, and Elementary and Secondary Education Act to increase the amount of funding available for identifying and treating mental, behavioral, and biological disorders of children and youth resulting from witnessing or

H.R. 1757: Trauma-Informed Care for Children and Families Act of 2017

Introduced: 3/28/2017

Sponsor: Rep. Danny K. Davis (D-IL)

In an effort to address the psychological, developmental, social, and emotional needs of children, youth, and families who have experienced trauma, establishes the Interagency Task Force on Trauma-Informed Care, the National Law Enforcement Child and Youth Trauma Coordinating Center, and the Native American Technical Assistance Resource Center. Amends the Public Health Service Act, Child Care and Developmental Block Grant Act, Social Security Act, and Elementary and Secondary Education Act to increase the amount of funding available for identifying and treating mental, behavioral, and biological disorders of children and youth resulting from witnessing or experiencing a traumatic event as well as to improve trauma support services and mental health care for children and youth in educational settings. Requires the Secretary of Health and Human Services to conduct an analysis of and submit a report to Congress on the prevalence and public health impacts of child, youth, and adult trauma experienced in the US, existing modules that measure and assess adverse childhood experiences, and outcomes modules that measure and evaluate the utilization and efficacy of trauma-informed interventions. Also instructs the Director of the Centers for Disease Control and Prevention to authorize and encourage states to collect and report data on adverse childhood experiences. *Status: Referred to the Subcommittee on Crime, Terrorism, Homeland Security, and Investigations on 4/12/2017.*

H.R. 1748: Opening Doors for Youth Act of 2017

Introduced: 3/28/2017

Sponsor: Rep. Bobby Scott (D-VA)

In an effort to improve employment and education outcomes for at-risk and disconnected youth, including young people involved in or aging out of the foster care system, authorizes the Secretary of Labor to allocate funds to subsidize summer and year-round youth employment programs designed and implemented by local

Expresses support for a uniform adoption process for foster youth and promotes enactment of the Interstate Compact for the Placement of Children by all states to ensure that more children are placed in safe, permanent homes. *Status: Referred to the Subcommittee on Regulatory Reform, Commercial and Antitrust Law on 1/23/2017.*

H.R. 269: Look-back Elimination Act of 2017

Introduced: 1/4/2017

Sponsor: Rep. John Lewis (D-GA)

In an effort to treat all children equally, eliminates the requirement that, to be eligible for foster care maintenance payments, a child would have to have been eligible for aid under the former program of Aid to Families with Dependent Children at the time of removal from the home. Supports the replacement of the requirement with income eligibility standards based on certain criteria and encourages the Secretary of Health and Human Services to collaborate with Members of Congress and child welfare advocates to develop modified standards. *Status: Referred to the Subcommittee on Human Resources on 1/18/2017.*

H.R. 253: Family First Prevention Services Act of 2017

Introduced: 1/4/2017

Sponsor: Rep. Vern Buchanan (R-FL)

In an effort to strengthen families and reduce congregate care placements by allowing states to use foster care funding to provide evidence-based prevention services, ensure more foster children are placed with families, reduce the amount of time foster children wait to be adopted or placed with relatives, and support relatives who assume responsibility for a child, amends Parts B and E of Title IV of the Social Security Act. *Status: Partially enacted through H.R. 1892 in Public Law No. 115-123 on 2/9/2018.*
