The tested model of Subaru Impreza was introduced in Australia and New Zealand in November 2016. This ANCAP safety rating applies to all hatch and sedan variants.

Dual frontal, side chest and side head airbags (curtains) and a driver knee airbag are standard. Advanced seat belt reminders are fitted to all seats. Autonomous emergency braking (AEB) and lane support systems (LSS) are not available on the base variant but are optional or standard on higher variants. Occupant Protection.

Frontal Offset Test

Each body region is scored out of 4 points

Head / neck:	4.00 points
Chest:	3.43 points
Upper legs:	4.00 points
Lower legs:	3.37 points

The passenger compartment held its shape well in the frontal offset test. Pedal and steering wheel displacements were well controlled. Driver and passenger contact with the airbags was stable. All doors remained closed during the crash. After the crash all doors could be opened with normal effort.

Side Impact Test

Each body region is scored out of 4 points

Good protection was provided for the driver in the side impact test. The side airbags performed well.
