Mongolian Government Approves Centerra's Feasibility Study of the Gatsuurt Project

TORONTO, CANADA – **March 11, 2008** – Centerra Gold Inc. (TSX - CG) announced today that the Mineral Resources and Petroleum Authority of Mongolia has accepted the feasibility study for the development of the Gatsuurt hard-rock gold deposit. The Company and the Government have commenced negotiation of an Investment Agreement for the development of the Gatsuurt deposit.

"Now that the Gatsuurt Project feasibility study has been approved, I am hopeful we can negotiate an acceptable Investment Agreement, which will allow us to develop the Gatsuurt deposit in a timely manner," said Len Homeniuk, President and the CEO of Centerra Gold Inc.
