I, in consideration of the personal benefits accruing to me and through participation in the Event and other good and valuable consideration received, have elected to participate in the event and hereby release absolutely, forever discharge and hold harmless FIRST BAPTIST CHURCH OF BATON ROUGE, LOUISIANA, its successors, affiliates, officers, directors, employees, members, volunteers and/or agents and any organization or person(s) working for or with FIRST BAPTIST CHURCH OF BATON ROUGE, LOUISIANA or sponsoring an event/program for FIRST BAPTIST CHURCH OF BATON ROUGE, LOUISIANA (collectively, "Releasees") from any and all present or future liability, claims, demands or actions, whether asserted by me or a third party, arising out of my travel to and from and participation in the Event, including, but not limited to injury or death ("Claims"). Additionally, I agree that I, my heirs, successors, and assigns will not make any claim or institute any lawsuit against FIRST BAPTIST CHURCH OF BATON ROUGE, LOUISIANA and/or the Releasees for any and all liability for losses, injuries, damages, and/or death that may result from my participation in the missions program of the FIRST BAPTIST CHURCH OF BATON ROUGE, LOUISIANA. Further, I agree to indemnify the Releasees for any such Claims and for liability and/or damages associated therewith, including, but not limited to, reasonable attorney's fees, court costs and other legal expenses.

Understanding. I represent and acknowledge that I have completely read and understand this document, that I have had ample opportunity to obtain the advice of counsel and that by signing this document understand that I am relinquishing legal rights and remedies that may have otherwise been available to me. I understand that this Waiver and Release shall be construed as broadly and inclusively as is permitted by applicable law and agree that if any portion of this document is held invalid, the remaining shall continue in full force and effect. To the extent the Release / Indemnification provision above is deemed unlawful, I agree to submit any claims I may have to a Christian conciliation/mediation organization for binding resolution.

Media Consent.
