Memorial Bible Church Beliefs – Statement of Faith

- I affirm my confidence in the Bible as the inspired, the only infallible, authoritative Word of God.
- I believe there is one God, Creator of all things, infinitely perfect, and eternally existing in three persons: Father, Son, and Holy Spirit.
- I claim Jesus Christ as my Lord – God who came in human flesh – the object of my worship and the subject of my praise.
- I believe that the Holy Spirit, the third person of the Trinity, is incessantly at work convicting, convincing and comforting.
- I confess that Adam's fall into sin left humanity without the hope of heaven apart from a new birth, made possible by the Savior's death and bodily resurrection.
- I believe that salvation is by grace, through faith alone, utterly apart from any human merit or work. I believe that our salvation has been completely accomplished through Christ, who died in our place. I believe that all the redeemed, once saved, are kept by God's power and thus are secure in Christ forever.
- I believe God expects my life to reflect that I belong to Him and am pursuing a holy life being obedient to His Word.
- I believe in the personality and reality of Satan.
- I believe in the personal imminent coming of the Lord Jesus Christ for His own, the Church, and His subsequent return to earth in power and glory to set up His Messianic, Millennial Kingdom.
- I believe in the bodily resurrection of all men: the saved to eternal life, and the unsaved to judgment and everlasting punishment. We believe in the reality of Heaven and Hell.
- I believe that the Lord Jesus instituted the ordinances of water baptism and the Lord's Supper, to be observed by all believers, and only believers, until His return. We believe in water baptism by immersion soon after accepting Christ as personal Savior. We believe this baptism is not for salvation, nor even for membership in the local church, but is an act of obedience to Christ and a testimony of faith in Christ. We believe the Lord's Supper is a memorial service, setting forth in sacred and symbolic manner the death of the Lord Jesus Christ.
- I believe in the Great Commission – which is our responsibility to do all we can to bring people in our geographic area and throughout the world, to faith in Jesus Christ, and growth in Him.
