

# Benin and Togo

## Course Tuition–Due First Day of Each Course

1. For Adult High School (HS) completion – no tuition (only MGST/T-Net fees)
2. Diploma – 10,000 CFA/course (no MGST/T-Net fees)
3. Bachelor of Arts (BA) – 10,000 CFA/course
4. Master of Arts (MA) – 15,000 CFA/course
5. Doctor of Ministry (D.Min) - 20,000 CFA/course

## Minnesota Graduate School of Theology / T-Net Fees

Every degree requires payment of the following fees:

1. \$50 USD registration fee paid in the first year of the degree program
2. \$50 USD matriculation fee paid in the second year of the degree program
3. \$50 USD graduation fee. paid in the third year of the degree program

A 2500 CFA money transfer fee must be paid with **each** \$50 payment to cover the costs of sending funds to MGST/T-Net.

## MGST / T-Net Fee Payment Schedule and Late Payment Penalties

### Registration fees

1. **10-Course T-Net Training Center HS/BA/MA** - For every different degree there is a separate registration fee of \$50 USD due on the first day of course one (Note: Adult High School Completion students must pay two fees during the 10-Course T-Net Training Center, \$50 for HS and \$50 for BA). A student must also submit a one-time MGST / T-Net application for admission. The application and fee must be submitted and paid by the first day of course 3 to avoid a late fee.
2. **Late Payment Penalties for HS/BA/MA**
  - If paid between course 3 and 4, late fee = 2500 CFA
  - If paid between course 4 and 5, additional late fee of 2500 CFA
  - If paid later, additional 2500 CFA for every meeting late.
3. **Organizational Management D.Min or MA** - Registration fee is due and must be paid at the second class (Course 626) taken after graduation from the 10-Course Training Center Program to avoid late fees.
4. **Late Payment Penalties for D.Min or MA in Organizational Management** - If paid after Course 626 a late fee of 2500 CFA will be charged for every meeting late.

**Matriculation fees** – For every different degree level there is a separate matriculation fee of \$50 USD.

1. HS/BA/MA courses: \$50 on the first day of course 6
2. D.Min or MA in Organizational Management: \$50 paid at course 629
3. Shipping/handling fees must be added to each fee paid
4. **Late Payment Penalties** - If paid later, 2500 CFA penalty for every course paid late – just as above

**Graduation fees** – For every different degree level there is a separate matriculation fee of \$50 USD.

1. HS/BA/MA courses: \$50 on the first day of course 9
2. D.Min or MA in Organizational Management: \$50 paid at course 862
3. Shipping/handling fees must be added to each fee paid
4. **Late Payment Penalties** - If paid later, 2500 CFA penalty for every course paid late – just as above
