<ul style="list-style-type: none">➤ Estimated Surrogate reimbursement, including monthly misc. expenses➤ Estimated expenses for one local transfer, including travel expenses, transfer payment (travel expenses refundable if not used)➤ Estimated expenses for singleton pregnancy, including maternity clothing, post birth recovery, housekeeping➤ Includes allowance of \$2,000 for contingencies in Surrogate Agreement (refundable if unused, can be more depending on circumstances)

Additional Payments Based on Circumstances⁴

Estimate for Additional Transfer or Mock Cycle	\$3,000 - \$6,000
<ul style="list-style-type: none">➤ Includes additional transfer fee for surrogate, monthly misc. expenses, and estimate costs for travel and local monitoring	
Estimate for Twin Pregnancy	\$10,000 - \$15,500
<ul style="list-style-type: none">➤ Higher reimbursement to Surrogate and Agency➤ Higher contingency fund to pay for Surrogate expense, including maternity clothing, post-birth recovery expenses, c-section fee	
Estimate for Additional Egg Retrieval	\$14,000
<ul style="list-style-type: none">➤ Estimated payment to Egg Donor and travel to IVF clinic for retrieval	
Estimate for Singleton Newborn Expenses	\$2,000 - \$5,000
<ul style="list-style-type: none">➤ Estimated singleton hospital bill, after insurance pays, Circle can assist with billing upon request	
Estimated Expense Surrogate Rematch Needed	\$11,050
<ul style="list-style-type: none">➤ Includes Agency Rematch Fee➤ Includes estimated legal and screening expenses➤ Includes \$500 for travel expenses

⁴ Other Potential Expenses include: Additional local counsel fees for birth order/adoption – \$2,000; Additional reimbursement to Surrogates for: previous experience (\$5,000+), living in high demand state (\$5,000+), matching with SPAR program (\$2,500), and/or matching with IPs who need translator (\$2,500); Expenses for translator - \$3,500; expenses for pumping payments & supplies (if IPs request) - \$2,000; Donor’s local monitoring (if needed) - \$2,000
