| <ul style="list-style-type: none"><li>➤ Program Manager will serve as Concierge, the Intended Parents' sole point of contact for communication both internal and external to Circle</li><li>➤ Concierge will act as liaison between Intended Parents and Egg Donor Manager, Matching Manager, legal team, accounting team, insurance companies, etc.</li></ul>  |                 |
| <b>Fixed Fee Program<sup>4</sup></b>  | <b>\$12,500</b> |
| <ul style="list-style-type: none"><li>➤ Fixed price on all Surrogate and Donor fees and expenses, including reimbursements to Surrogate or Donor, travel expenses, contingencies, etc.</li><li>➤ Fixed price for all legal work, including local counsel and filing fees to establish Intended Parents' rights in the US</li><li>➤ In this program, IPs pay fixed price of \$26,000 for all maternity insurance and medical expenses, life insurance and complications insurance for retrievals and transfers</li><li>➤ IPs recommended to use unlimited IVF programs to fix cost of IVF as well (can be purchased for as low as \$35,900 with some physicians)</li></ul> |                 |

| <ul style="list-style-type: none"><li>➤ Higher reimbursement to Surrogate and Agency</li><li>➤ Higher contingency fund to pay for Surrogate expense, including maternity clothing, post-birth recovery expenses, c-section fee</li><li>➤ Flat fee of \$13,750 if part of fixed fee program</li></ul> |                            |
| <b>Estimate for Additional Egg Retrieval</b>   | <b>\$14,000</b>            |
| <ul style="list-style-type: none"><li>➤ Estimated payment to Egg Donor and travel to IVF clinic for retrieval</li><li>➤ Included in fixed fee program</li></ul>  |                            |
| <b>Estimate for Singleton Newborn Expenses</b>   | <b>\$2,000 - \$5,000</b>   |
| <ul style="list-style-type: none"><li>➤ Estimated singleton hospital bill, after insurance pays; Circle can assist with billing upon request</li></ul>   |                            |

<sup>5</sup> Other Potential Expenses include: Additional local counsel fees for birth order/adoption – \$2,000; Additional reimbursement to Surrogates for: previous experience (\$5,000+), living in high demand state (\$5,000+), matching with SPAR program (\$2,500), and/or matching with IPs who need translator (\$2,500); Expenses for translator - \$3,500; expenses for pumping payments & supplies (if IPs request) - \$2,000; Donor's local monitoring (if needed) - \$2,000
