Program Options

Surrogate Maternity Insurance for Twins³ \$5,000

- Circle will guarantee a match with a Surrogate with approved maternity insurance, thereby avoiding to use a Lloyds of London Primary plan which has a \$30,000 deductible for a twin pregnancy

Concierge Program³ \$7,500

- Program Manager will serve as Concierge, the Intended Parents' sole point of contact for communication both internal and external to Circle
- Concierge will act as liaison between Intended Parents and Matching Manager, legal team, accounting team, insurance companies, etc.

Fixed Fee Program⁴ \$10,000

- Fixed price on all Surrogate fees and expenses, including reimbursements to Surrogate, travel expenses, contingencies, etc.
- Fixed price for all legal work, including local counsel and filing fees to establish Intended Parents' rights in the US
- IPs pay fixed price of \$26,000 for all maternity insurance and medical expenses, life insurance and complications insurance for retrievals and transfers
- IPs recommended to use unlimited IVF programs to fix cost of IVF as well (can be purchased for as low as \$35,900 with some physicians)

Additional Payments Based on Circumstances⁵

Estimate for Additional Transfer or Mock Cycle	\$3,000 - \$6,000

Estimate for Twin Pregnancy	\$10,000 - \$15,500
