

Career Launcher: A Profile

Career Launcher began its journey in 1995, with a starting capital of Rs 17,000, two employees and one vision to enable individuals realize their potential and make their dreams come true. Since then, CL has established itself as a leading player in the Indian preparatory education market with a strong brand equity among the student community.

The revenue for the first year was a meager Rs 1 lakh, which rose to Rs 2.05 crores during 1998-99. In the same year, CL made a foray into careers after class XII, namely, BBA, fashion, design, law and hotel management.

Growth at CL has been a way of life - growing from teaching 100 students, without any existing center in 1996 to 42,000 enrolments across 90 centers within a span of a decade. Our revenue for the period April - March 2006 was Rs 5400 lakhs and the corresponding figure for April-Mar 2007 was Rs 7000 lakhs.

Over the past 5 years CL has grown at a CAGR of 50% and is expected to grow by more than 35-40% per annum over the next few years. The management has always focused on increasing the footprint of centers, widening their product offerings and making forays in geographies outside India.

With its strong track record, CL has embarked upon an aggressive and ambitious growth plan in its endeavor to become a globally recognized edu-corp providing a comprehensive range of education services targeted at the worldwide student community.

Currently, we are a 400+member strong organization with presence in over 120 locations spread across India, Middle East and the USA. We are a group of high achievers, bound by a passion for education. CL owes its success to its people and the manner in which the management team has succeeded in bringing together a group of young and dynamic individuals, with a flair for innovation.

A firm believer in the inorganic model of growth, we have made seven acquisitions till date that include Law School Tutorials; KITS, the market leader in CET Test-prep from Maharashtra; Lohana's Test Series for training SSC students; Arun Roy Classes for IIT-JEE Test-prep, among others. We also have a 100% owned subsidiary in the US. The initial focus here is the offline and online tutoring markets from Grade 3 till Grade 12. Subsequently, this would expand into the various test-prep options in the US market that include SAT, GRE, etc. in both online and offline modes.

Over the past decade, we have diversified from test-prep and moved into e-learning content development and on-demand online tutoring. Our most recent initiative is in the domain of mainstream education in India. Through our Career Launcher Education Infrastructure & Services (CLEIS) division, we have embarked on setting up a chain of schools under the brand name Indus World School and a chain of playschools called Ananda. The first two Ananda and Indus World Schools are already operational in Hyderabad and Indore. The first standalone Ananda began operation in Noida in 2007.

The focus on technology for superior, boundary-less education is what sets Career Launcher apart from the rest. As a technology-driven organization, we have implemented advanced ERP, e-CRM, workflow and content management solutions for managing our diverse operations.
