



# HITS Post Time Farm Education Station

**Parent Responsibility:** I understand my child's success depends upon the information and the direction provided to the Education Station. It is incumbent on me to provide the information that the Education Station needs in order to provide the educational services that will facilitate my child in fulfilling the requirements of our school at home. **THE HOME SCHOOL MUST PROVIDE US WITH THE TEXT BOOKS REQUIRED AND THE WORK TO BE COVERED. THIS INCLUDES TESTS AND QUIZZES.** I am expected to provide for my child, sufficient time to complete assigned schoolwork, to ensure daily attendance (Monday – Thursday 9-12:30) and to contact the Education Station for conferences when needed. Should our school require assignments to be sent back during the program, I will see to it that it is delivered to the Education Station. I will provide the Education Station with all the information on the application including the home school's phone, fax and address. My child's success in this program is our joint responsibility. Should I have any questions or concerns about my child's progress or ability to complete the requirements of our home school, it is up to me to contact the Education Station to address them. I will support The Education Station's methods, and contact The Education Station immediately if any concerns arise. I will be responsible for obtaining and/or making sure all academic materials are received by The Education Station as requested.

**The Education Station's Responsibility:** I understand the Education Station will provide qualified and effective educators to instruct my child according to the direction that they receive. The staff will develop a plan for my child's compliance with our school's expectations and will offer a quality experience enabling my child to meet our school's academic requirements. The Education Station will not be held responsible for the lack of progress if the student or parent fail to fulfill his or her responsibilities as outlined. Please note we do not have the resources to accommodate students with special learning needs.

**Student's Responsibility:** My student will allow The Education Station teachers to direct learning activities and schedules as they deem in the student's best interest. S/he will attend class on time and be ready to work, behave appropriately at all times, and complete work as assigned in a timely manner. My student is responsible for sharing with The Education Station staff the communications that our school may send through her/him. My child will comply with the rules and procedures set forth by the Education Station. It is also understood that a student can be removed from the program for disruptive behavior. The student will be responsible for taking their completed work package back to their home school.

**Applications:** Please be sure that the application is completely filled in. Do not send in applications without all subjects and contact information. Weeks may not be substituted/exchanged or refunded.

The sooner your application is received, the easier it will be to be prepared for the student and to be sure that there is an opening. We would appreciate all applications at least 2 weeks prior to starting, and for those attending in February and March, by February 1. We cannot guarantee a space in our facility unless we have the applications.

**Deposit:** One week non-refundable deposit required with application. The balance due will be billed to your first week's show account. **Please note there will be EXTRA FEES involved when the Education Station Staff is NOT provided with the appropriate materials from the home school such as student text books, course work, tests, etc.. THERE ARE NO REFUNDS AS SPACE IS LIMITED AND RESERVED.**
