4. SERVICE PROGRAM. Client hereby contracts for the Rooker Training Stable/Espirit Arabians \_\_\_\_\_ program as defined in the Rooker Training Stable/Espirit Arabians, to be rendered at Rooker Training Stable/Espirit Arabians, for a base fee of \$\_\_\_\_\_ per day or \$\_\_\_\_\_ per day with foal, plus such additional fees and expenses described in the Rooker Training Stable/Espirit Arabians Price List as may apply. 5. CONSIGNMENT SELLER FORM. If Client requests that Rooker Training Stable/Espirit Arabians attempt to sell the Horse while in residence for training purposes, then Client shall complete and sign a "Consignment Seller" form (provided upon request). In the event the Horse is sold while at Rooker Training Stable/Espirit Arabians or in a Rooker Training Stable/Espirit Arabians program, client shall pay Rooker Training Stable a commission equal to twenty (20%) of the sales price.
6. INSURANCE. If requested by Rooker Training Stable/Espirit Arabians Client shall provide certificates of insurance prior to acceptance of said animal for boarding, training or conditioning. This shall be full mortality insurance in the amount of Client's assessed valuation of the Horse(s). If Horse is not insured, owner's signature below on this Agreement acknowledges that owner assumes all risk of loss.
7. TRANSPORTATION. When Rooker Training Stable/Espirit Arabians is responsible for transportation, there will be a \_\_\_\_\_ cents per mile transportation fee (both ways). It is agreed that during the term of this Agreement, the risk of loss during transportation shall be assumed by the Client and Client agrees to hold Rooker Training Stable/Espirit Arabians, its officers, directors and stockholders, employees and agents harmless from such loss or injury.
8. SHOW EXPENSES. Client agrees to pay show fees according to current programs/price list which are subject to change without notice. Client agrees to pay all entry and related fees for his Horse(s) entry in a particular show. Whenever possible, Client will submit his own entry blank to show management prior to closing date of entries.
9. SHOW COMPETITION. Rooker Training Stable makes no commitment as to when, where, or if the Horse(s) will be shown.
