AFFIDAVIT FOR SEARCH WARRANT

BEFORE THE UNDERSIGNED JUDGE OF THE DISTRICT COURT

I. ROLAND E. GARRETT, being duly sworn deposes and says that he has reason to believe that, the property known as:

Spint, Attn: Custodian of Records, 6480 Sprint Parkway, Overland Park, KS 66251: account of cellular telephone number 405-436-7872

in the city of Oklahoma City, Oklahoma County, State of Oklahoma, there is now located certain property to wit:

All business records and subscriber information, in any form kept, pertaining to the accounts described above, including applications, subscriber' full names, all account names associated with the subscribers, methods of payment, telephone numbers, addresses, detailed billing records, text messages, and cell cite records

Your Affiant is a police officer employed by the city of Oklahoma City where he has worked for the past twenty three years. My current assignment is homicide investigation where I have worked for the past ten years. The following information was learned by myself or related to me by other police officers and witnesses.

On 121011, Officers of the Oklahoma City Police Department received a call to 9000 5.E. 29th Street in reference to a missing person. At the scene, officers spoke to Justin Adams who said that he had found his wife's van at the location and he wanted to attempt to get inside of it. Adams said that his wife, Jaymie was missing from this location and he hadn't spoken to her since 0045 hours on 121011.

Justin said that Jaymie left their house in the van about 2300 hours on 120911 to go the grocery store. While enroute to the store, she called him and stated that she was meeting a friend at the McDonald's located at I-40 & Douglas. He said that she texted him when she arrived at McDonald's at approximately 0045 hours on 121011. Justin advised the officer that he didn't know the name of the friend who Jaymie was to meet at McDonald's. Justin said that he found Jaymie's van at 0500 hours on 121011. The responding officer completed a report and listed Jaymie in NCIC as a missing person.

On 121111, at approximately 1115 hours, Justin Adams walked into the OCPD Santa Fe Briefing Station and informed officers that he hadn't been completely honest with officers in reference to his report on 121011. Justin said that Jaymie left home at 2200 hours on 120911 to meet a client at a motel/hotel in Norman, OK. He said that he received a text from her advising him that she was at the hotel. He said that he received a call from her at 2340 and she said that she was meeting a different client at a McDonald's in Midwest City, Justin said that he received text messages from Jaymie stating she had arrived in Midwest City and that the client didn't show up for the meeting. Justin said that the manager of Denny's told him that he saw Jaymle on store video paying for her meal at 0253 hours on 121011.

Justin advised officers that Jaymie had advertised on Craigslist as a massage therapist. He said that she had been meeting with strangers all over Oklahoma City, Moore, Norman, Del City, and Midwest City since October. He said that the ad was for a massage, but Jaymie had been engaging in sexual acts for cash. Officers impounded the van, a 2004 Chrysler Town & Country, from 9000 SE 29th on 121211.

During an interview with Inspector Cris Cunningham on 121211, Justin advised her that he and Jaymle also participated in "swinging" with people they met on Craigslist. Justin said that Jaymie took her cellular telephone and her laptop computer with her when she left the house. Justin signed a search waiver for his laptop computer and his trailer home located at 2432 County 1323 Rd, Blanchard, OK. On 121311, Sgt. E, Baxter and I searched the trailer home of Justin and Jaymie Adams. I located their marriage license and Jaymie's social security card atop a bedroom dresser. I recovered a red purse containing several sexual toys in the same bedroom.

On 121311, I requested an offline NCIC check for Jaymle Adams. The results showed that no law enforcement agency had contacted her since 120911. An exigent phone records request revealed phone records for both Justin and Jaymie. The telephone records show that during the morning of 12/10/11, the telephones of both Justin and Jaymie were relaying telephone calls from the same telephone towers. . .

i spoke to the manager of the Denny's restaurant located at 3130 S. Douglas Blvd. The manager, Saman Salekl, advised me that he didn't remember seeing a female fitting the description of Jaymie Adams during the morning hours of 121011. Officers reviewed surveillance video from the restaurant and didn't see Jaymie on the video.

On 121511, Justin agreed to be polygraphed. The test was administered by OCPD Polygraphist Lisa Butledge. Justin was found to be deceptive in reference to question "Do you know your wife's whereabouts."
