I, Detective David Freudiger of the ~~Norman Police Department~~, the Affiant, being first duly sworn, upon oath, deposes and says that I am a duly sworn and authorized peace officer for the City of Norman, County of Cleveland, State of Oklahoma and was acting in that capacity at all times mentioned herein.

On 07/25/2014, at 0239 hours, officers were dispatched to an assault involving a female victim at 759 Asp Avenue. Officer's contacted the victim, as well as several witnesses, who stated that during a verbal altercation an unknown black male punched the victim in the face knocking her unconscious. At least two of the witnesses identified the male as Joe Mixon. The victim told officers at the scene that the altercation stemmed from the use of a homosexual slur directed towards her friend by the unknown black male.

The female victim was transported to the Norman Regional Hospital where she was found to have a fractured jaw, fractured cheek bone, fractured sinus and fractured orbit which caused a hematoma on the left eye.

I went to 759 Asp and I viewed/obtained the surveillance video which showed Joe Mixon and the victim in a verbal altercation both outside and inside of the business. While in the business the female victim (5'06" tall and 130 pounds) pushed Joe Mixon (6'02" tall and 210 pounds). He then lunged at her in an aggressive manner, leading with his head and with his right fist clinched by his side. The victim reacted by slapping Joe Mixon, with an open right hand, near his left ear. He then struck her on the left side of her face with his closed right fist, knocking her into a table top and then to the ground where she laid motionless. Joe Mixon then left then scene.

Based on the foregoing facts, your Affiant prays that this honorable court issue a finding of fact that probable cause exists to believe that the crimes of **Aggravated Assault and Battery, 21 O.S. § 646 and/or Acts Resulting in Gross Injury, 21 O.S. § 22**, have occurred at 759 Asp within the City of Norman, County of Cleveland, State of Oklahoma. Further that the said offenses were committed by the Defendant, Joe Mixon, contrary to the law and against the peace and dignity of the State of Oklahoma. The Affiant swears and affirms that the above information is true and correct.

WHEREFORE, your Affiant prays this Honorable Court to find probable cause to issue a warrant for the arrest of the Defendant.


