Facts & Circumstance that support probable cause to arrest the above named person are

investigation on Jeremy Daniel Oliver who is an attorney within the State of Oklahoma with Bar Number of 22250 with a listed address of 601 South Johnson Lane, Wynnewood, Oklahoma. The investigation being conducted relates to the exploitation of child pornography. Jeremy is believed to be using two separate cell phones. I have located two cell phone numbers which are 01. 316.204.7946 and 02. 405.694.3333. These two cell phones are being utilized by Jeremy. I am aware that a [REDACTED] has made allegations on Jeremy regarding sexual favors in return for lesser attorney fees which he represents her on in criminal case CF-2012-[REDACTED]. The original allegation that [REDACTED] made was to the Norman Police Department approximately one month ago. [REDACTED] claimed that Jeremy wanted to have nude pictures and or sex with her and her two daughters. The daughters are the ages of 18 and 13. [REDACTED] has made brief statements to Sheriff Larry Rhodes and myself on 01/22/2013 concerning her allegation and the ongoing criminal investigation on Jeremy by the Norman Police Department.

On 02/03/2013, I was contacted by Deputy Jeff Paul. Deputy Paul advised that [REDACTED] had made contact with him on this date. Deputy Paul advised that [REDACTED] said that Jeremy Oliver made contact with her also on this date and advised that he wanted nude photos of [REDACTED] and her 13 year old and 17 year old daughters tonight. [REDACTED] expressed concern that Jeremy may attempt to make contact with her at her residence. [REDACTED] advised that Jeremy was making contact with her via cellular text messages.

On 02/03/2013 at approximately 1950 hours, I was advised by Deputy Zach Barby that [REDACTED] had contacted us again in regards of Jeremy sending text messages and one picture of a penis to her cell phone. Deputy Barby and Deputy Shane Rich went to [REDACTED] location. The deputies were present when text messages were being received by [REDACTED]. The deputies witnessed the request of nude pictures and Jeremy wanting to have sex with the daughters

I have reviewed the text messages that were submitted from cell phone number 405.694.3333. I have reviewed the picture that depicts a penis that sent from 405.694.3333 at approximately 1934 hours on 02/03/2013. The picture also depicts a multi colored pair of pants that is being worn by a male and desk along with a keyboard on the desk. The sender of the picture is believed to be Jeremy Oliver. The text messages are between 1853 hours and 2241 hours of 02/03/2013. The text messages sent from Jeremy Oliver request nude pictures of a 13 year old and 18 year old. The text messages sent from Jeremy Oliver request to have sex with both daughters and mother.

During the course of the criminal investigation, Jeremy states he was at his residence while sending the text messages and or picture of his penis. I know

Facts & Circumstance that support probable cause to arrest the above named person are

that a Jeremy Oliver offered \$1000.00 off for sexual favors and or nude pictures of the 18 year old daughter. I know that Jeremy Oliver offered \$500.00 off for sexual favors and or nude pictures of the 13 year old daughter. I know that sexual favors has been offered to [REDACTED] as well.

Based of the criminal intelligence received, I applied for a search warrant/court order. I was granted a court order to search the property of Jeremy Oliver by Special District Judge Misak.

On 02/04/2013 at approximately 1355 hours, the search warrant was executed at the residence of 601 South Johnson Lane. Several hundred nude/naked photographs (off DVD's, CD's, computer, cell phones, magazines, Ipad,) of females were seized along with a cam corder and a computer. I located the two cell phones that were being utilized by Jeremy (on his person). Jeremy confirmed ownership of the two cell phones. One cell phone had the same picture of a penis that was submitted to [REDACTED] cell phone. I seized a green leafy substance believed to be marihuana based off training and experience. There was a total of four firearms inside the residence.

On 02/04/2013 at approximately 1630 hours, I spoke with Jeremy. I explained to Jeremy what had transpired and what has been seized as evidence. Jeremy never denied the text messages or the marihuana. Jeremy did dispute the rifle that was reported stolen but did state the handgun was questionable. Jeremy stated "it is what it is" referring to the overall investigation.

On 02/05/2013 at approximately 0945 hours, I conducted a field test on the green leafy substance which tested positive for marihuana.
