ON Monday the 27<sup>th</sup> this month at about 11:30am officer Micheal Coleman was serving us lunch a county orderly was passing our trays to us D.O.C inmates when the officer got to my cell and opened my door I asked him why he wasn't letting us D.O.C out for our recreation time he said because he didnt want to so I stepped to the side of my cell door #48 and said well then call a Sergeant or a Lieutenant so I can speak to them he told me he aint callin no one... so I called him a dumb ass and out of no where he hit me with his sight check want its a peice of metal and plastic want that they use to do count on the doors here. he hit me in the left ear then my collar bone with it when it slipped out of his

hand he struck me with his fists 3 or so times and through me up against the wall trying to through me back in the cell at this time he did and came in the cell with me then got mad even more and walked off a ways when I recovered and stood outside my cell picking up his ward and handing it back to him he was trying to finish feeding after that when every one including me trying to get him to call some one any one at this time I was slightly bleeding on my left ear all the pod on top run then pushes the button for me calling medical "13<sup>th</sup> floor" to call for any one to come help finally S.E.R. showed up with an officer I knew "Robberson" is his name I told him that I asked for a Sgt. or Lt.

another officer I don't know  
the name of cuffed me and  
took me to the 13<sup>th</sup> floor  
where I was treated then  
the Investigator showed  
took pictures - asked if I  
wanted to press charges I

Lt. that meet me on 13<sup>th</sup> floor  
was here at this time then  
Lt. White told a officer to  
take me to 1<sup>st</sup> floor where  
I saw the Investigator and  
officer Micheal Coleman "the  
one who assaulted me" and Lt.  
White go in a room. I seen  
them all come out with  
officer Micheal Coleman in  
uniform cuffed they took him  
in the back some others he  
came back to Lockup in County  
of Orange the Investigator told  
me to get a lawyer and said  
I was ok to go. →

because they had video of  
it all and I have about 20 or  
50 witnesses... Lt. White was  
then talking to me saying he  
thanked me for not hitting his officer  
that I did the right thing that  
he seen the video he said he was  
surprised that I kept my cool I  
told him thanks for staying strong  
till I got back to my cell!

I write you all this in  
hopes of finding a good lawyer  
and to let every one know that  
I was done very wrong now  
I'm suing... I'm trying  
to get IUREN Box on my  
case! Thank you for your  
time!!!
