PROBABLE CAUSE AFFIDAVIT

The undersigned, of lawful age, being duly sworn, upon oath deposes and states as follows:

1. **Jeff Watts** is a CLEET certified Police Officer employed by the Stillwater Police Department.
2. **Jeff Watts** has conducted an investigation and based on the knowledge gained from that investigation of the circumstances, it appears as follows:

Isaiah Marin was arrested at 5200 West 6th Ave. on 10-29-2014 at 1504 hours. He was arrested because:

On 10-29-2014 at 2:46 PM Stillwater Police Dispatch received a 911 call from a cellular phone. Recruit Dispatcher Jennifer Kline answered the incoming call. Dispatcher Kline attempted to speak with the caller but there was a short delay in the caller responding to her request. The caller then stated he was at the car lot near El Vaquero. The caller then advised "I murdered someone". The caller began rambling about sacrificing and magic. Senior Dispatcher Lisa Murrell took over the phone call and began trying to obtain additional information from the caller. Dispatcher Murrell assigned two patrol officers to respond to the area of Janzen Toyota (4900 W. 6th Ave.). Dispatcher Murrell advised the responding officers of the type of call and that the 911 call was plotting near Janzen Toyota. Dispatcher Murrell asked the caller for his name. He stated his name was Isaiah Marin. Dispatcher Murrell asked Isaiah how he murdered someone. Isaiah stated "I hacked them to death with a machete". Dispatcher Murrell asked Isaiah where the person was, that he killed. Isaiah stated they were at an apartment complex.

Approximately 3 minutes into the initial call dispatch received an additional 911 call from an employee at Janzen's Toyota. The caller stated a male subject was walking toward Highway 51, AKA 6th Ave, from the front of the business. The caller stated the subject was covered in blood and carrying a machete. The caller then stated the subject was walking west on Highway 51.

Stillwater Police Officer Paul Blankinship arrived on scene and located Isaiah walking westbound on Highway 51. Isaiah began running westbound with a knife in his hand. Isaiah dropped the knife and laid on the ground. Officer Hiner assisted Officer Blankinship with detaining Isaiah at gunpoint. Stillwater Police Detective Royce Stephens handcuffed Isaiah as he was lying on the ground. Detective Stephens asked Isaiah where he was coming from. Isaiah told Detective Stephens apartment #6, behind El Vaquero. Detective Stephens, Stillwater Police Detective Adam Elliot and Stillwater Police Officer John Stanbery responded to the apartments located behind El Vaquero restaurant in an attempt to locate and render medical aid to any victims. The apartment complex is located at the corner of 5th Avenue and Oakdale Street. The officers located apartment #6. Detective Elliot observed what he believed to be blood smears on the door knob of the residence. Detectives Elliot, Stephens and Officer Stanbery entered the unlocked apartment. The officers observed blood on the stairwell which leads to the kitchen of the upstairs apartment. As the officers began the ascent up the stairs they observed the blood covered body of a male

lying on the kitchen floor at the top of the stairs. The male subject had what appeared to be multiple deep slash and stab wounds. The male subject's head was mostly severed from his body. There was a large amount of blood around the body. The officers checked the remainder of the residence for any other victims. No other victims were located and the officers immediately exited the apartment.

The scene was secured pending a search warrant.


While your affiant was at the scene, a male subject, identified as Jesse Crockett, arrived at the apartment. Jesse stated he lives at apartment #6, 416 S. Oakdale with his brother Jacob Crockett and his friend Samuel Marin. Jesse stated he received a call from Samuel at 2:50 PM. Jesse stated Samuel told him that Samuel's brother, Isaiah, had stabbed Jacob. Jesse stated he believed Samuel was fabricating the story. Jesse stated he was at an orthodontist appointment in Edmond, Oklahoma when he received the call. Jesse stated he observed the police units as he was returning to his apartment. Jesse told your affiant that Isaiah is a "religious zealot" and "heavy drug user".

Detective Sergeant Dale Higgins interviewed Samuel Marin about the homicide. Samuel told Sgt. Higgins his brother, Isaiah, was at his apartment, 416 South Oakdale #6, on this date (10-29-2014). Samuel stated he and Isaiah were playing a card game and Jacob was in the room with them. Samuel stated Isaiah had been watching YouTube videos related to his Christian beliefs and the Book of Matthew. Samuel stated while he and Isaiah were playing a card game, Isaiah picked up a large black sword and removed it from a sheath. Samuel stated Isaiah stood up and began swinging the sword around. Samuel told Isaiah to be careful or he was going to cut someone. Samuel stated Isaiah told him "I would never cut you bro". Samuel said he was holding some of the game cards in one hand and texting with his other hand. Samuel stated he heard a noise described as the sound of someone getting stabbed. He stated he looked up and saw Jacob stand up and blood gushing from his chest. Samuel stated Isaiah was still holding the sword. Samuel stated he immediately fled the apartment. He said Isaiah was following him and trying to calm him down. Samuel said Isaiah stated he would explain why he killed Jacob from letters he would write while he was in prison. Samuel stated Isaiah told him, he (Isaiah) was going to call the police. Samuel followed Isaiah back to the apartment so he could gather some things and leave. Samuel stated once he arrived back at the apartment he noticed additional stab and cut wounds to Jacob. Samuel said he gathered some clothing and his phone and departed the scene.

Samuel told Sgt. Higgins in the past Jacob and Isaiah had disagreements because Jacob and Jesse were practicing witchcraft and Isaiah had strong Christian beliefs.

Isaiah was booked into the Stillwater City Jail on one count of Murder in the 1st Degree.


