I, **Tom Lee**, the undersigned District Attorney of said County, in the name and by the authority, and on behalf of the State of Oklahoma, give information that in said County of Payne and in the State of Oklahoma, **ISAIAH ZOAR MARIN**, did then and there unlawfully, willfully, knowingly and wrongfully commit the crime(s) of:

**COUNT 1: MURDER IN THE FIRST DEGREE ~ a FELONY,** That is to say, the said defendant, on or about the **29th day of October, 2014**, in the County and State aforesaid, then and there being, with malice aforethought, and the deliberate intention to unlawfully take the life of a human being, did then and there willfully, unlawfully and feloniously, without authority of law, effect the death of Jacob Crockett, by repeatedly striking the victim with a large knife thereby inflicting certain mortal wounds in the body of said Jacob Crockett from which mortal wounds the said Jacob Crockett did languish and die on the 29<sup>th</sup> day of October, 2014, in violation of Title 21 O.S.
