NARRATIVE

BODY OF REPORT:

THE WEST CHECK POINT ALARM WENT OFF AT 1252. I RESPONDED TO THE CHECK POINT AND SPOKE WITH RP SANDERS WHO HAD A GRENADE IN THE XRAY MACHINE ON LANE #2. I LOOKED AT THE OBJECT BUT COULD NOT TELL IF IT WAS LIVE. I SPOKE WITH IP COYNE WHO OWNED THE BAG IT WAS IN. HE SAID IT WAS GIVEN TO HIM AT A PARTY IN ARKANSAS ON NOVEMBER 4, 2012. HE ADVISED IT WAS A GRENADE BUT SAID IT WAS DEAD AND WAS PAINTED.

TSA MANAGER DOUG TOWNSEND WAS ON THE PHONE WITH HIS PEOPLE. I CALLED LT. HURD WHO WAS OFF DUTY AND ADVISED HIM. HE CALLED CAPTAIN PATTY. TSA ADVISED THEY HAD NO BOMB GUYS ON DUTY TODAY. I SPOKE WITH CAPTAIN PATTY AND ADVISED HER. SHE CALLED THE MAJOR. CAPTAIN PATTY CALLED FOR AN ON DUTY LIEUTENANT. LT. TREAT #1412 CAME OUT.

TSA SHUT DOWN THE WEST CHECK POINT. MIKE CALTON WITH TSA IS A BOMB TECH. HE CAME IN AND CLEARED THE GRENADE. IT WAS NOT LIVE AND HAD A WHOLE IN THE BOTTOM. THE WEST CHECK POINT WAS REOPENED AT 1345. THE GRENADE WAS PAINTED GOLD AND TSA MIKE CALTON TOOK CONTROL OF IT. I CALLED LT. HURD AND CAPTAIN PATTY AND ADVISED THE ALL CLEAR.

IP COYNE WAS ON UNITED AIRLINES FLIGHT 5037. IP WAS VERY COOPERATIVE AND UP FRONT WITH ME AND TSA ANSWERING ALL QUESTIONS. IP SAID HE SHOULD HAVE KNOWN BETTER HE WAS RELEASED AND CLEARED TO GO.
