COUNT 1: POSSESSION OF MARIJUANA WITH INTENT TO DISTRIBUTE ~ 63 O.S. § 2-401 a  
FELONY

COUNT 2: POSSESSION OF CONTROLLED SUBSTANCE – SCHEDULE IV ~ 63 O.S. § 2-  
402(A)(1) a MISDEMEANOR

COUNT 3: UNLAWFUL POSSESSION OF DRUG PARAPHERNALIA ~ 63 O.S. § 2-405(B)(2) a  
MISDEMEANOR

STATE OF OKLAHOMA, COUNTY OF PAYNE:

I, Robert L. Hudson, the undersigned District Attorney of said County, in the name and by the authority, and on behalf of the State of Oklahoma, give information that in said County of Payne and in the State of Oklahoma, **BO MICHAEL BOWLING**, did then and there unlawfully, willfully, knowingly and wrongfully commit the crime(s) of:

COUNT 1 63 O.S. § 2-401 ~ POSSESSION OF MARIJUANA WITH INTENT TO DISTRIBUTE a  
FELONY, on or about the 8th day of February, 2009, by knowingly possessing with the intent to distribute, MARIJUANA, a controlled dangerous substance in Schedule I of the Uniform Controlled Dangerous Substances Act of Oklahoma.

This crime is punishable by imprisonment for 2 years - life or a fine of up to \$20,000, or both.

COUNT 2 63 O.S. § 2-402(A)(1) ~ POSSESSION OF CONTROLLED SUBSTANCE – SCHEDULE  
IV a MISDEMEANOR, on or about the 8th day of February, 2009, by knowingly and intentionally having in defendant's possession under defendant's control ALPRAZOLAM said drug being classified as a controlled dangerous substance in Schedule IV of the Uniform Controlled Dangerous Substances Act of Oklahoma

This crime is punishable by imprisonment up to 1 year.

COUNT 3 63 O.S. § 2-405 ~ UNLAWFUL POSSESSION OF DRUG PARAPHERNALIA(B)(2) a  
MISDEMEANOR, on or about the 8th day of February, 2009, by possessing digital scales and a
