STATE OF OKLAHOMA, COUNTY OF GARVIN:

I, Greg Mashburn, the undersigned District Attorney of said County, in the name and by the authority, and on behalf of the State of Oklahoma, give information that in said County of Garvin and in the State of Oklahoma, JEREMY DANIEL OLIVER, did then and there unlawfully, willfully, knowingly and wrongfully commit the following crime(s):

COUNT 1: SOLICITING SEXUAL CONDUCT OR COMMUNICATION WITH MINOR BY USE OF TECHNOLOGY — a FELONY, on or about the 3rd day of February, 2013, by facilitating, encouraging, offering or soliciting sexual conduct or engaging in communication for sexual or prurient interest with S.B., a minor, by sending text messages to S.B. offering money for sexual contact with her minor child: to wit a female aged 13 years contrary to the form of the Statutes in such cases made and provided and against the peace and dignity of the State of Oklahoma.

This crime is punishable by imprisonment up to 10 years or a fine up to \$10,000, or both.

COUNT 2: OBSCENE MATERIAL - PUBLISH/DISTRIBUTE/PARTICIPATE ~ a FELONY, on or about the 3rd day of February, 2013, by sending a picture of his erect penis through means of an electronic device to S.B., contrary to the form of the Statutes in such cases made and provided and against the peace and dignity of the State of Oklahoma.

This crime is punishable by imprisonment up to 10 years or a fine up to \$10,000, or both.

COUNT 3: POSSESSION OF CONTROLLED DANGEROUS SUBSTANCE — a MISDEMEANOR, on or about the 3rd day of February, 2013, by knowingly and intentionally having in defendant's possession under defendant's control Marijuana said drug being classified as a

controlled dangerous substance in Schedule I of the Uniform Controlled Dangerous Substances Act of Oklahoma, contrary to the form of the Statutes In such cases made and provided and against the peace and dignity of the State of Oklahoma.

This crime is punishable by imprisonment up to 1 year and a fine of up to \$1000.
