STATE OF OKLAHOMA, COUNTY OF PAYNE:

I, **Robert L. Hudson**, the undersigned District Attorney of said County, in the name and by the authority, and on behalf of the State of Oklahoma, give information that in said County of Payne and in the State of Oklahoma, **DARRELL WILLIAMS**, did then and there unlawfully, willfully, knowingly and wrongfully commit the crime(s) of:

**COUNT 1: RAPE BY INSTRUMENTATION, a FELONY, defendant on or between the 12th day of December, 2010, and the 13th day of December, 2010, did penetrate the vagina of victim with an inanimate object, to-wit: defendant's finger, without victim's consent, defendant forcefully holding victim against her will.**

**This crime is punishable by imprisonment of 1-15 years.**

**COUNT 2: SEXUAL BATTERY, a FELONY, defendant on or between the 12th day of December, 2010. and the 13th day of December, 2010, did knowingly commit a sexual battery on the person of , defendant intentionally touching, mauling or feeling the body of , including her breasts and buttocks in a lewd and lascivious manner and without consent of defendant also forcing 's hand on defendant's erect penis.**

**This crime is punishable by imprisonment for up to 10 years.**

**COUNT 3: RAPE BY INSTRUMENTATION, a FELONY, defendant on or between the 12th day of December, 2010, and the 13th day of December, 2010, did penetrate the vagina of victim , with an inanimate object, to-wit: defendant's finger, without victim's consent, defendant forcefully holding victim against her will while doing so in a basement located at 423 S. Lewis, Stillwater, Oklahoma.**

**This crime is punishable by imprisonment of 1-15 years.**

COUNT 4: RAPE BY INSTRUMENTATION, a FELONY, defendant on or between the 12th day of December, 2010, and the 13th day of December, 2010, did penetrate the vagina of victim with an inanimate object, to-wit: defendant's finger, without victim's consent, in the yard of a residence located at 423 S. Lewis, Stillwater, Oklahoma.

This crime is punishable by imprisonment of 1-15 years.
