Your affiant, Detective David Jaebson #096770CPD, DEPUTY, being duly sworn deposes and says that at the following location:

11000 S. Bryant Ave., Oklahoma City, Cleveland County, Oklahoma. This is a single story residence, with a brown composition roof, brown rock walls, and a brown and white carport in front of the garage. The front door faces the west. There are several vehicles parked in front and in back of the residence. This residence is north off a private drive (Sunny Slope Drive) which runs east off of S. Bryant drive.

In the city of Oklahoma City, Cleveland County, State of Oklahoma, there is now located certain property to wit:

Blood, items having blood on them, body fluids and secretions, hair fibers, fingernails, fingerprints, palm prints, shoes, articles of clothing, clothing fibers, and other garments; Seat cushions and/or coverings of the furniture, and other items which might contain traces of any of the preceding articles.

Firearms including but not limited to handguns, projectiles, ammunition, bullet casings and jackets, bullet fragments, cartridge fragments, and other items which might contain traces of any of the preceding articles.

Edged weapons including but not limited to knives, razors, axes, hatchets, improvised knives, or other items that could be employed as edged weapons, and other items which might contain traces of any of the preceding articles.

Blunt weapons including but not limited to clubs, bats, pipes, tools, brass knuckles, or other items that could be employed as blunt weapons, and other items which might contain traces of any of the preceding articles.

And articles of personal property tending to establish the identity of the person or persons in control or possession of the vehicle; to include, but not limited to, receipts, papers, personal letters and notes, vehicle registration, credit card receipts, repair bills, keys, photographs, and articles of clothing:

Affidavit of Search Warrant

Facts tending to establish the foregoing grounds for issuance of a search warrant are as follows:

On 11/09/12, OCCPD officers met with Scott Kuper at 11000 S. Bryant in reference to checking the welfare of his elderly aunt, Janet Hume (77 yoa). Kuper told officers that Janet Hume lives at this residence with her schizophrenic son Gerald Hume. Kuper and other family members have been attempting to make contact with Janet since 11/08/12, and were concerned for her welfare. None of the family has spoken to Janet since 11/04/12.

Kuper went to the residence on 11/09/12, and found that Janet's car was in the driveway. Kuper knocked on the door, but no one answered. After a short period of time, Gerald came out of the house and told Kuper that Janet had left with friends and would be back in two days. Gerald would not allow Kuper inside the house, so he called police at that time. The responding officer knocked on the door to check on Janet's welfare. Gerald answered from behind the door that "everything is OK", and "Two days?". Gerald refused to open the door or speak to the officer further. Kuper told the officer that it was strange for Janet to have left with friends, and that he didn't believe Gerald was telling the truth. It was decided that a police report would be made, and that officers would continue to try and check the welfare of Janet.

On 11/11/12, at approximately 1149 hours, Kuper called police to the residence again because none of the family had been able to contact Janet. The family was very concerned for her welfare at this point because it is unusual for her to not talk with family members. When officers arrived, Janet's vehicle was still in the driveway of her house. They attempted to make contact with Janet or Gerald but no one would answer the door. Officers observed several gas cans with electrical wire coming out of them in the backyard of the house. They also located PVC pipe in the front drive with electrical wires going to the cigarette lighter of one of the vehicles parked in the drive. Officers were concerned the items they had located could be some sort of explosive device, so members of the OCCPD Bomb Squad came to the scene to check them. The Bomb Squad made the devices safe, and made reports on the devices. Kuper told the officers that he did have a key but family members were not allowed inside the house without permission. Officers could not locate Janet or Gerald at that time.

Later that day (11/11/12), at approximately 1418 hours, officers again attempted to check the welfare of Janet or Gerald but no one came to the door. Kuper told officers that

Gerald is a known schizophrenic, hears voices, and requires treatment. Kuper spoke to the people at Janet's work place and found that she had not been to work since the 11/05/12. Janet left her work at 11/05/12 to go to her house, but never returned to work that day, or since that day. Janet's cell phone has been turned off since that day. Janet's vehicle was still in the driveway of her residence.

On 11/12/12, officers returned to the house to check on the welfare of Janet. Officers knocked on the door and Gerald eventually came to the door. Gerald told the officers that he needed to put a computer on the front porch, and he would then explain the situation to them. Officers asked to speak to Janet, and Gerald told them she was there but he would not allow them to talk to her. Gerald closed the door, and refused to come back to the door.

On 11/13/12, OCPD detectives with the Missing Person Unit, and Homicide Unit conducted interviews with Janet Hume's family members. The family members are concerned that Janet is either deceased in her house or in need of medical care and Gerald is not allowing anyone to enter the house. It is possible that Gerald has done something to Janet because of his mental condition. Kuper told detectives that he has removed several rifles from Janet's house because of Gerald's mental condition. Kuper does think it is possible there are more weapons in the house, and that Gerald does pose a threat to officers. Detectives spoke to a family friend on 11/13/12, and were told that Janet Hume told her that Gerald has recently bought several guns.

Detectives found in OCPD records that in 08/26/09, Gerald was in involved in an incident in which he boarded up the windows of the residence, and shot at vehicles as they drove by. He has also had several mental health interventions with OCPD.

Based on the listed information and facts, your affiant is requesting a search warrant be issued to check the welfare of Janet Hume, and for the above residence, for the purpose of processing the scene of a possible crime, being MURDER, as set forth in Chapter 24, Title 22 of the Oklahoma Statutes.

Your affiant requests that Immediate Entry be authorized for the safety and protection of officers, suspects and potential bystanders.


