BODY OF REPORT:

ON 2/10/09 SGT. WHITLOCK, #1428 AND I WERE WORKING MORALS VIOLATIONS IN THE RESIDENTIAL NEIGHBORHOOD AROUND 3300 BLOCK OF S. ROBINSON. THIS AREA IS KNOWN TO HAVE A HIGH INCIDENCE OF PROSTITUTION AND ILLEGAL DRUG ACTIVITY. SGT. WHITLOCK AND I WERE NORTHBOUND IN THE 3400 BLOCK OF S. ROBINSON AND OBSERVED THE ABOVE LISTED GOLD CHEVY MALIBU PARKED AT THE PAY PHONE AT THE SOUTHWEST CORNER OF THE INTERSECTION OF SW. 33RD AND ROBINSON. THIS IS A FREQUENT LOCATION FOR PROSTITUTES WILL LOITER AND PICK UP JOHNS.

AT APPROXIMATELY 2026 HOURS, SGT. WHITLOCK AND I OBSERVED THE MALIBU FLASHING IT'S LIGHTS AT CARS PASSING BY. AS WE CIRCLED THE BLOCK WE OBSERVED THE ABOVE LISTED WHITE CHEVY PICKUP PULL UP NEXT TO HER AND PARK. AFTER APPROXIMATELY 30 SECONDS, BOTH VEHICLES PULLED OUT TOGETHER AND PROCEEDED NORTHBOUND ON ROBINSON. WE SUSPECTED A PROSTITUTION DEAL HAD BEEN ARRANGED AND FOLLOWED THE VEHICLES IN OUR UNMARKED CITY VEHICLE.

WE FOLLOWED THE VEHICLE TO A PARK ON THE NORTH SIDE OF THE ROAD NEAR SW. 17TH AND SANTA FE. BOTH VEHICLES PARKED NEXT TO EACH OTHER. THE DRIVER AND ONLY OCCUPANT OF THE PICKUP, IS LATER IDENTIFIED AS WI-JOHNSON, GOT OUT OF THE PICKUP AND GOT INTO THE GOLD MALIBU WITH A WHITE FEMALE, LATER IDENTIFIED AS AR-SMITH. AFTER SEVERAL MINUTES, SGT. WHITLOCK AND I PULLED UP BEHIND THE VEHICLES AND PARKED, PRIOR TO WALKING UP TO THE OCCUPANTS OF THE MALIBU.

SGT. WHITLOCK OBSERVED AR'S BLOUSE WAS OPEN AS SHE WAS SEATED IN THE DRIVER'S SEAT. AS I APPROACHED THE FRONT SEAT PASSENGER, I OBSERVED WI-JOHNSON SHUFFLING IN THE FRONT SEAT AS HE ATTEMPTED TO PULL HIS PANTS BACK UP. UPON INITIAL CONTACT, AR-SMITH DID NOT HAVE ANY ID ON HER. SHE WAS ASKED TO STEP OUT OF THE VEHICLE SO WE COULD IDENTIFY HER.

WI-JOHNSON IDENTIFIED HIMSELF WITH AN OKLAHOMA DRIVER'S LICENSE. HE ADMITTED HE AND WIFE ARE HAVING MARTIAL PROBLEMS AND HE WAS HAVING SEXUAL FRUSTRATIONS. HE WORKS AT THE FRITO-LAY AND KNOWS HE COULD PICK UP A PROSTITUTE ON S. ROBINSON. HE SAID HE DROVE DOWN S. ROBINSON AND OBSERVED AR-SMITH FLASH HER LIGHTS. HE TOLD ME HE PULLED OVER NEXT TO HER AND STOPPED AND SHE ASKED HIM IF HE WAS LOOKING FOR SOME COMPANY. HE SAID HE WAS AND AR ASKED HIM IF HE HAD ANY MONEY. WI SAID HE DID NOT, BUT AR AGREED TO GIVE HIM A "BLOW JOB" MEANING ORAL SEX, FOR A BOX OF CHIPS. WI POINTED OUT A CASE OF FRITO-LAY CHIPS IN THE BACK SEAT OF AR'S CAR WHICH HE TOLD ME WAS WORTH APPROXIMATELY \$30.

IT SHOULD BE NOTED I OBSERVED AN ADDITIONAL CASE OF CHIPS, FRITO-LAY IN THE FRONT SEAT OF WI'S PICKUP.

UPON INITIAL CONTACT WITH AR, SHE ADMITTED TO SGT. WHITLOCK SHE HAS A PRIOR HISTORY OF PROSTITUTION.

SGT. WHITLOCK READ THE MIRANDA WARNING TO AR AND WHEN ASKED IF SHE UNDERSTOOD HER RIGHTS SHE REPLIED, "YES." WHEN ASKED IF SHE WANTED TO MAKE A STATEMENT, AR STATED, "YES." SGT. WHITLOCK ASKED AR TO CONTINUE ON WITH THE STATEMENT SHE WAS MAKING BEFORE SHE WAS MIRANDIZED.
