I, Cris Cunningham, the Affiant, being first duly sworn, upon oath, depose and say:

That the facts known to the Affiant which establish probable cause to believe;

1. a criminal offense was committed,
2. the offense was committed by the above named person, are the following.

I, Inv. C. Cunningham, the Affiant, being first duly sworn, upon oath, depose and say:

I have been an Oklahoma City Police Officer for nineteen years. I am presently assigned to the Homicide Unit where I have worked since November 2004. I have received specialized training in the investigation of serious violent crimes. I have personal knowledge of the facts and circumstances hereinafter related, as a result of my own investigative efforts and those of fellow officers who have related their findings to me.

That the facts known to the Affiant which establish probable cause to believe that a criminal offense was committed, and that the offense was committed by the above named person, are the following:

On 121011, Officers of the Oklahoma City Police Department received a call to 9000 S.E. 29th Street in reference to a missing person. At the scene, officers spoke to Justin Adams who said that he had found his wife's van at the location and he wanted to attempt to get inside of it. Adams said that his wife, Jaymie, was missing from this location and he hadn't spoken to her since 0045 hours on 121011.

Homicide investigators interviewed Justin Adams and other witnesses in the days following the report. The investigation included cell phone records and interviews of witnesses.

Investigators obtained information from various sources including email accounts and the internet. During interviews Justin Adams provided information which investigators determined was not consistent with the factual information related to the investigation.

Your affiant located information, from law enforcement agencies and other non law enforcement witnesses, which indicated the relationship between Justin and Jaymie Adams was physically violent. Jaymie Adams reported being assaulted by Justin, during the month prior to her disappearance.

On 01/26/12, investigators presented the information from the investigation to ADA Jennifer Chance. She authorized filing two (2) counts of Murder against Justin Adams, for the death of Jaymie Adams and her unborn child.

Based upon the information provided, your affiant believes there is probable cause to arrest the above listed defendant for the charge Murder in the First Degree, 21-701.A, two (2) counts.
