AFFIDAVIT

The undersigned upon oath deposes and states as follows, to-wit: Your affiant, Jeff Watts, is a C.L.E.T certified Stillwater Police Officer. I have been employed by the Stillwater Police Department, in the capacity of police officer, since September of 1991. I have been assigned to the Criminal Investigations Division since August of 2005. I currently hold the rank of Detective Sergeant. I have received specific training in conducting investigations into child abuse, child sexual abuse, rape, robbery, homicide, assaults and arson investigation.

On 12-18-2012 your affiant met with JOHN DOE #1, A 22 year old male. JOHN DOE #1 told your affiant on 08-11-2012 he was a guest at Nathan Cochran's residence located at 1008 West Connell. JOHN DOE #1 stated at approximately 0344 hours he laid down on a sofa bed in the living room of the residence. JOHN DOE #1 told you affiant Nathan had offered the sofa bed to him earlier in the night. JOHN DOE #1 stated he thought he we would be the only person sleeping on the sofa bed but when he got the room where the bed was located Nathan was already asleep on one side of the bed. JOHN DOE #1 said he laid down on the opposite side of the bed and he and Nathan had their backs to one another. JOHN DOE #1 told your affiant shortly after lying down on the bed Nathan began rubbing his hand up and down JOHN DOE #1's leg and back. JOHN DOE #1 stated Nathan was snoring and he thought he was moving around in his sleep so he moved further away from Nathan. JOHN DOE #1 said Nathan moved toward him, continued rub his leg and back and tried to put his hand inside JOHN DOE #1's pants. JOHN DOE #1 stated he pushed Nathan hand away. JOHN DOE #1 said he received a text message from Nathan while they were in bed and Nathan indicated he wanted to know what it was like to be with male. JOHN DOE #1 stated he told Nathan to stop touching him. JOHN DOE #1 stated Nathan continued to touch him even after he told him to stop. JOHN DOE #1 stated he got out of the bed and departed the residence.

The residence where the crime occurred is located in the city limits of Stillwater, Payne County, Oklahoma.

Based on this information, the undersigned prays that this Honorable Court issue a finding of fact that probable cause exists to believe that a crime has been committed and that there is probably cause to believe the defendant(s) named above committed that crime.
