Subject: Interview of Charles Perkins B/M 05/12/42 - Security Guard at Reliable Pharmacy

On 07/09/09, I received a phone message from Doug Sizemore, who is the owner of the Reliable Pharmacy. He requested I call him in reference to Charles Perkins (security guard) locating a shell casing in the pharmacy. I was on my lays off, and passed this information onto Det. Porter who went to the pharmacy on 07/10/09. He spoke to Perkins at the store, and took custody of a shell casing from him at that time. For further information reference that interview, see Det. Porter's supplemental report. This information was passed on to the ).A.'s office.

On 07/15/09, at approximately 1021 hours, Charles Perkins came to the nomicide office to be interviewed further, reference finding the shell casing at the pharmacy. The following is a summary of this interview. This interview vas video recorded. For further information see DVD. Det. Porter was present luring this interview.

I told Perkins who I was, and that I was conducting the follow up investigation into this incident. Since I was not present during the first interview with Perkins, I asked him what had happened. Perkins said he 'arbitrarily" looked under the bookshelf, and found a shell casing. Perkins presented a drawing he had made of the pharmacy, in which he had marked the location where he found the shell casing. I made a copy of this drawing, and nad Perkins sign it. Det. Porter and myself also signed the copy in red ink. This copy will be given to the D.A.'s office to be placed in the "Black Book" case file.

Perkins explained to me that he located the shell casing under a bookshelf, in Sizemore's (owner) office. This room in located next to the main pharmacy rea. Perkins said he also looked under a refrigerator located in that area. 'erkins showed me a drawing he had made of the height of the bookshelf ( approximately 1" - 2") from the floor in which the shell casing was found inder. Perkins said a vacuum cleaner would not have been able to get under that bookshelf.

Perkins said he had watched the film of the incident, and noticed the ispect had moved the slide of the gun every time he fired it. I asked Perkins he thought the subject was firing the gun. Perkins said "O yeah". I asked im why he thought this subject was firing his gun. Perkins said it was because had to "cock it" first, unless the subject was having a lot of misfires. I asked then said that the police "dug two bullets out of the wall". I asked within the had told him that information. Perkins said "I know it for a fact". Told Perkins that both of us were at the pharmacy the night of the incident, and that no bullets were located, or removed from any walls of the pharmacy. I wish said that he was told that the police took two bullets out of the wall, and that the news media took pictures of them. I told Perkins that information as not true, there was not any bullets dug out of the wall, or bullet holes in the wall. I told Perkins that's why I couldn't figure out where this casing had ome from. Perkins then said that when a shell casing came out of the gun, it it the carpet in the office area and bounced, or someone could have cidentally kicked it up under the shelf.

Det. Porter asked Perkins why he had been looking for a shell casing in the irst place. Perkins said that Ersland (Jerome) talked about it every day. Island would say, "What really gets me is that they found all of my shell asings, but they never found the other guys". Perkins made the comment that he idn't understand why they hadn't shot each other at that close range. Perkins nen said that it was very dirty under the bookshelf, and it didn't look like had been cleaned in a long time.

Perkins said he still felt that an officer had accidentally kicked it up iderneath the bookshelf. The casing was not very far back, but right at the cont edge (motioned approximately 1' back). Perkins said when he located the iell casing; he called Ersland back to the office and told him he found it. Erkins opened his baton, and used it to push the casing out from under the bookcase. Perkins said that Ersland "jumped for joy". It was Monday, July 6th ien he found the shell casing. Perkins said he took a pen from his pocket and toked up the casing with the pen. Ersland told Perkins he needed to place it is a bag, but Perkins told Ersland to get a pill bottle. Ersland got a pill ottle and Perkins placed it in the bottle. Perkins said when he went home that ight; he made the labels that he later put on the pill bottle.

Tuesday (July 7th) Ersland and Perkins were afraid that someone would throw vay the pill bottle with the shell casing that they put in the store vault. Erkins said he then hid the pill bottle three rooms back, and he was the only le that knew where it was hidden. Perkins said that no one else knew that they led found the casing, or that they had hidden it at that point. I asked Perkins ly he did not call the police about the shell casing. Perkins said that resland didn't want to give it to the police, because he didn't trust the police with it. I asked Perkins "Wouldn't that have helped his case?" Perkins lid, "It depends on what happened to the shell casing, but yeah".

I told Perkins that Sizemore had called me about the casing (July 9th) and sked him when he told Sizemore about the casing. Perkins said they tried for vo days to get a hold of Ersland's attorney. When they couldn't, they weren't

sure what to do with the casing. Ersland told Perkins that he didn't want the police to have the casing. Ersland wanted to ask his attorney what to do with it.

I asked Perkins why Ersland was so happy to find the casing. Perkins said he thought it would help his case. Ersland told Perkins "That's the missing link". I asked Perkins if Ersland had been talking about finding a shell casing, and Perkins said "Every day". Ersland told Perkins he couldn't figure out why they didn't find his (SU's) shell casings, and only found his (Ersland). Perkins then said "I don't know why he (Ersland) would tell me they dug two bullets out of the wall if it wasn't true". I told Perkins that Ersland told us that the SU's had revolvers. Perkins said, "That's not true". Perkins said that he had looked at the film last night, and that the gun the SU had was not a revolver. I again told him that Ersland told me that the SU's had revolvers. Perkins then said, "He's way off". Perkins said you don't have to "pull" a revolver to fire it.

I asked Perkins if he and Ersland had been talking about finding a casing in the pharmacy. Perkins said they didn't talk about it, but that Ersland would mention it every day. Perkins felt he hadn't put much effort into looking for the casing ("glancing around both rooms"), but that day (July 6th) he went ahead and looked under the bookcase. Perkins said he didn't expect to find it there. He also looked under the refrigerator and behind a display case that day. Ersland also told Perkins that the police had dug two bullets out of the north wall.

Perkins said once he told Sizemore about the casing, that's when Sizemore called me. I asked Perkins if he thought it was odd that Ersland didn't want to call the police about finding the shell casing. Perkins said the first thing he said to Ersland was "Lets call the police", but Ersland didn't want to call the police because he didn't trust the police with the shell casing. Ersland told Perkins, "They might lose it". Perkins told Ersland that anybody that they give it to would have to give to the police, but Ersland wanted to call his attorney about it. I asked Perkins if he or Ersland decided to tell Sizemore. Perkins said he didn't remember. Perkins then said that he thought that Sizemore already knew because Ersland had told Sizemore's wife about finding the shell casing.

Perkins said that Ersland had told him the subject on the floor was getting up when he shot him. Perkins had seen the video and he felt the no one could have seen what this subject was doing because the camera can't see that area.

I asked Perkins how he thought the shell casing got under the bookcase. Perkins said, "I have no idea". I explained to him that the whole pharmacy had been searched, photographed, and processed by CSI officers that night. I explained we just wanted to know how this shell casing was located now. Perkins asked if anyone looked under the bookcase the night of this incident. I told him that CSI officers had been in that room looking for evidence. Perkins then said, "Well maybe it was put under there on purpose". I told Perkins that was what we were trying to figure out. Perkins said " Maybe he (Ersland) put it under there". Ersland talked to him about shell casings every day. I asked

erkins if he thought Ersland put the shell casing under the bookcase for him o find. Perkins said "Its humanly possible".

I told Perkins that we were going to test the shell casing for DNA, and sked him if he would allow us to get a BUCCAL SWAB from him. Perkins said he ever touched the shell casing and his DNA would not be on it, but agreed to be wabbed.

I told Perkins I felt he was trying to help Ersland out in this case, but hat I didn't want him to get in trouble for doing something illegal. Perkins aid he did not want to get into trouble either. Perkins told me he had been ninking about this case, and had experience in investigations with the spartment of Defense. Perkins said he didn't want to see Ersland get "hung", it he had been thinking about how Ersland was always talking about finding a nell casing, and then he found one. Perkins said he didn't want to get nvolved in this. I told Perkins that if Ersland did put this under the pokcase, we needed to clear it up now and move on with the investigation. I sked him again if he thought that Ersland put the shell casing under the pokcase. Perkins said "I don't want to say that I think he put it there, and hen have the recording be put out that I said that". Perkins was aware he was sing recorded. I also told him he was being recorded. Perkins said he could be give me any further information about the shell casing. Perkins said he ped Ersland didn't put the shell casing under the bookcase, but everyday reland would talk about finding the other subject's shell casings. Ersland ever told him where to look; he just looked there, and found it.

I asked Perkins how Ersland felt about this incident. Perkins said Ersland alt like he was getting "shafted". Perkins told Ersland that he should not eve gone back and got the second gun and "pumped" 5 more rounds into him (SU). Erkins felt that would be the part that would get him.

I asked Perkins what Sizemore had said about his incident. He said Sizemore pesn't talk about it; he just wants Ersland to calm down about it. Ersland is ways talking to the employees about it. Ersland talks to Perkins every day pout the incident.

Det. Porter completed the BUCCAL Swab kit on Perkins, sealed the kit, and ooked into the property room (serology). Perkins signed the SEARCH WAVIER.

Perkins told Det. Porter that he did have one request; he wanted to know here the shell casing came from. Perkins was now concerned, because he was the he that found it, and didn't want to get in trouble. Perkins said he didn't hink the SU's gun was a .22 caliber like the casing found. Ersland told rkins that once he found the casing that was the first night he had been able sleep. Perkins told Det. Porter that Ersland could have been "feeding him" hat.

Perkins continued to ask us about looking under the bookcase that night, and cating bullets in the back wall. Det. Porter told him that no bullets were cated in the north wall. Perkins said, "That's incredible". Perkins said he tched CSI shows and felt if the CSI guys had been there that night, he should

I asked Perkins if we could meet him at the pharmacy at some point and get some pictures of the exact location he found the shell casing. Perkins agreed, and said he would be at work on Friday. Perkins agreed to meet Det. Porter there, for further information see supplemental reports.

After making copies of Perkins drawing, we gave him our cards. I then escorted him to the front desk. It seemed to me that after talking to us, Perkins was now concerned that the shell casing had been put there on purpose by Ersland. Perkins didn't want to get in trouble for finding it.
