1 : ON OR ABOUT THE 19TH DAY OF MAY, 2009, A.D., THE CRIME OF MURDER IN THE FIRST  
DEGREE WAS FELONIOUSLY COMMITTED IN OKLAHOMA COUNTY, OKLAHOMA, BY  
JEROME JAY ERSLAND, WHO WILLFULLY, UNLAWFULLY, AND WITH MALICE  
AFORETHOUGHT, KILLED ANTWUN PARKER BY SHOOTING HIM WITH A PISTOL WHILE  
ANTWUN PARKER WAS UNARMED, INCAPACITATED AND LYING ON HIS BACK,  
INFLECTING MORTAL WOUNDS, WHICH CAUSED HIS DEATH ON THE 19TH DAY OF MAY,  
2009, CONTRARY TO THE PROVISIONS OF SECTION 701.7 OF TITLE 21 OF THE  
OKLAHOMA STATUTES, AND AGAINST THE PEACE AND DIGNITY OF THE STATE OF  
OKLAHOMA.

**AFFIDAVIT OF  
PROBABLE CAUSE**

Your affiant, Detective David Jacobson (OCPD/#0967), being first duly sworn upon oath, depose and state as follows:

I have been a police officer employed by the City of Oklahoma City, Oklahoma since 1992. I am currently a Detective assigned to the Homicide Unit. On 05/19/09, I was assigned a case to investigate an incident that occurred on that date.

On 05/19/09, at approximately 1740 hours, officers of the Oklahoma City Police Department were dispatched to the Reliable Pharmacy, 5900 S. Penn., OKC, in reference to a armed robbery. When officers arrived at the scene, they found that two masked subjects had attempted to rob the store. One of the subjects was armed with a pistol, and demanded money, and drugs from the employees. Two of the employees (females) ran to the back room, and called 911.

Jerome Ersland, the pharmacist for the store, has a concealed carry permit, and had two pistols inside the store with him. Ersland was able to get to a pistol, and shot at the subjects robbing the store. One of these subjects (later identified as Antwun Parker) was hit by Ersland's shots, and fell to the ground. Ersland continued to fire at the second subject (armed with a pistol), but this subject was able to run out of the store, and has not been identified or caught at this time. Officers found Parkers body lying on the floor of the pharmacy, with numerous gunshot wounds.

During the scene investigation, it was found that there was not a pistol located on, or near Parkers body. Parker had been shot once in the head, and five times in the stomach area. There was no evidence located (bullet defects/shell casings other than from Ersland's pistols) that showed the armed subject fired any rounds at Ersland, or inside the store. The store has video surveillance, and a video of the incident was recovered.

DEJ

The video of the incident shows that the two masked subjects enter the store, and that the unidentified subject is armed with an automatic pistol, and points his weapon at the employees. Ersland retrieves a pistol, and fires it at the subjects. The second subject (Parker) enters the store behind the first, and while attempting to put on his mask, is shot by Ersland, and drops to the floor, out of the camera's view. Ersland continues to shoot at the second unidentified subject, who runs out the front door. Ersland runs by Parker who is on the ground, but does not seem concerned about him being a threat. Ersland chases the unidentified subject out of the store, but then comes back in the store a short time later.

The video shows that Ersland comes back into the store, and walks directly in front of the area where Parker is lying. Ersland shows no concern for his safety as he walks by Parker, and turns his back to Parker as he walks behind the pharmacy counter. Ersland is then seen to put the pistol he is carrying on the counter, and retrieve a second pistol from a drawer. Ersland takes this pistol, and walks up to the area where Parker is lying on the ground. Ersland is seen to stand near Parker (at his feet), point the pistol at him, and then fire it numerous times at the area Parker is lying. Ersland then returns to the counter area, and is seen on the phone. The video does not show Parker ever get back on his feet after he is shot the first time.

Ersland was brought to the homicide office to be interviewed by detectives. Ersland's account of the incident does not match the video, or the evidence collected at the scene. Ersland also gave several news media statements that do not match the video, or the evidence.

The Medical Examiner performed an autopsy on Parker's body, and found that Parker had been shot in the head, but was still alive when he was shot in the stomach area, and died from these injuries.


