Synopsis of arrest to include all elements of the charged crime:

On 9-25-09 I received a call-out in reference to a fourteen-year-old child, later identified as VICTIM B.M. (age 14), that had been physically abused for the past four years by his biological mother, later identified as DEFENDANT LARHONDA MCCALL (age 37). B.M. also advised that he was abused by DEFENDANT STEVE HAMILTON.

B.M. disclosed LARHONDA had beat him with a broom stick, electrical chord, belt and tied him up with twine over the past four years. B.M. disclosed LARHONDA would lock him in a closet and not feed him for several days at a time. B.M. had visible scars on his back, arms, neck, legs and chest. B.M. advised STEVE was abusive as well. B.M. disclosed STEVE hit him in the head with a car jack handle. STEVE knew of the abuse going on by LARHONDA as well.

On 9-26-09 at approximately 0343 hours Det. R. Gregory #1332 and I interviewed LARHONDA. LARHONDA admitted to striking B.M. with a belt numerous times on his chest, back and legs over the past three years. LARHONDA admitted she struck B.M. with a ruler and hit B.M.'s hands with a broom handle. LARHONDA admitted to choking B.M. on one occasion because he was choking her first. LARHONDA stated B.M. moved in with her when they lived at 1604 S. Phillips, Oklahoma City, Oklahoma County. LARHONDA stated in October of 2007 they moved to 301 NW 82, Oklahoma City, Oklahoma County. In January of 2009 LARHONDA moved to 5613 S. Youngs, Oklahoma City, Oklahoma County. LARHONDA moved in to 2324 NE Grand Circle, Oklahoma City, Oklahoma County, about a month ago.

On 9-26-09 at approximately at 1720 hours, Det. Gregory read STEVE his Miranda Advice of Rights. After acknowledging his rights he signed the waiver. STEVE advised that B.M. has been abused by LARHONDA for the last two years. Steve witnessed LARHONDA physically abuse B.M. Steve advised he took over caring for B.M. from June 2007 to December 2007. STEVE advised this was when he started to hit B.M. STEVE admitted he hit B.M. on the back, legs, and arms with a belt and also a wire cable. B.M. went back to live with LARHONDA after Dec. 2007. Steve continued to help LARHONDA care for B.M. STEVE admitted he continued to hit B.M. with the belt and or cable wire when he got out of line.

STEVE stated between June 2007 and August of 2009 he has probably left marks on the victims back, arms, or legs about 20 times to his recollection. STEVE witnessed LARHONDA also beat the victim in this way as well. STEVE stated he also knew that LARHONDA would punish B.M. by putting him in a closet on several different occasions. STEVE advised he saw B.M. locked in the closet on at least 27 different occasions. STEVE advised LARHONDA would at least keep him in a locked closet sometimes all day or more. STEVE also was aware that LARHONDA would tie the victims hands up to punish him with a belt. STEVE also admitted he did strike the victim on the head with a car jack but it was an accident at that time. However, STEVE admitted he should have taken B.M. to the hospital but didn't. STEVE advised B.M. never went to the hospital for anything since he has known him. STEVE never
