On 03-08-11, at approx. 1504 hours, I was called to assist Fire Department on a unconscious infant at 2632 Richland. While enroute dispatch advised the infant was not breathing and CPR was being administrated. I and Officer Roach arrived and observed several of the FD personal giving CPR to the infant, Jacob Hedger. EMSA also arrived at the same time and began to assist. I then began talking with the babysitter, Traci Kramer. She advised that he was "fussy" and that she laid him down to go to sleep at approx. 1430 hours on this same date. She advised that she laid him on the bed in the master bedroom. She then came back to the bedroom and found V-Hedger not breathing at approx. 1500 hours. She picked him up and began walking around the residence thinking this would wake him up. She then called 911. I then asked who had been in the house during the time V-Hedger was asleep and she stated "I, Seth and Samuel". Officer Roach then contacted Sgt. Gilbert of the situation and T.I. Yardley and Det. Leitch were called to the scene. V-Hedger was transported to Baptist Medical Center. T.I. Yardley and Det. Leitch arrived on scene and began taking over the investigation. Officer Roach filled out the crime scene log and I booked it into property.

Incident Narrative

Supplemental Reporting EPD OFFICER JASON ROACH - EDMD, 3 03/08/2011 23:01 ID # 461

On March 8, 2011 I was dispatched to assist Officer Morefield on a call where a child was not breathing. Edmond Fire arrived on scene a few minutes before us. Officer Morefield and I then arrived on scene with EMSA. When I walked inside the residence, I observed Edmond Fire providing medical treatment to the infant in the living room.

I then started a crime scene log and stood by where V-Jacob Hedger had been sleeping to make sure nobody went in or out of the bedroom.

Inside the master bedroom was the bed that V-Hedger had been sleeping on. The area around where V-Hedger was sleeping was surrounded by pillows and bed sheets.

I then notified Sgt. Gilbert of the incident and requested a detective and TI.
